THE COMPANY MAY, BY ORDINARY RESOLUTION ON THE RECOMMENDATION OF THE DIRECTORS, DECIDE TO PAY ALL OR PART OF A DIVIDEND OR OTHER DISTRIBUTION PAYABLE IN RESPECT OF AN ORDINARY SHARE BY TRANSFERRING NON-CASH ASSETS OF EQUIVALENT VALUE (INCLUDING, WITHOUT LIMITATION, SHARES OR OTHER SECURITIES IN ANY COMPANY). ANY CAPITALISED SUM MAY BE APPLIED IN PAYING UP NEW SHARES OF A NOMINAL AMOUNT EQUAL TO THE CAPITALISED SUM WHICH ARE THEN ALLOTTED CREDITED AS FULLY PAID TO THE PERSONS ENTITLED OR AS THEY MAY DIRECT; AND/OR (IF APPROPRIATED FROM PROFITS AVAILABLE FOR DISTRIBUTION) IT MAY BE APPLIED IN OR TOWARDS PAYING UP ANY AMOUNTS UNPAID ON EXISTING SHARES HELD BY THE PERSONS ENTITLED OR IN PAYING UP NEW DEBENTURES OF THE COMPANY WHICH ARE THEN ALLOTTED CREDITED AS FULLY PAID TO THE PERSONS ENTITLED

OR AS THEY MAY DIRECT. ON A RETURN OF ASSETS ON LIQUIDATION, ANY SURPLUS ASSETS OF THE COMPANY REMAINING AFTER PAYMENT OF ITS LIABILITIES SHALL BE DISTRIBUTED AMONGST THE HOLDERS OF THE ORDINARY SHARES IN PROPORTION TO THEIR RESPECTIVE HOLDINGS. REDEMPTION ORDINARY SHARES ARE NOT REDEEMABLE.
