**ORDER**

**UPON THE APPLICATION** of Robert Neil Dymond and Gemma Louise Roberts as the former Joint Liquidators of Retail Refrigeration Limited ("the Company")

**AND UPON READING** the Witness Statement of Robert Neil Dymond filed in support and the Skeleton Argument of Carl David Jones (Solicitor-Advocate of MD Law)

**AND UPON THE COURT** noting the Statements of Acceptance and Consents to Act as Joint Liquidators signed by the Applicants in accordance with Rule 6.22(2) of the Insolvency (England and Wales) Rules 2016 and exhibited to Mr Dymond's witness statement

**AND UPON** considering the matter on the papers without a hearing

**IT IS ORDERED THAT:-**

1. Pursuant to section 201(3) of the Insolvency Act 1986 the date at which the dissolution of the Company is to take effect is deferred for 12 months to 30 April 2024 or, if earlier, to the date which expires 3 months from registration of the Joint Liquidators' further final account filed after the date hereof pursuant to section 106 of the Insolvency Act 1986.
2. Pursuant to section 108 of the Insolvency Act 1986, Robert Neil Dymond and Gemma Louise Roberts of Wilson Field Limited, The Manor House, 260 Ecclesall Road South, Sheffield, S11 9PS

are appointed as Joint Liquidators of the Company with effect from the date of this Order, and they are authorised to carry out all functions, duties and powers by either one or both of them.

3. The Joint Liquidators shall:-

3.1 Pursuant to section 109(1) of the Insolvency Act 1986, publish in the Gazette and deliver to the Registrar of Companies for registration a notice of their appointment in the form prescribed by statutory instrument made by the Secretary of State within 14 days of the date of this Order; and

3.2 Pursuant to Rule 6.22(6) of the Insolvency (England and Wales) Rules 2016, deliver a notice of the appointment to creditors of the Company within 28 days of the date of this Order.

4. The basis of the Joint Liquidators' remuneration shall continue on the same basis as previously approved by creditors on 10 September 2013 i.e. by reference to the time given by them and their staff in attending to matters arising in the Company's Liquidation.

5. The costs of the application be paid as an expense of the Company's Liquidation.
