

ORDER

UPON the Application of Orsted Power Sales (UK) Limited, a creditor of the above named Snow Factor Limited, with registered office at Unit 11, Fisher Street, Fisher Galleries, Carlisle, England, CA3 8RH (“the Company”), for the making of an administration order in respect of the Company (“the Application”)

AND UPON hearing Richard Tetlow, Counsel for the Applicants

AND UPON the Court having read the witness statement of Stefania Trovato dated 8 October 2021 and exhibits in support of the Application

AND UPON BEING satisfied on the evidence before it that the EU Regulation as it has effect in the law of the United Kingdom applies and that these proceedings are COMI proceedings

IT IS ORDERED that:-

1. the Company be placed into administration and Keith Jeffery Algie of RSM Restructuring Advisory LLP, 3 Hardman Street, Manchester, M3 3HF, and Paul Dounis of RSM Restructuring Advisory LLP, 1<sup>st</sup> Floor, Quay 2, 139 Fountainbridge, Edinburgh, EH3 9QG be appointed as the Joint Administrators of the Company;
2. the appointment shall take effect from 22 October 2021 at 11.49 a.m.;
3. during the period for which this order is in force the affairs, business and property of the Company be managed by the Joint Administrators;
4. for the purposes of paragraph 100 (2) to Schedule B1 of the Insolvency Act 1986 any act required or authorised under any enactment to be done by an administrator may be done by either or both of the Joint Administrators; and

5. the costs of the Application be payable as an expense of the administration of the Company.
