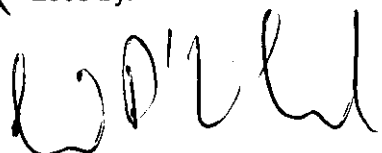
For the period ended 31 December 2004, the company was entitled to exemption under sub-section (1) of section 249A of the Companies Act 1985.
