1. Introduction and circumstances giving rise to the appointment of the Administrators



On 26 April 2018, the Company entered administration and Geoffrey Paul Rowley and Jason Daniel Baker were appointed as Administrators.

This document, together with its appendices, forms the Administrators' statement of proposals to creditors in accordance with Paragraph 49 of Schedule B1 to the Insolvency Act 1986 and the Insolvency Rules. The proposals are deemed delivered two business days after they are dated.

Certain statutory information about the Company and the administration is provided at **Appendix A**.

Background information regarding the Company

The Company's operations focused on African iron ore opportunities which were constrained by a lack of infrastructure from 2010 onwards. IMIC's stated strategy was to establish an asset-ownership position in the West and Central African iron ore mining sector through investment in junior miners and related infrastructure.

The acquisition of Afferro in December 2013 provided IMIC with its first (and only) assets on the ground. This comprised four exploration licenses in the South Cameroon iron ore corridor at: Akonolinga, Essong (Ngoa), Ntem and Nkout.

Of the four licenses, the Company focused on two predominately:

- Ntem 4 million tonnes of iron ore per annum (projected) and close to the port (80km) so less capital expenditure intensive; and
- Nkout larger at 35 million tonnes of iron ore per annum (projected) but 330km from port so requiring a railway joint venture.

In order to help deliver its infrastructure solutions, IMIC and its strategic partner AIOG established strategic partnerships with various Chinese state owned companies in railway and port construction, power, iron ore beneficiation and iron ore marketing.

These relationships were intended to give IMIC and AIOG the ability to work with relevant governments and financial institutions to deliver infrastructure solutions and to guarantee the onward sale of iron ore in China and other emerging world markets.

Iron ore prices plummeted during 2014 and 2015, limiting the Group's ability to raise external finance or investment in the infrastructure projects required to unlock the projects.

IMIC shares were traded on the London Stock Exchange's AIM market until the NOMAD resigned in October 2015 following a delay in notification of a tax assessment in Cameroon that was subsequently settled. The Company was unable to find a replacement for the Nomad and was subsequently delisted.

The PFSs for Nkout and Ntem were progressed and completed in 2016, funded by a series of bond issues by IMIC and its immediate fully owned subsidiary Afferro Mining Inc.

The Group was unable to raise further funding from 2016 onwards, which led to various rounds of restructuring and forbearance discussions with creditors, ultimately culminating in the Company entering administration on 26 April 2018.

Events leading to the appointment of the Administrators

The Company engaged FRP Advisory on 7 November 2017 to provide a letter of advice regarding the solvency of the business and the directors' responsibilities having regard to the financial position as advised by the directors. A further engagement to provide general restructuring advice to the Company was entered into on 29 November 2017.

This advice was taken by IMIC in anticipation of interest payments becoming due to bondholders from December 2017 for which the Company intended to request forbearance.

Forbearance was requested from certain bondholders, one of which being the majority creditor, LFB, who hold bonds in both IMIC and Afferro. LFB requested additional

information from the Company in order to gain a better understanding of the positon before forbearance was provided.

Following review of this information, LFB advised the Company it was not willing to provide further funding.

Appointment of the Administrators

Discussions were held between IMIC and LFB which culminated in LFB filing an administration application in the High Court on 5 March 2018.

The Company contested the application and an adjournment until 22 March 2018 was agreed with LFB. At the subsequent hearing on 22 March 2018 a consent order was agreed whereby the application would be heard on 16 April 2018, once both parties had filed further evidence. At this hearing insufficient time was available to hear all evidence submitted, so LFB requested the application be heard on an urgent basis and listed for a full day. This was granted and the hearing took place 25 April 2018. Following the first day of the hearing, the directors conceded to the application and a consent order was agreed the following morning. An administration order was then granted in the High Court on 26 April 2018 with Geoffrey Paul Rowley and Jason Daniel Baker appointed as Administrators.



The objective of the Administration

The Administrators think that objective (a) of the Administration, as detailed in Paragraph 3(1) of Schedule B1 to the Insolvency Act 1986, being to rescue the Company as a going concern, could be achieved subject to the successful completion of a DFS for Ntem and restructuring of the Company's debts. Should the above be unsuccessful, it is envisaged that objective (b) will be achieved, being a better result for the Company's creditors as a whole than would be likely if the Company had been wound-up (without first being in Administration). This will be via an asset realisation strategy either with or without a DFS being completed for Ntem.

The Administrators' actions

Immediately following appointment, it was identified that the mining licenses held by one of IMIC's subsidiaries, Caminex, represented the Company's main assets.

Only Ntem and Nkout have been considered viable in the near term by directors of IMIC and progressed through a PFS process, to a standard +/-25% forecast net present value tolerance. The next stage in the progress of either would be to complete a DFS, which reduces the forecast tolerance to +/-15%, which is considered adequate to raise finance within the industry.

If a DFS is completed and approved by the CDoM, a mining permit is issued and construction of the mine and extraction of the ore can commence thereafter.

We are advised by the directors that very limited work has been undertaken on the Akonolinga and Essong (Ngoa) projects and in effect only enough to keep them holding over.

There has also been a letter from the CDoM requiring various further works be undertaken by Caimnex before an extension of the Akonolinga license.

The Administrators are exploring the legal and commercial complexities of realising value from these licenses but it is uncertain as to what realisations can be anticipated from these assets at this time. Expert local technical and legal advice is being sought.

We are advised by the directors that progress on the Nkout project has stalled as there is not currently any funding in place for the building of the railway required by the mine.

The PFS for Nkout was completed in Aug-15 and estimated a multi billion dollar NPV and capex requirement. It is not deemed viable to fund or progress within the administration and the Administrators are therefore exploring their ability to realise this license.

The Ntem project is significantly more costs effective due to its close proximity to the Kiribi port and the PFS estimates an NPV and capital expenditure requirement of NPV and several hundred million dollars for the project.

Metallurgy results indicate that a high-grade concentrate of up to 70% Fe (out of a possible 72% Fe maximum), meaning the reserves of are of a premium quality ore, which we are informed will achieve a higher than standard commodity value.

The license has been extended four times already and currently expires on 13 April 2019. We understand there are no further extensions permissible under the terms of the license/relevant legislation. However, the Company's management team assert an extension of 6 months could be obtained if the project were being progressed and that there is precedent for this.

Assuming an extension can be agreed and funding obtained, Ntem is the only project which has the prospect of being progressed.

The Administrators' are in discussions with a number of parties including the largest creditor with a view to funding being provided for the completion of the DFS.



These discussions remain ongoing and will dictate whether the Administrators continue to trade the Company in order to undertake the DFS at Ntem or alternatively attempts are made to sell all of the licenses in their current state. Either strategy will require the cooperation of the Cameroonian Government.

The Administrators are in the process of obtaining specialist valuation and sales advice regarding the mining assets. LFB have undertaken a valuation of the Ntem licence, which they have shared with the Administrators on a confidential basis. The valuation is commercially sensitive but supports the exploration of funding to progress the Ntem DFS.

Details of work already undertaken or anticipated will be undertaken is set out in the schedule of work attached at **Appendix C**.

Highlights to date include:

- Liaising with directors in order to realise the Company's funds held in bank accounts in the UK and Switzerland.
- Meetings with directors and senior staff to ascertain the history and assets position of the Company.
- Understanding the overall group structure and inter-company balances which are complex.
- Liaising with the Company's pre-existing mining consultant in order to obtain proposals from the various contractors required to undertake the DFS.
- Liaising with LFB and their legal advisors on various matters.
- Liaising with various bond holders in relation to the history and current position with the Company.

Following approval of the Administrators' proposals the Administrators will continue to conduct the Administration to achieve the purpose of the administration.

Key matters to be undertaken include:

Continued discussions with parties regarding funding for the Ntem DFS.

- Trading the business in order to complete the Ntem DFS if appropriate, including agreeing funding, instructing the appropriate contractors and overseeing the associated work through to completion.
- Realise the Company's remaining assets including the mining licenses.
- Ensure all statutory and compliance matters are attended to.
- Pay all Administration expenses and bring the Administration to an end when deemed appropriate by the Administrators.

Receipts and Payments Account

Copies of the Administrators' receipts and payment accounts relating to both GBP and USD funds to date are attached at **Appendix B**.

The directors' Statement of Affairs

The directors of the Company have been asked to submit a Statement of Affairs under paragraph 47 of Schedule B1 of the Insolvency Act 1986. A copy of the Statement of Affairs is provided at **Appendix E**.

The end of the Administration

The Administration will end automatically after 12 months from the date of appointment of the Administrators. This period can be extended with consent of the creditors for up to 12 months or longer by application to the Court as required.

Administrators' remuneration

A schedule of the work to be undertaken during the Administration is set out at **Appendix C** together with a Schedule of costs which includes an estimate of the expenses likely to be incurred by the Administrators. Assumptions made in preparing the summary of work, estimated expenses and the fees estimate where a time cost resolution is proposed are set out in the schedule of work.

The Administrators' remuneration will be drawn from the Company's assets and it is proposed that it will be charged by reference to the time incurred in attending to matters arising. Further details of how this will be calculated is set out below. The basis of the Administrators' remuneration has not yet been approved by creditors, and the Administrators have accordingly not drawn any remuneration in this case.

Should the Company subsequently be placed into liquidation and the Administrators appointed as Liquidators, the basis agreed for the drawing of the Administrators' remuneration will also be that utilised in determining the basis of the Liquidators' remuneration, in accordance with the Insolvency Rules.

Remuneration charged by reference to the time incurred in attending to matters arising

The Administrators' remuneration which is proposed to be charged by reference to time incurred is set out on the fee estimate attached at Appendix C. This estimate is calculated assuming funding is obtained to complete the Ntem DFS. Should the Administrators not obtain funding to complete the Ntem DFS then costs will reduce accordingly. Time costs incurred in relation to these matters as at 14 June 2018 totalled £95,277. The time charged is based on computerised records capturing time charged by the Administrators and their staff in dealing with the conduct of those aspect of the case being charged on a time cost basis. Charge out rates are reviewed at least annually, details of FRP Advisory's charge out rates are included at **Appendix**

Matters dealt with during the assignment are dealt with by different members of staff depending on the level of complexity and the experience required. Time is charged to the case in maximum units of six minutes. Charge-out rates are based on individual expertise, qualification and grade. The costs of the firm's support staff are not directly charged to the estate unless dealing with directly identifiable case specific matters.

Administrators' disbursements

The Administrators' disbursements are a recharge of actual costs incurred by the Administrators on behalf of the Company. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the Administration of the Company, are paid by FRP Advisory at the HMRC approved mileage rate. It is proposed mileage is recharged and drawn at the HMRC approved mileage rate prevailing at the time the mileage was incurred.

Pre-administration costs charged or incurred by the Administrators

Attached at **Appendix D** is a statement of pre-administration costs incurred by the Administrators totalling £19,025.

We are seeking approval from creditors for the payment of this amount and a standalone separate resolution is included on the proxy form attached.

Appendix D also shows pre-administration legal costs incurred of £120,855.36 which represent the costs incurred by LFB's solicitors relating to the administration application. These costs have been awarded against the Company by the High Court and will therefore be paid as an expense of the Administration.

Creditors' ability to challenge the Administrators' remuneration and expenses

Creditors have a right to request further information from the Administrators and further have a right to challenge the Administrators' remuneration and other expenses under the Insolvency Rules following receipt of a progress report.

Schedule of costs

We attach at **Appendix C** a Schedule of costs which has been prepared from the information provided by the directors, included in their statement of affairs, advice received in connection with the value of the Company's assets, estimated sums due to creditors and an estimate of our remuneration and other professional fees and expenses that may be incurred during the course of this Administration. The assumptions made in preparing the Schedule of costs are set out in the schedule of work.

Based on the information available to date and the assumptions made, set out below is the anticipated the outcome for creditors.

Outcome for Preferential Creditors

No preferential claims have been estimated in the directors' statements of affairs. Any claims received will be made up of employees' preferential element for arrears of pay, unpaid pension contributions and holiday pay as calculated in accordance with legislation. It is anticipated that preferential creditors will be paid in full should any claims arise. To date, none have been notified.

Outcome for Unsecured Creditors

Based on the assumptions made in the Schedule of costs it is currently estimated that there will be sufficient funds available to make a distribution to unsecured creditors in due course. This distribution will be paid by a subsequently appointed Liquidator. The costs of the liquidation cannot at this stage be estimated and therefore it is not possible to estimate the level of distribution that may be made.

Prescribed Part

The prescribed part is a carve out of funds available to the holder of a floating charge which is set aside for the unsecured creditors in accordance with section 176A of the Insolvency Act 1986. 
