Prescribed particulars

Each Ordinary share carries the right to one vote on a poll. The right to vote is determined by reference to the register of members at a time specified in the notice of meeting, being not more than 48 hours (disregarding non-working days) before the general meeting in question. All dividends shall be declared and paid according to the amounts paid up on the shares.

The shares do not carry any rights as respects capital to participate in a distribution (including on a winding-up) other than those that exist as a matter of law. The shares are not redeemable.

The Deferred shares do not carry a right to vote at a general meeting. They have no rights to dividends. In a distribution of capital (including on a winding-up), the holder of Deferred shares is entitled only to the repayment of the amount paid upon such shares. The Deferred shares may be purchased at nominal value at the option of the Company by notice in writing served on the holder of the Deferred shares.


