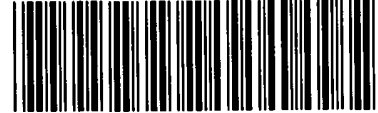

Each Ordinary share carries the right to one vote on a poll. The right to vote is determined by reference to the register of members at a time specified in the notice of meeting, being not more than 48 hours (disregarding non-working days) before the general meeting in question. All dividends shall be declared and paid according to the amounts paid up on the shares.

The shares do not carry any rights as respects capital to participate in a distribution (including on a winding-up) other than those that exist as a matter of law. The shares are not redeemable.

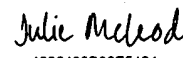
