unaudited abbreviated accounts of Vemotion Interactive Limited**





Notes to the abbreviated financial statements for the year ended 30 September 2006

1. Accounting policies

1.1. Accounting convention

The accounts are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005)

1.2. Turnover

Turnover represents the total value, excluding value added tax, of sales made during the year and derives from the provision of goods falling within the company's ordinary activities

1.3. Patents

Patents are valued at cost less accumulated amortisation

Amortisation is calculated to write off the cost in equal annual instalments over their estimated useful life of 20 years

1.4. Tangible fixed assets and depreciation

The fixed assets acquired at commencement of trade have continued to be depreciated at the rates based on original costs rather than the lower of cost of acquisition

Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows

Alterations to leasehold properties	-	25% straight line
Computer and IT equipment	-	25% straight line
Demonstration equipment	-	25% straight line
Platform	-	33% straight line

1.5. Stock

Stock is valued at the lower of cost and net realisable value

1.6. Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more, or a right to pay less or to receive more tax

Deferred tax assets are recognised only to the extent that the directors consider that it is more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date

1.7. Going concern

Mr G R Haworth, a director of Vemotion Interactive Limited, has undertaken to ensure that the company has sufficient funds to meet its liabilities to its creditors as they become due for at least 13 months from the date of approval of the financial statements. 4. Transactions with directors

Included in creditors is £715,000 (2005 - £100,000) due to Mr G R Haworth a director of the company the loan is interest free and has no fixed repayment terms
