THIS DEED is made on 23 November 2018

BETWEEN:

- (1) **THE COMPANIES** whose respective names and company numbers appear in schedule 1 (The New Chargors) (collectively the "**New Chargors**" and each a "**New Chargor**");
- (2) **CARETECH HOLDINGS PLC**, a company incorporated in England and Wales with registered number 04457287 (the "**Obligors' Agent**") for itself and as agent for and on behalf of each of the existing Chargors; and
- (3) **NATIONAL WESTMINSTER BANK PLC** as Security Agent for the Secured Parties (the "Security Agent").

RECITALS

This Deed is supplemental to a debenture dated 29 October 2018 between, amongst others, the Chargors named therein and the Security Agent, as previously supplemented and amended by earlier Security Accession Deeds (if any) (the "Debenture").

THE PARTIES AGREE AS FOLLOWS:

1. INTERPRETATION

1.1 Definitions

Terms defined in the Debenture shall have the same meanings when used in this Deed.

1.2 Construction

Clauses 1.2 to 1.11 (Construction) of the Debenture will be deemed to be set out in full in this Deed, but as if references in those clauses to the Debenture were references to this Deed.

2. ACCESSION OF NEW CHARGOR

2.1 Accession

Each New Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had been a party to it as a Chargor.

2.2 Covenant to Pay

Each New Chargor covenants with the Security Agent (as trustee for the Secured Parties) that it will pay, perform and discharge the Secured Liabilities as and when the same fall due for payment, performance or discharge in accordance with the terms of the Finance Documents.

3. FIXED SECURITY

3.1 Charges

(a) Each New Chargor, as security for the payment, performance and discharge of all the Secured Liabilities, charges in favour of the Security Agent (as trustee for the Secured Parties) by way of a first legal mortgage all of its right, title and interest in and to the freehold, commonhold and leasehold property (if any) specified in schedule 2 (Real Property).

- (b) Each New Chargor, as security for the payment, performance and discharge of all the Secured Liabilities, charges in favour of the Security Agent (as trustee for the Secured Parties) by way of first fixed charge all of its right, title and interest in and to the following assets, both present and future:
 - (i) all estates or interests in any freehold, commonhold or leasehold property (other than such property effectively mortgaged under clause 3.1 above);
 - (ii) all licences held by it to enter upon or use land and/or to carry on the business carried on upon that land and all agreements relating to land to which it is a party or otherwise entitled;
 - (iii) where any Mortgaged Property is leasehold property, any right or interest arising by virtue of any enfranchising legislation (including, but not limited to, the Leasehold Reform Act 1967 and the Leasehold Reform Housing and Urban Development Act 1993 but excluding Part II of the Landlord and Tenant Act 1954) which confers upon a tenant of property whether individually or collectively with other tenants of that or other properties the right to acquire a new lease of that property or to acquire, or require the acquisition by a nominee of, the freehold or any intermediate reversionary interest in that property;
 - (iv) any amounts owing to it by way of rent, licence fee, service charge, dilapidations, ground rent and/or rent charge in respect of any Mortgaged Property or Premises;
 - (v) all fixed and other plant and machinery, computers, vehicles, office equipment and other chattels in its ownership or possession (but excluding any of those items to the extent that they are part of its stock in trade);
 - (vi) to the extent not effectively assigned pursuant to clause 3.2 (Assignment), all Insurances, including all claims, the proceeds of all claims and all returns of premium in connection with Insurances;
 - (vii) all book debts and all other debts or monetary claims (including all choses in action which may give rise to a debt or monetary claim), all proceeds thereof and, in each case, any cheque, bill, note, negotiable instrument or other document representing the same;
 - (viii) all moneys from time to time deposited in or standing to the credit of any bank account with the Security Agent (including, for the avoidance of doubt, the Holding Account and Mandatory Prepayment Account) or any other bank or financial institution (including, without limitation, any rent deposit given to secure liabilities in relation to land and any retention or similar sum arising out of a construction contract or any other contract (and, in each case, any cheque, bill, note, negotiable instrument or other document representing the same)), including those accounts (if any) listed in schedule 6 (Account Details) of the Debenture or in any Security Accession Deed;
 - (ix) all Securities and their Related Rights;
 - (x) all of its goodwill and uncalled capital;
 - (xi) all Intellectual Property; and
 - (xii) to the extent not effectively assigned pursuant to clause 3.2(a)(i) (Assignment), each of the Specified Contracts.

3.2 **Assignment**

- (a) Each New Chargor, as security for the payment, performance and discharge of all the Secured Liabilities, assigns to the Security Agent (as trustee for the Secured Parties) absolutely by way of a first legal assignment all of that Chargor's right, title and interest in and to:
 - (i) each of the Specified Contracts; and
 - (ii) all Insurances, including all claims, the proceeds of all claims and all returns of premium in connection with Insurances,

provided that on payment or discharge in full of the Secured Liabilities the Security Agent will at the request and cost of the relevant Chargor re-assign the relevant rights, title and interest in the assigned assets to that Chargor (or as it shall direct);

4. FLOATING CHARGE

Each New Chargor, as security for the payment, performance and discharge of all the Secured Liabilities, charges in favour of the Security Agent (as trustee for the Secured Parties) by way of a first floating charge all of its undertaking and all its other property, assets and rights whatsoever, all the stock in trade of that Chargor and the property, assets and rights not otherwise validly and effectively mortgaged, charged or assigned (whether at law or in equity) by way of fixed security pursuant to clause 3 (Fixed Security).

5. INCORPORATION INTO DEBENTURE

The Debenture and this Deed shall be read together as one instrument on the basis that references in the Debenture to "this Deed" will be deemed to include this Deed.

6. CONSENT OF EXISTING CHARGORS

Each existing Chargor agrees to the terms of this Deed and agrees that its execution will in no way prejudice or affect the security granted by each of them under (and the covenants given by each of them in) the Debenture.

7. THIRD PARTY RIGHTS

Nothing in this Deed is intended to confer on any person any right to enforce or enjoy the benefit of any provision of this Deed which that person would not have had but for the Contracts (Rights of Third Parties) Act 1999.

8. NOTICES

Each New Chargor confirms that its address details for notices are as is listed next to its name in schedule 1 (The New Chargors).

9. **COUNTERPARTS**

This Accession Deed may be executed in any number of counterparts, and this has the same effect as if the signatures (and seals, if any) on the counterparts were on a single copy of this Accession Deed.

10. **GOVERNING LAW**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

THIS ACCESSION DEED has been signed on behalf of the Security Agent, signed on behalf of the Obligors' Agent and executed as a deed by each Subsidiary and is delivered on the date stated above.
