ANY EXIT PROCEEDS SHALL BE DISTRIBUTED AMONGST THE SHAREHOLDERS IN THE MANNER AND ORDER OF PRIORITY SET OUT BELOW: FIRST, IN PAYING TO THE HOLDERS OF THE PREFERENCE SHARES THE SUM OF £1.00 IN RESPECT OF EACH PREFERENCE SHARE HELD.
