2. **THAT** the pre-emption rights on the transfer of shares (Article 13 of the Company's articles of association) should be disapplied in respect of Secured Institutions.

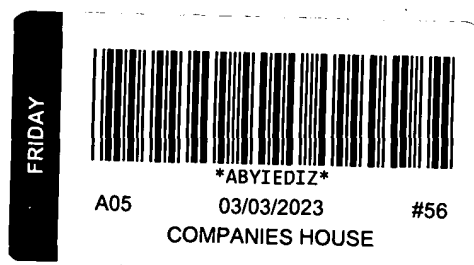
