- (1) THE ENTITIES whose names and addresses are set out in part 1 of schedule 1 ("Institutional Vendors"); and
- (2) THE PERSONS whose names and addresses are set out in part 2 of schedule 1 ("Management Vendors"); and
- (3) ALCONTROL TRUSTEE COMPANY LIMITED a company registered in England and Wales with number 4141143 whose registered office is at Templeborough House, Mill Close, Rotherham, South Yorkshire, S60 1BZ ("Trustee Vendor"); and
- (4) ALCONTROL HOLDINGS (UK) LIMITED (formerly Nailmist Limited) a company registered in England and Wales with number 05257340 whose registered office is at 10 Upper Bank Street, London, E14 5JJ ("Purchaser")

together ("Parties")

BACKGROUND

- A This deed is supplemental to the sale and purchase agreement relating to the sale and purchase of part of the issued share capital of ALcontrol Holdings Limited between the Institutional Vendors, Management V endors, Trustee Vendor and P urchaser d ated 16 No vember 20 04 ("Agreement").
- B Pursuant to clause 3.4 of the Agreement the Parties agreed that the total Consideration and aggregate cash consideration payable would be varied to the extent that the exchange rate determined in accordance with clause 27.2 of the Agreement differed from the Assumed Rate, as defined in the Agreement.
- C Pursuant to clause 3.4 of the Agreement the Parties agreed to procure that schedule 1 of the Agreement would be amended to reflect a variation to the Assumed Rate prior to the date falling 3 Business Days prior to Completion.
- D Pursuant to clause 4.2 of the Agreement, the Management Vendors have submitted Rollover Adjustment Notices, as defined in the Agreement.

E The Parties wish to enter into this deed to confirm their agreement in respect of the effect of the exchange rate determined in accordance with clause 27.2 of the Agreement and the effect of the Rollover Adjustment Notices.

THIS DEED WITNESSES AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

1.1 In this deed the following words and expressions shall have the following meanings:

"Completion" means completion of the sale and purchase of the Shares in accordance with clause 7 of the Agreement;

"Consideration" means the consideration for the Shares set out in clause 4 of the Agreement; and

"Consideration Adjustment" means the sum of €17,000.

1.2 This deed incorporates the schedules to it.

2. EXCHANGE RATE

The rate of exchange used for the purposes of determining the Euro payments under the clauses 4.1.1 and 27.2 of the Agreement shall be 1.4485. Accordingly, the Euro equivalent of the £1,750,000 referred to in clause 4.1.1 of the Agreement as payable by the Purchaser to Kelda Group plc shall for the purposes of the Agreement be €2,534,875.

3. AMENDMENT TO CLAUSE 4

The following amendments shall be made to clause 4 of the Agreement:

- 3.1 the full stop at the end of clause 4.1.5.2 of the Agreement shall be deleted and replaced with ";and"; and
- 3.2 the following additional clause shall be added to clause 4 of the Agreement:
 - "4.1.6 the payment in cash to the Vendors of the sum of €7,962,406.73 such sum being allocated to each Vendor in the ratio each Vendor's Relevant Shares bears to the total number of Shares."

4. TRANSACTION COSTS AND CONSIDERATION ADJUSTMENT

The Vendors:

- 4.1 agree that the costs set out in schedule 2 to this deed may be deducted by the Purchaser from the Consideration in accordance with paragraph 3.1 of schedule 6 of the Agreement; and
- 4.2 agree that the Consideration Adjustment may be deducted by the Purchaser from the Consideration.

5. SCHEDULE 1 AMENDMENT

Pursuant to clause 3.4 of the Agreement, in order to reflect the exchange rate agreed above and the Rollover Adjustment Notices submitted by the Management Vendors, schedule 1 to this deed shall replace schedule 1 to the Agreement.

6. GOVERNING LAW AND JURISDICTION

- 6.1 This deed shall be governed by and construed in accordance with the laws of England.
- 6.2 The parties irrevocably agree that the courts of England shall have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this agreement and that accordingly, any suit, action or proceedings arising out of or in connection with this agreement shall be brought in such courts.

7. AGREEMENT CONTINUES IN FORCE

Save as expressly provided in this deed, the Parties agree that the provisions of the Agreement shall remain in full force and effect in accordance with its terms.

IN WITNESS whereof the parties or their duly authorised representatives have executed this agreement as a deed and this is intended to be and is delivered on the date first written above.
