I present, for your information, my progress report on the liquidation for the period 28 November 2013 to 25 July 2014 as follows:

Statutory Information

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as liquidator of the Companies on 20 November 2013. Their respective company numbers are detailed above.

The Companies' trading address and previous registered office was 140 Aldersgate Street, London, EC1A 4HY. Their registered office was changed to 55 Baker Street, London, W1U 7EU following my appointment.

The Companies' former names are listed in the attached schedule. None of the Companies has any other trading style.

Receipts & Payments

There have been no receipts and payments in the liquidation of the Companies.

As detailed on the Companies' respective Declarations of Solvency the sole assets were intercompany debtor balances owed to the Companies.

These balances (as listed in the attached schedule) were distributed to the Companies' respective shareholders prior to this meeting.

Further to the above, regarding Mount Anvil (SWD) Limited ("SWD"), in January 2014 I was advised that two debtor balances totalling some £50,000 which had been written off prior to my appointment would now prove recoverable. These two loans were distributed in specie to SWD's immediate parent in March 2014.

Liquidator's Remuneration

My remuneration was approved on a time cost basis on the date of my appointment. As the Companies have no cash assets, the liquidation costs will be paid by a group company.

Creditors

Formal tax clearance from HM Revenue & Customs has been received in respect of Corporation Tax and VAT for the pre-liquidation periods; together with confirmation that no further returns are required and there are no objections to the liquidations being closed.

No other claims from creditors were expected, and none have been received.

The shareholders are invited to consider the following resolutions:

- 1 That the Liquidator's report and accounts to 25 July 2014 be and are hereby approved.
- That the Liquidator is authorised to dispose of the Companies' books and records one year after the dissolution of the Companies.
- 3 The Liquidator is released.

The resolutions were all duly approved.
