POST BALANCE SHEET EVENTS

During the year the Moto Group was acquired by Everest UK Bidco Limited, a wholly-owned indirect subsidiary of Universities Superannuation Scheme Limited (acting in its capacity as sole corporate trustee of Universities Superannuation Scheme). USS is the principal pension scheme provided by Universities, Higher Education and other associated institutions for their employees. Subsequently, it was announced on 4 December 2015 that USS had agreed to sell 40% of its shareholding to funds advised by CVC Capital Partners. The sale completed in the first quarter of 2016.
