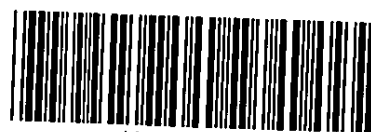

1 ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The company was dormant throughout the year ended 30 November 2009. However, reference to information relating to the year ended 30 November 2008 has been made where appropriate

Turnover

Turnover represents net invoiced sales of services, excluding value added tax
