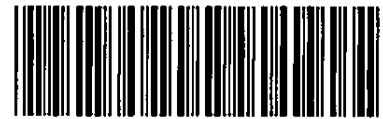

Short particulars

The property mortgaged or charged is such property as set out in Part 3 of the continuation sheets attached to the Form 395s which have been filed against the Pledgor at Companies House in respect of each Belgian Security Document

Pursuant to clause 2 1 of the Second Supplemental Agreement with effect from the Effective Date, the Belgian Security Documents (amongst others) were supplemented and amended on the terms set out in the Second Supplemental Agreement

Clause 3 2 of the Second Supplemental Agreement further provided that, as from the Effective Date, the Belgian Security Documents and the Second Supplemental Agreement shall be read and construed as one document and references in the Belgian Security Documents and in each of the Senior Finance Documents to the Belgian Security Documents shall be read and construed as references to the Belgian Security Documents as supplemented by the Second Supplemental Agreement

Definitions

"Belgian Security Documents" means (a) the pledge agreement relating to shares of INEOS Services Belgium NV, entered into between INEOS European Holdings Limited and INEOS Europe Limited as pledgors and the Security Agent as pledgee, dated 16 March 2006 (as supplemented and amended by the First Supplemental Charge), and (b) the pledge agreement relating to shares of INEOS Sales Belgium NV entered into between INEOS European Holdings Limited and INEOS Europe Limited as pledgors and the Security Agent as pledgee, dated 16 March 2006 (as supplemented and amended by the First Supplemental Charge),

"Effective Date" means 11 July 2006,

"First Supplemental Agreement" means the supplemental agreement relating to the Belgian Security Documents dated 15 February 2006,

"Pledgor" means INEOS Europe Limited,

"Security Agent" means Barclays Bank PLC,

"Senior Facilities Agreement" means the credit agreement entered into between, amongst others, INEOS Holdings Limited and principal obligor, INEOS Group Limited as parent and the Security Agent dated 14 December 2005 (as amended and restated from time to time), and

"Senior Finance Documents" has the meaning given to it in the Senior Facilities Agreement
