1. Introduction

- 1 1 All companies in the Group were placed into Administration on the Appointment Date by the Director of the companies pursuant to Paragraph 22 of Schedule B1 to the Act
- 1 2 The purpose of this report is to provide creditors with a final account of the progress of the Administrations for the Reporting Period, together with a summary of the Administrations. This report should be read in conjunction with the Proposals and Previous Progress Reports
- 1 3 A Block Transfer Order (High Court of Justice Number 3401 of 2014) was obtained on 8 December 2014 in respect of all companies in the Group. The Order provided for the formal removal of Paul John Clark and David John Whitehouse from office and appointed a replacement office holder, Benjamin John Wiles, a licensed Insolvency Practitioner of Duff & Phelps, as Joint Administrator
- 1 4 Paul John Clark and David John Whitehouse were released from liability on 25 February 2015, 28 days after the date of the progress report advising of same
- 1 5 In accordance with Paragraph 100(2) of Schedule B1 to the Act, the functions of the Joint Administrators can be exercised by either of the Administrators
- 1 6 The Joint Administrators previously reported on the Closed Administrations together with the Group. The Closed Administrations were closed on 4 June 2015 and a separate report is available on the Duff & Phelps website in this respect
- 1 7 Further, the Administration of the Parent Company was closed on 30 July 2015. A separate report is available on the Duff & Phelps website in this respect
- 1 8 Statutory information regarding all companies in the Group is attached at Appendix 1

2 Joint Administrators' Report and Statement of Proposals

All companies in the Group except for UK Hotels (Finance) plc

- 2 1 The Proposals were deemed approved by creditors on 11 November 2014 in respect of each company
- 2 2 Please refer to the Proposals for further information regarding the Joint Administrators' pursuit of same. There were no major amendments to or deviations from the Proposals
- 2 3 A copy of the approved Proposals is attached at Appendix 4

UK Hotels (Finance) plc

- 2 4 In accordance with Paragraph 51 of Schedule B1 to the Act, a creditors' meeting was held at Duff & Phelps on 14 November 2014. The meeting was adjourned and reconvened twice, concluding on 28 November 2014 at which the Joint Administrators' Proposals were rejected
 - 2 5 The Joint Administrators requested that the voting creditors provide an explanation of why the Proposals were rejected but no responses were received. Further, no alternative proposals were put forward by any creditors
 - 2 6 The rejection of the Joint Administrators' Proposals did not affect their appointment status, statutory powers or ability to continue the Administration
-

- 2 7 Following the rejection of the Proposals, the Joint Administrators reported this fact to the court. A court hearing was held on 18 August 2015 which provided the Joint Administrators with consent to conclude the Administration and take on the necessary steps to move UK Hotels (Finance) plc to dissolution.

3. Progress of the Administrations

- 3 1 The manner in which the affairs and business of the Group were managed and financed since the appointment of the Joint Administrators is set out below.

All companies in the Group except for UK Hotels (Finance) plc

Sale of Businesses and Assets

- 3 2 As previously advised, a sale of the businesses and certain assets of the Hotel Operating Companies completed on 11 September 2014 shortly following the appointments. For further details including a breakdown of the sale consideration per company and the events leading up to the sale transactions, please refer to the Proposals and the Previous Progress Reports. The sale consideration breakdown per company is also detailed in the Joint Administrators' Receipts and Payments accounts at Appendix 2.

Book Debts

- 3 3 The Group's book debts were excluded from the sale agreements. The sale agreements also provided that the Purchaser collect the book debts for the benefit of the Administrations.
- 3 4 In March 2015 the Purchaser agreed to acquire the remaining outstanding book debt ledgers of circa £648k for 70% of value. This was agreed as the remaining debts had been outstanding for more than 6 months and it was considered that this would represent the best outcome for creditors. The outstanding debts were assigned to the Purchaser and payments were made to the Administration estates totalling circa £454k accordingly.
- 3 5 In order to finalise the agreement a full reconciliation of the book debt ledgers and cash in transit balances as at the date of appointment was undertaken. A breakdown of the final book debt position is shown below.

- 3 6 The collections balances include the amounts paid by the Purchaser to acquire the remaining outstanding debts. The outstanding balances totalling £1,118,850 includes credit notes of £62,262, booking agent and credit card commissions of £655,959, bad debts of £206,208 and other dilutions of £194,421 which are not collectable.
- 3 7 Please note that the opening book debt ledgers as at the Appointment Date have been adjusted from those previously reported. This is due to allocating cash received prior to the appointment of Joint Administrators against the ledgers.

Intercompany Book Debts

- 3 8 As previously advised, all of the entities that the balances are due from have been placed into Administration. All dividends paid in respect of intercompany claims were paid direct to LSREF via the Security Trustee in accordance with the subordination agreement in place and therefore there were no realisations from this source.

- 3 11 Please note that the balance reported in respect of Paramount Hotels Limited is less than that previously reported. This is due to this cash being reallocated as part of the Group book debt and cash in transit reconciliation.

Deposit held by Royal Bank of Scotland Plc

- 3 12 The Joint Administrators realised a £120,000 deposit from Royal Bank of Scotland Plc in respect of the direct debit and credit card facilities operated by Paramount Hotels Limited prior to the Reporting Period.

Business Rates Refunds

- 3 13 The Joint Administrators engaged Hilco Profit Recovery to review all property costs and to pursue all recoveries due. There have been no realisations from this source.
- 3 14 A further potential asset realisation of £19,500 has been identified in respect of business rate review appeals to date in the estate of Paramount Hotels Limited. The Joint Administrators have assigned the Group's right and interest in any future business rate revaluation appeals to Hotel Collection Services Limited, the current operator of the properties to which any potential assets relate to. Please note that the maximum Prescribed Part of £600,000 was distributed in respect of Paramount Hotels Limited and therefore if the asset of £19,500 is realised in future, it would not result in further distributions to non-preferential unsecured creditors.
- 3 15 Prior to the engagement of Hilco Profit Recovery, the Joint Administrators realised £422,424 in relation to business rates refunds. There were no realisations in the Reporting Period.

UK Hotels (Finance) plc

Intercompany Book Debts

- 3 16 As previously advised, UK Hotels (Finance) plc is owed money from certain other entities in the Wider Group, all of which have been placed into Administration. Two of these entities, UK Group of Hotels plc and Paramount Hotels Group Limited had insufficient funds to enable distributions to their unsecured creditors. Carlton Hotel (Edinburgh) Limited paid a Prescribed Part distribution to UK Hotels (Finance) plc of £708.09 on 7 September 2015.

Channel Island Security Exchange Authority ("CISEA")

- 3 17 As previously advised, CISEA considered that UK Hotels (Finance) plc's securities were not suitable for listing and therefore the securities were suspended from their official listing by CISEA on 6 January 2015. The listing of the securities was subsequently cancelled by CISEA with effect from 07.00 on 30 January 2015.

Other Assets

- 3 18 UK Hotels (Finance) plc has no other assets to realise.

4 Investigations

- 4 1 The Joint Administrators' investigations into the Group's affairs have concluded satisfactorily.
- 4 2 The Joint Administrators have a statutory obligation to file a separate report in respect of each company in the Group with DBIS concerning the conduct of the directors that held office in the three years prior to the Appointment Date. The content of these reports is confidential and the reports were filed on 23 February 2015.

4 3 There are no outstanding lines of enquiry

5 Dividend Prospects / Prescribed Part

All companies in the Group except for UK Hotels (Finance) plc

Secured Creditors

- 5 1 As at 29 August 2014, the Wider Group's indebtedness to LSREF was £327,520,160, subject to accruing interest, charges and costs
- 5 2 As noted in the Proposals, deemed fixed and floating charge distributions totalling £195,980,226 were made to the Secured Creditor on 11 September 2014
- 5 3 Total floating charge cash distributions of £17,232,388 were paid by the Group during the Administrations, of which £679,760 was paid in the Reporting Period. These figures include distributions to the secured creditor but paid direct to directors (consultancy costs), UK Hotels (Finance) plc and other Administrations as agreed with the Secured Creditor and as detailed in the receipts and payments accounts at Appendix 2
- 5 4 Please refer to Appendix 2 for the amounts distributed to the Secured Creditor from each Administration estate
- 5 5 There have been insufficient asset realisations to repay LSREF in full. Each company in the Group and the Wider Group is unable to repay the full amount of the cross-guaranteed debt to LSREF in full

Preferential Creditors

- 5 6 None of the companies in the Group had any employees
- 5 7 No preferential claims have been received in relation any of the companies

- 5 8 Prescribed part distributions have been declared and paid for each of the companies as detailed below

Non-Preferential Unsecured Creditors

- 5 9 There will be insufficient asset realisations to enable a distribution to the non-preferential unsecured creditors, other than from the Prescribed Part, as noted above
- 5 10 As all of the companies will soon be dissolved, there will be no further payments to any class of creditor

UK Hotels (Finance) plc

- 5 11 UK Hotels (Finance) plc did not have any secured debt, any employees and the Prescribed Part does not apply
- 5 12 There have been insufficient asset realisations to enable a distribution to the non-preferential unsecured creditors of UK Hotels (Finance) plc

6. Joint Administrators' Receipts and Payments Accounts

- 6 1 Detailed receipts and payments accounts for all companies in the Group in respect of the Reporting Period and the Cumulative Period of the Administrations are shown at Appendix 2

7. Pre-Administration Costs

- 7 1 On 28 November 2014 the Pre-Administration costs (plus VAT) detailed at Appendix 4 of the Proposals were approved by the Secured Creditor, to be paid out of the assets of the relevant Administration estates. These costs have been paid in full

8. Joint Administrators' Costs and Expenses

All companies in the Group except for UK Hotels (Finance) plc

- 8 1 In accordance with Rule 2.106 of the Rules, the basis upon which the Joint Administrators' remuneration is fixed is by reference to the time properly given by them and their staff in attending to matters arising in the Administrations. Approval for this basis was agreed by the Secured Creditor on 28 November 2014. Category 2 disbursements were also approved regarding all companies on 28 November 2014

UK Hotels (Finance) plc

- 8 2 The Joint Administrators convened a creditors' meeting on 14 November 2014 in order to consider the Joint Administrators' basis of remuneration. The creditors' meeting was adjourned twice and reconvened on 21 November 2014 and on 28 November 2014. The creditors rejected the Joint Administrators' Proposals which included a resolution regarding the Joint Administrators' remuneration and therefore the Joint Administrators' basis of remuneration has not been agreed by the creditors of UK Hotels (Finance) plc
- 8 3 The secured creditor agreed to directly pay the Joint Administrators a fee of £35,000 plus disbursements in respect of UK Hotels (Finance) plc prior to the Reporting Period. Further, the secured creditor agreed to directly pay legal fees and disbursements of £11,170 in the Reporting Period. A breakdown of the Joint Administrators' disbursements is detailed below

- 8 4 Please note that £43 39 was paid directly by the Secured Creditor, with the balance of £708 09 being paid by the dividend received from Carlton Hotel (Edinburgh) Limited. This was paid directly to Duff & Phelps as UK Hotels (Finance) plc did not open an Administration bank account.

All companies in the Group

- 8 5 The time costs and disbursements charged by the Joint Administrators in the Reporting Period and since the Appointment Date are as analysed at Appendix 3.
- 8 6 Total remuneration of £584,000 has been paid in respect of the companies in the Group, of which £170,000 has been paid in the Reporting Period and £35,000 relates to UK Hotels (Finance) plc as noted at paragraph 8 3. Details of the remuneration drawn in each estate are shown in the receipts and payments accounts at Appendix 2.
- 8 7 The Joint Administrators' disbursements are also detailed at Appendix 3.
- 8 8 Duff & Phelps' disbursements policy and hourly charge out rates for each grade of staff that may undertake work in respect of the Group, is in a document called "A Creditors' Guide to Administrators' Fees". This can be viewed and downloaded from the Joint Administrators' website at <http://www.duffandphelps.com/uk-restructuring/creditor-guides>. Should you require a copy, please contact this office.
- 8 9 In accordance with Rule 2 48A of the Rules, Secured Creditors and unsecured creditors (with the concurrence of at least 5% in value of total unsecured creditor claims or with the permission of the court) may make a request in writing for further information about the remuneration or expenses set out in this progress report. This should be done within 21 days of receipt of this report, after which the Joint Administrators have 14 days to respond.
- 8 10 In addition to the above, any Secured Creditor, or any unsecured creditor (with the support of at least 10% in value of the total unsecured creditors or with the permission of the court) may apply to the court on the grounds that the remuneration or basis fixed for the Administrators' remuneration or the expenses incurred by the Joint Administrators are considered to be excessive. In accordance with Rule 2 109 of the Rules, this application must be made no later than eight weeks after receipt of the Progress Report, where the charging of the remuneration or the incurring of expenses in question occurs.

9 Conclusion and Ending the Administrations

- 9 1 The Joint Administrators consider that they are now in a position to conclude the Administrations and cease to act
- 9 2 As previously outlined, it is the intention of the Joint Administrators to exit the Administrations via dissolution
- 9 3 All assets have now been realised as outlined earlier in this report. The companies in the Group will be automatically dissolved three months after the Notices of Move from Administration to Dissolution have been filed by the Registrar of Companies. The relevant documentation, attached at Appendix 5, was sent to Companies House in respect of all companies in the Group on 10 September 2015

All companies in the Group except for UK Hotels (Finance) plc
