ORDER

IT IS ORDERED THAT:

- 1 Edward Thomas and Guy Robert Thomas Hollander be removed from office as Sole and/or Joint Trustee(s) in bankruptcy of the bankrupts listed in Schedule 1 attached hereto pursuant to Section 298(1) of the Insolvency Act 1986, with effect from 31 August 2017 and Matthew

Carter and Ann Nilsson be appointed as Joint Trustees in bankruptcy in substitution in respect of the said bankrupts where they are not already a Joint Trustee, with effect from the same date, pursuant to Section 298 of the Insolvency Act 1986.

2. Martin Dominic Pickard be removed from office as Joint Trustee in bankruptcy of the bankrupts listed in Schedule 2 attached hereto pursuant to Section 298(1) of the Insolvency Act 1986, with effect from 31 August 2017 and Edward Thomas be appointed as Joint Trustee in bankruptcy in substitution, together with the current joint appointee listed in Schedule 2 with effect from the same date, pursuant to Section 298 of the Insolvency Act 1986.
3. Martin Dominic Pickard be removed from office as Sole Trustee in bankruptcy of the bankrupts listed in Schedule 2 attached hereto pursuant to Section 298(1) of the Insolvency Act 1986, with effect from 31 August 2017 and Ann Nilsson and Edward Thomas be appointed as Joint Trustees in bankruptcy in substitution in respect of the said bankrupts with effect from the same date, pursuant to Section 298 of the Insolvency Act 1986.
4. Matthew Edward Carter be appointed as Joint Trustee in bankruptcy of the bankrupts listed in Schedule 3 attached hereto, together with the current appointee listed in Schedule 3, pursuant to Section 303(2) of the Insolvency Act 1986, with effect from 31 August 2017.
5. Martin Dominic Pickard and Guy Robert Thomas Hollander be removed from office as Sole and/or Joint Liquidator(s) of the companies in Creditors' Voluntary Liquidation listed in Schedule 4 attached hereto pursuant to Section 108 of the Insolvency Act 1986, with effect from 31 August 2017 and Simon David Chandler and Rebecca Jane Dacre be appointed as Joint Liquidators in substitution in respect of the said companies with effect from the same date, pursuant to Section 108 of the Insolvency Act 1986.
6. Martin Dominic Pickard be removed from office as Liquidator of the companies in Members' Voluntary Liquidation listed in Schedule 5 attached hereto pursuant to Section 108 of the Insolvency Act 1986, with effect from 31 August 2017 and Simon David Chandler and Rebecca Jane Dacre be appointed as Joint Liquidators in substitution in respect of the said companies with effect from the same date, pursuant to Section 108 of the Insolvency Act 1986.
7. Martin Dominic Pickard and Edward Thomas be removed from office as Joint Liquidators of the companies in Compulsory Liquidation listed in Schedule 6 attached hereto pursuant to Section 172 of the Insolvency Act 1986, with effect from 31 August 2017 and Simon David Chandler, Matthew Edward Carter and Edward Thomas be appointed in substitution in

respect of the said liquidations with effect from the same date in accordance with the proposed appointees set out in Schedule 6, pursuant to Section 172 of the Insolvency Act 1986.

8. Martin Dominic Pickard be removed from office as Joint Trustee of the insolvent estates of deceased persons subject to Insolvent Administration Orders listed in Schedule 7 attached hereto, pursuant to Section 421 of the Insolvency Act 1986, with effect from 31 August 2017 and Edward Thomas be appointed in substitution in respect of the said estates together with the current joint appointee, with effect from the same date, pursuant to Section 421 of the Insolvency Act 1986.
9. Where the appointments referred to in this Order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
10. Those bankruptcies, liquidations and Insolvent Administration Orders listed in Schedules 1 to 3 and 6 to 7 attached hereto which are (or were) proceeding in a County Court be transferred to the High Court for the purpose of this Order only.
11. Where required, any relevant notice required to be filed at Court be filed at the same time as the next notification as required pursuant to statute.
12. The appointments made pursuant to the application hearing be notified to the creditors at the same time as the next report pursuant to statute is made to the creditors.
13. The Respondents shall, when the next routine report is due to the creditors of each appointment, give written notice of the making of this Order to each such creditor, such notice to include the following matters:-
 - a. an explanation as to the effect of the Order; and
 - b. express reference to the liberty to apply as set out in the Order.
14. Liberty to each creditor of each bankruptcy, liquidation and insolvent administration to apply to vary or discharge this Order within 28 days of receipt of the notices directly to be sent under paragraphs 11 to 13 above.
