Diamond Coatings UK LimitedNotes to the Abbreviated Accounts for the year ended 31st March, 2007**1 Accounting policies**

**1.1 Basis of preparation of the Accounts** - the Accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005) The Company and its overseas subsidiary, Diamond Coatings Italia SRL, comprise a small group and as a result of this small group status the Company has taken advantage of the exemption provided by section 248 of the Companies Act 1985 not to prepare group accounts The Accounts therefore present information about the Company as an individual undertaking and not about its group

**1.2 Turnover** - turnover comprises the invoiced value of services supplied by the Company excluding VAT and includes the work in progress at the period end

**1.3 Tangible fixed assets and depreciation** - are stated at acquisition cost less depreciation Depreciation is provided at rates calculated to write off the cost of the fixed assets, less their estimated residual value, over their expected useful lives at the rate of 25% per annum on the reducing balance.

**1.4 Stocks** - comprise Work in Progress which has been valued at the lower of cost and net realisable value This value includes a proportion of the attributable overheads

**1.5 Foreign currencies** - transactions in foreign currencies are translated into Sterling at the rate ruling on the transaction date Exchange differences are taken into account in arriving at profit

**1.6 Deferred taxation** - the provision takes into account timing difference between the tax allowances claimed being greater than the depreciation provided for As the timing differences reduce so the provision will reverse itself
