Notes to the Abridged Financial Statements

Year ended 30 September 2021

1. General information

The company is a private company limited by shares, registered in England. The address of the registered office is 250 Aztec West, Almondsbury, Bristol, BS32 4TR, England.

2. Statement of compliance

These abridged financial statements have been prepared in compliance with Section 1A of FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

3. Accounting policies

Basis of preparation

The abridged financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through profit or loss.

The abridged financial statements are prepared in sterling, which is the functional currency of the entity.

4. Related party transactions

The company was under the control of the directors throughout the current and previous year. By virtue of their equal status and agreed contributions, there is no single over-riding controlling party.
