## Report of the trustees

The trustees present their report and financial statements for the year ended 31 March 2011

### Objectives and activities

The objectives of the charity are set out in full in its Memorandum and Articles The charity aims to promote and develop socio-economic programmes for the benefit of the communities, and those living in them, in areas in which Genesis Housing Group Limited owns or manages housing stock

The charity's activity in 2010-11 continues to be focused on developing and delivering socio-economic programmes aimed at Genesis Housing Group Limited's (Genesis) residents and supporting the communities in which they live, within the broad objectives of the charity. The scope of that activity has, by necessity, been defined by the capacity of the charity and its resources available to deliver its programmes. Activities have been prioritised by reference to the geographic concentration of Genesis' stock (focusing on the local authority areas and in neighbourhoods and communities where it has a significant presence) and by a parallel assessment of need. This is defined by local indices of deprivation and other indicators.

## Achievements and performance

#### New Developments

2010-11 has been an exciting year for the charity because, with our grant from Genesis restored to the level it had been prior to the cut of last year 2009-10, we have been able to launch the very innovative and radical new programme we have called Opportunities Plus. We have also very significantly enhanced our Financial Inclusion Programme, recruiting a dedicated manager to deliver this and additional advice staff.

#### Launch of the Opportunities Plus Programme

Opportunities Plus is latest strand in our overarching Opportunities for Life Change Programme and is an entirely new departure for the charity. It is a programme designed to offer empowerment and support targeted at those of Genesis residents who are in need. Its stated aim is to create opportunities for all Genesis residents who need to improve their life chances, through giving them the tools to help themselves.

This programme has significantly added to the charity's ability to extend its charitable aims to support as many of those residents of Genesis who are in need as possible, and also the communities in which they live. The Opportunities Plus Programme has been developed so that it is delivered as an integral part of the mainstream housing services of Genesis. The development of the Programme has been built on our learning and experience gained from the earlier pilot we developed as a project funded by the TSA Innovation and Good Practice Grant.

#### The Opportunities for Life Change Programme

The implementation of the Opportunities Plus Programme has meant that we have been able to consolidate and refocus our overarching Life Change Programme. The charity continues to successfully deliver its Life Change Programme but now with the Opportunities Plus programme as a very significant addition. All the core activities of the charity form essential strands of this all encompassing approach, which seeks both to improve the life chances of those housed by Genesis Housing Group Limited and of those who live in the neighbourhoods in which the Group operates, as well as building on the social capital within the communities where those residents live

For this year the three main strands to the Life Change Programme are Opportunities Plus, Young Peoples programme and the Programme for Old and Vulnerable People In addition the charity has continued to deliver the externally funded employment outreach programmes commissioned by London Borough of Hackney and Westminster City Council The charity has also developed its Financial Inclusion Programme It continues to work in local communities and manages five community centres and continues its community capacity building Small Grants Programmes

During the year the charity has supported 45 projects in 15 boroughs, and led and continued to manage the award winning Harrow Road Neighbourhood Renewal Partnership, in Westminster This partnership was awarded the title of Best UK Neighbourhood Renewal Programme for 2009

The highlights of our Programmes are

## **Opportunities Plus**

The Opportunities Plus Programme was launched in June 2010 following the successful recruitment of a team of seven advisers. In this year the team has focused on the London area but the intention is that in 2011-12 the reach of the Programme will be extended to include the remaining core operating areas of Genesis – Essex and Hertfordshire

The Opportunities Plus Programme works through the housing management service and the Opportunities Plus Officers work alongside Property Managers and take referrals from those managers. The Opportunities Plus officers also take self referrals by residents. The remit of the Programme is to engage with residents in need of support across a range of issues from worklessness through benefits advice to broader issues around access to health care or child care. The stated aim of the Programme is to help residents to help themselves by building up their confidence and supporting them to both identify the issues for which they need help and support and then guide the resident to the most appropriate services local to where they live and which address their needs

In the period from June 2010 to March 2011, the Opportunities Plus Officers have received a total of 1,020 referrals resulting in 1,167 cases (some referrals had multiple cases). The cases have covered a wide range of areas from employment issuers including job search (37%), skills training courses 18%, volunteering opportunities 6% and money and debt advice14%

#### **Employment Initiatives**

During the year, the decision was taken that the charity's focus on supporting workless residents and those seeking to improve their employment skills would be covered through the Opportunities Plus Programme and that has proved an effective way of engaging with residents in this areas

Our separate Employment Outreach and Engagement Programme has therefore been scaled back to the two commissioned projects namely the Hackney Ways into Work Programme funded by LB of Hackney and the Westminster Works programme. This latter has been a partnership led by the charity of Genesis, City West and Octavia HA funded in part by Dolphin Square foundation and in part by LAA funding through Westminster CC

This is the last year of both these projects as the funding has been withdrawn by the Government. The targets for engaging with residents seeking work under each of these programmes have continued to be challenging but in both cases the charity has been successful in meeting those targets.

In Hackney Ways into Work programme the figures are

- 1,204 residents engaged through out reach
- 405 clients registered onto the programme
- 371 referred onto the "Client Gateway"
- 9 events delivered

## In Westminster Works

- 3,328 residents engaged through outreach
- 505 clients registered onto the programme and referred to advisers
- Across the whole of WW at least 297 into jobs
- Across the whole of WW At least 317 people into training
- 9 job fairs delivered

#### Youth Programme

The Youth Programme continued to deliver its Three Stage Youth Programme engaging young people in Genesis neighbourhoods in Brent, Camden, Hertfordshire, Ealing, Tower Hamlets, Newham and Redbridge The street outreach element continued to engage young people aged 8 – 19 years of age through building relationships and forming trust among residents within these neighbourhoods. The offering of mentoring support, information workshop opportunities and to sign post to local youth provides was also offered to young people. This approach was designed to develop personal and social development and to enhance life skills. During the year the team engaged 1,321 young people of whom 439 went onto attend mentoring/registration sessions within one of the Genesis youth projects. 90 young people took up training opportunities and 21 went into volunteering and part time/full time paid employment. Genesis Community delivered the youth projects in Brent and Camden, the other elements of project delivery was commissioned and delivered by the following partners.

With many new Genesis developments completed in East London area, the Youth Team have during the year focused the major estate areas Newham and Tower Hamlets engaging with young people through outreach and door knocking East London will continue to be an area of focus for the youth team from April 2011 onwards

One of the challenges is the lack of suitable community facilities in parts of East London, so the youth team are establishing key partnerships with local services and youth providers to ensure that our local residents have access to youth services

Our Youth Programme is also developing sports programmes with local partners in Brent to deliver weekly sessions in basketball and football. Genesis is in discussions currently to take this forward to develop and deliver sports accreditation training opportunities for young people from the summer of 2011.

#### Older Persons Programme

The charity continues to develop and promote a range of projects involving older people across Genesis' Supported Housing both in East London and Essex and in residential schemes in West London. The key theme is Life Long Learning

A range of projects have been run over the year including

• A continuation of the well established and very successful digital inclusion IT learning programme which continues in Essex through funding from the Big Lottery to an Essex wide partnership of which the charity is a lead partner. This has resulted in a further 720 (this is only up to Quarter 3 figures) older people learning how to access the internet and communicate with family and friends through email or receiving further tutorials and workshops in computer skills. The project also promotes its work to residents in General Needs accommodation and the general public. The London UniTe project continues to provide workshops and training and the charity has also been successful in securing grant funding to extend the programme to two West London residential schemes which have featured on ITV 1's 'Daybreak'. To date 341 residents have received training

## Report of the trustees (continued)

- Learning activities in Genesis' residential supported housing schemes in East London covering a range of
  activities including health and exercise, art and craft and social activities. These activities continue to be
  well received with over 340 residents taking part. In January 2011 the team conducted a consultation
  workshop at the schemes to engage with the residents and determine what new activities can be developed
  and built upon.
- The Knitty Nora's knitting project continues to flourish. It has supported several national and international
  charities and the intergenerational work is still well received. In July 2010 the project won a national
  Bloom Award for encouraging hope, freedom, enjoyment, achievement, and a sense of belonging in
  services for older people.
- The three Active Citizens' community groups in Westminster, Brent and Barnet aimed at isolated older residents living on their own
- Working with Genesis' floating support team to deliver projects identified by their general needs residents
- The charity has recently started working in partnership with Eastwards Trust on several new initiatives to support Asian elders in residential schemes and the Charity funded a celebration event for over 100 residents in January Three new pilot projects are planned for 2011/12 which includes befriending and intergenerational work
- The charity has also worked with the Genesis Disability Forum to develop a service for disabled residents Funding was secured for an IT training course tailored to the individual needs and delivered at a beginner, intermediate and advanced level. The forum members will also deliver information sessions in local schools in June to promote disability awareness and try to combat initial prejudices and challenge stereotypes.

## Financial Inclusion

The other significant advance to our services which has happened during this year has been the strengthening and expansion of the Financial Inclusion Programme. In July we successfully recruited a Financial Inclusion manager who took up post at the beginning of September. The first challenge for the new manager was to produce a Financial Inclusion Strategy for Genesis as the basis for developing the service and integrating it into the Genesis Customer Accounts Section. This has been successfully achieved.

Our target is to provide a wide range of advice and support to residents in greatest need. To this end we have begun the recruitment of two benefits advice officers to augment the team. The focus of our strategy will be on providing advice and support across a range of financial topics including budgeting and money management, debt advice and support, a benefits advice service and run workshops on energy efficiency and avoiding fuel poverty. The charity's strategy will be to explore the development of effective partnerships with advice organisations and with community based financial institutions such as credit unions. This has already begun with Brent CU

The Financial Inclusion Team will work closely with both the Customer Accounts Teams and with Opportunities Plus officers to ensure we are providing a joined up service

#### Small Grants Programme

The charity provides a community based small grants programme with two strands First the Community Chest makes grants to small community organisations across the operating areas of Genesis Housing Group Limited Secondly through the Knowles Trust small grants are made to support Genesis Supported Housing and local external organisations working with old and vulnerable people

## Report of the trustees (continued)

#### **Grant Making Policy**

All grant applications for the Genesis Small Grants Programme go through a scrutiny process within Genesis Community Foundation conducted by its Grants Officer to evaluate the bids against the charity's grant making criteria set out in its grant making guidelines. These guidelines are made available to applicants. The Grants Officer makes recommendations to the Head of Genesis Community Foundation, who has authority from the Board to approve the grants, on which he reports to the Board on a regular basis. In the case of the Knowles Trust, he makes recommendations to the Board of Trustees who approve the grants.

The Community Chest is a very important tool in developing capacity building amongst small grass roots organisations in the community. The charity continues to be oversubscribed for its grants

## **Community Centres**

The charity manages five community centres for Genesis namely Hartspring Lane and The Phoenix, both in Bushey, The Vale in Kilburn, Savoy Court in Harrow, and Mulberry Court in Neasden

The Centres are widely used by local groups and projects For example in Hartspring Lane there are eight community groups using the Centre and running programmes during the week ranging from mother and toddlers sessions to yoga and fitness, and Zumba dancing, as well as a daily after-schools club which has benefited considerably from the charity's support in capacity building and also grant funding from the Small Grants Fund

The Vale Centre in Kilburn is used by over a dozen community groups regularly offering a variety of sessions such as family support, older people's activities, 'cooking for kids', literacy and numeracy training, and other community services. The Vale is pivotal in local community activities, being the home of the Kilburn Consortium for Cohesion, and the Vale Older People's Consortium, which between them bring together a wide spectrum of the community for regular networking and joint capacity building for the small local service providers comprising the two consortia Genesis has been instrumental in ensuring the continued success of these community groups, being involved in all consortium meetings and offering one to one support to many of them. Overall the centre is used by two to three hundred people on a weekly basis

Of the other centres, Savoy Court is developing a little more slowly than the other centres due to issues with the local residents and due also to the absence of parking facilities on site. We have nevertheless managed to attract several community groups that offer activities acceptable to the residents such as educational training for special needs children, fitness for elders, financial inclusion advice

Overall across all the Centres there has been an increase in income derived from hire charges, up from £26k last year to £44k this year and through cost cutting measures expenses were reduced from £42k to £32k over the same period

## Plans for 2011-12

## Meeting New Challenges

The restructuring of Genesis Housing Group Limited by amalgamating Pathmeads Housing Association Limited, Springboard Housing Association Limited and Paddington Churches Housing Association Limited to become one single entity- Genesis Housing Association Limited, has opened new and challenging ways for the charity to work across Genesis It presents exciting opportunities to develop new ways of delivering our programmes to create greater integration into the mainstream of Genesis in tackling poverty and deprivation within our resident base and the communities in which they live

## Report of the trustees (continued)

In the year ahead our main development objectives are to extend Opportunities Plus into Essex and Hertfordshire, to build up the Financial Inclusion capacity to deliver, to develop a new Volunteering Programme that will be able to offer volunteering opportunities to residents and staff alike, to start to build up an enterprise culture within Genesis and in the communities in which we operate working with external organisations both to run business start up programmes for residents and to develop social enterprises

These are all significant challenges, but the Trustees are confident that the charity will be able to deliver on them and are very pleased that Genesis has agreed to increase its grant for the year ahead to £1 6m to support the continued development of the charity's work with its residents

The greatest area of concern in terms of challenges will be how the charity adapts to the new economic climate of benefit caps and withdrawal of funding streams. For the Trustees the concerns are that the charity will find increasing numbers of vulnerable residents seeking support and guidance as a result of job loss, benefit cuts and similar. It is also extremely likely that a significant number of smaller third sector organisations with which the charity partners, and on whom it relies to make referrals, will either go out of business or be reduced in their capacity to deliver through funding cuts.

At this stage the Board can but be aware of these challenges and monitor them closely through its officers, which it will do, being very much aware that future methods of working may well have to change to meet changing needs and demands

#### Efficiency Plans

The charity works hard to achieve efficiency savings and will continue to seek efficiencies wherever possible. The Trustees are confident that through greater emphasis on efficiency and use of resources the charity will create even more effective outcomes.

#### **External Funding**

External funding has all but dried up as a result of the comprehensive spending review and such that may be available in the future is undoubtedly going to remain largely a commissioning source of finance such as the Westminster and Hackney employment programmes. The policy of the Board is to seek funding to deliver projects that have synergy with, or will naturally extend, the reach of the existing programmes delivered by the charity

#### Financial review

The statement of financial activities is set out on page 14 and shows the results for the year

The charity received £2,261k in income during the year. The net increase in these funds before other gains was £220,479 which was largely as result of the increase of the grant from Genesis Housing Group Limited from £750,000 for the previous year to £1,380,416

#### Corporate governance

Genesis Community Foundation is registered as a company limited by guarantee. It was incorporated on 2 February 2005 and is a charity registered with the Charity Commission. It is governed by its Memorandum and Articles of Association.

Genesis Housing Group Limited is currently the sole member of the charity and has the power to appoint and remove the Trustees are selected by a process of recommendation followed by a period of discernment by Trustees and confirmed by a vote of the Board Newly appointed Trustees are given a copy of the charity's latest financial statements and are made aware of the objectives of the charity. Training is provided to individual Trustees as is considered appropriate to their level of experience and knowledge. All decisions are taken by the Trustees at formally constituted meetings, which are held at intervals determined by the Trustees, usually four times a year. All decisions of the Trustees are formally minuted. Administration support services are provided by Genesis. The directors of the charitable company (the charity) are its Trustees for the purpose of charity law and throughout this report are collectively referred to as the Trustees.

The Board met three times during the year On one occasion all seven Trustees were present and the attendance for the other two meetings was 5 and 6 Trustees respectively

All Board members are appraised annually through various appraisal processes depending on whether they are also employees of Genesis or independent members and the Board is satisfied with the process

Review of internal controls is delegated to the Internal Audit Team of Genesis who regularly checks that systems and controls are in place

#### Public benefit statement

The Trustees have conducted a comprehensive review of the stated objects of the charity and are satisfied that all of these are capable of being delivered for the public benefit

The Trustees have referred to the Charity Commission guidance on Public Benefit when reviewing the charity's aims and objectives, in setting the grant making policy for the year and in planning future activities. Having done so the Trustees have conducted a comprehensive review of the stated objects of the charity and are satisfied that all of these are capable of being delivered for the public benefit.

## Report of the trustees (continued)

They have further reviewed all the activities of the charity tested against the charitable objects of the charity

- first to ensure that they fall within its charitable objects and
- secondly to test that each activity is being delivered in a manner which can be construed as being for the public benefit

The Trustees are satisfied that there are no activities conducted or promoted by the charity that are not open to all people falling within a defined class or category within the broad parameters of the objects of the charity. For example some of the work of the charity is predominantly focused on residents living within stock owned or managed by Genesis.

The Trustees have tested this limitation against the requirement of public benefit, and are satisfied that because the method of selection of residents by Genesis, and its nominating Local Authority partners, is open to all who meet the statutory and other criteria for eligibility for social housing, the work of the charity in addressing the needs of that category of persons is sufficiently wide and open, that it falls within the statutory definition of being for public benefit

Other projects run by the charity are focused on particular neighbourhoods or communities within local authority areas where Genesis owns or manages stock and are open to all who meet the broader charitable objects of need as defined by the objects of the charity with that area

The objects of the charity are set out in full in its Memorandum and Articles, but in summary it aims to promote and develop socio-economic programmes for the benefit of the communities, and those living in them, in areas in which Genesis owns or manages housing stock. In furtherance of these objectives the charity has been very active in the past year, and some of the key achievements are highlighted below.

#### Investment policy and performance

The Trustees reviewed the investments early in the year and resolved to leave the investments in the Charities Aid Foundation funds taking the view that the investments had performed as well as their realistic expectations given the serious economic downturn. The overall return was at about 4% in line with expectations. The funds showed a gain of 1.7% compared to 2010 values and have underperformed the UK general stock market.

The Trustees have adopted a policy of reviewing the investment performance to ensure the investments maintain a steady yield and growth in line with overall market trends. To achieve this, the Trustees' policy is to receive a quarterly report on income and growth performance and to review the investments in each financial year to consider what further advice might be necessary. The Trustees recognise this is a relatively modest fund and therefore wish to avoid heavy costs of an independent review unless a dip in performance of the Fund indicates a good reason to do

The Trustees are very aware that the costs of such reviews must be borne out of the income generated by the fund which in turn diminishes their ability to make grants to those in most need

### Reserves policy

The Trustees have considered the need for maintaining a level of free reserves. At the end of the year these stood at £597,690 and all of these reserves are designated for agreed projects within the operating plan of the Charity as detailed in note 9.

The Trustees have concluded that, as a matter of policy, they do not need to maintain further free reserves having regard to the particular circumstances of the charity. The charity's core funding and the bulk of all its unrestricted funding derives from Genesis and Genesis is committed to continuing to fund the charity. External funding is entirely project based and those funded projects only have a life which is co-extensive with the funding

## Risks policy

The Trustees believe in accepting manageable risks, which are unavoidable in carrying out their strategic objectives and prioritising actions that minimise them. The Trustees recognise that sound risk management is at the core of every successful business. They understand the need to take a balanced approach to risk through effective controls that ensure risks are managed and minimised, thereby enhancing the chances of business success. They have established a Risk Register which the Board resolved at its meeting on 10 March 2010 that it will review twice annually. The Trustees are satisfied that there are systems and procedures in place to manage those risks.

#### Disclosure of information to auditor

The Trustees who held office at the date of approval of this Trustees' report confirm that, so far as they are each aware, there is no relevant audit information of which the charitable company's auditor is unaware, and each director has taken all the steps that he/she ought to have taken as a trustee to make himself/herself aware of any relevant audit information and to establish that the Company's auditor is aware of that information

#### Auditor

Pursuant to Section 487 of the Companies Act 2006, the auditor will be deemed to be reappointed and KPMG LLP will continue in office

## Independent auditor's report to the members of Genesis Community Foundation

We have audited the financial statements of Genesis Community Foundation for the year ended 31 March 2011 set out on pages 14 to 24. The financial reporting framework that has been applied in their preparation is applicable law and UK Accounting Standards (UK Generally Acceptable Accounting Practice)

This report is made solely to the company's members, as a body, in accordance with Chapter 3 of Part 16 of the Companies Act 2006. #### 1 Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements

#### Basis of preparation

The financial statements have been prepared under the historic cost convention, with the exception of investments which are included at market value and in accordance with the Statement of Recommended Practice – Accounting and Reporting by Charities (SORP 2005) issued in March 2005, applicable UK Accounting Standards and the Companies Act 2006 The principal accounting policies adopted in the preparation of the financial statements are set out below

Under FRS 1 the charity company is exempt from the requirement to prepare a cash flow statement on the grounds that a parent undertaking includes the charity in its own published consolidated financial statements

#### Incoming resources

Voluntary income including donations, gifts and legacies and grants that provide core funding or are of general nature are recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability. Such income is only deferred when

- The donor specifies that the grant or donation must only be used in future accounting periods, or
- The donor has imposed conditions which must be met before the charity has unconditional entitlement

Investment income is recognised on a receivable basis

Income from charitable activities includes income received under contract or where entitlement to grant funding is subject to specific performance conditions is recognised as earned (as the related goods or services are provided) Grant income included in this category provides funding to support performance activities and is recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability

#### Resources expended

Expenditure is recognised when a liability is incurred. Contractual arrangements and performance related grants are recognised as goods or services are supplied. Other grant payments are recognised when a constructive obligation arises that will result in the payment being unavoidable.

Support costs, which include central functions, have been allocated to activities as a proportion of the particular activity cost to total activity cost

Governance costs include costs associated with the legal, strategic and governance arrangements of the charity

#### Investments

Listed investments are stated at their market value

## 1 Accounting policies (continued)

## Post-retirement benefits

Defined benefit schemes

The company is recharged contributions made by Genesis Housing Group Limited to defined benefit schemes. Assets are held separately from those of the Group. The amount charged to the income and expenditure account represents the contributions payable to the schemes during the financial year.

In the financial statements of Genesis Housing Group Limited, the pension surplus (to the extent that it is recoverable) or deficit is recognised in full. The movement in the scheme surplus/deficit is split between operating charges, finance items and, in the statement of total recognised surpluses and deficits, actuarial gains and losses.

Money purchase scheme

The company is also recharged contributions made by Genesis Housing Group Limited to a defined contribution scheme where the amount charged to the income and expenditure account represents the contributions payable to the scheme in respect of the financial year

## Fund accounting

Restricted reserves

The charity has a number of restricted income funds to account for situations where donors require that a donation must be spent on a particular purpose or where funds have been raised for a specific purpose

Designated reserves

Designated funds are unrestricted funds earmarked by the trustees for particular purposes
