The Plan now is to hold the first exhibition in relation to the launch of a book by Prof. Joel Kotek on the topic. We now have a provisional date for June 2008 for this publication and together with the launch of the book.

The exhibition will be held in the first instance at the Political Cartoon Gallery in London.

We are approaching other venues to hold the exhibitions as well at later dates.

To show the similarity between historical discredited images of Anti-Semitism and those produced today

The company will mount an exhibition showing images from medieval times, folk Anti-Semitism of the 18th century, 19th century Anti-Semitism, fascist and Nazi images and images produced today in the Islamic world and echoed sometimes in the Western media

Many of the images are in the form of published cartoons
