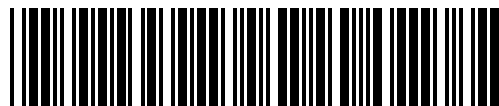

THE NON-VOTING ORDINARY SHARES SHALL BE NON-TRANSFERRABLE; AND C. THE NON-VOTING ORDINARY SHARES MAY BE REDESIGNATED AS ORDINARY SHARES BY THE BOARD, OR A DULY AUTHORISED REPRESENTATIVE THEREOF, ONLY UPON RECEIPT OF A NOTICE (AS DEFINED HERE) AND OTHERWISE SUBJECT TO THE TERMS AND CONDITIONS ATTACHED TO THE NON-VOTING ORDINARY SHARES.
