1 Interpretation

2 Sale of the Sale Shares

The Vendor shall sell the Sale Shares to the Purchaser on terms that they are free from all claims, liens, charges, encumbrances and equities and all other third party rights and also, but without prejudice to those terms, with full title guarantee and the Purchaser shall purchase the Sale Shares.

3 Consideration

3.1 The consideration for the sale of the Sale Shares shall be the allotment and issue by the Purchaser to the Vendor of the Consideration Shares credited as fully paid.

4 Completion

Completion of the sale and purchase of the Sale Shares shall take place immediately following the execution hereof, when:

- (a) the Vendor shall deliver or procure to be delivered to the Purchaser transfers in respect of the Sale Shares duly completed in favour of the Purchaser together with the certificates therefor; and
- (b) the Purchaser shall allot and issue the Consideration Shares to the Vendor and deliver to the Vendor a share certificate in the name of the Vendor in respect thereof.
