**"holder"** in relation to a share in the capital of the Company means the member whose name is entered in the register as the holder of that share,

**"in writing"** means in hard copy form or, to the extent permitted by the Act, in any other form,

**"member"** means a member of the Company,

**"office"** means the registered office of the Company from time to time,

**"paid"** means paid or credited as paid,

**"qualifying person"** means an individual who is a member of the Company, a person authorised under section 323 of the Act to act as the representative of a corporation in relation to a meeting or a person appointed as proxy of a member in relation to the meeting,

**"register"** means the register of members of the Company,

**"seal"** means the common seal of the Company and includes any official seal kept by the Company by virtue of section 39 or 40 of the Act,

**"secretary"** means the secretary of the Company (if any) and includes a joint, assistant, deputy or temporary secretary and any other person appointed to perform the duties of the secretary,

**"subsidiary undertaking"** or **"parent undertaking"** is to be construed in accordance with section 1162 (and Schedule 7) of the Act which for the purposes of this definition shall be treated as including any person the shares or ownership interests in which are subject to security and where the legal title to the shares or ownership interests so secured are registered in the name of the secured party or its nominee pursuant to such security, and

**"United Kingdom"** means the United Kingdom of Great Britain and Northern Ireland

Unless the context otherwise requires

- (1) words and expressions to which a particular meaning is given by the Act as in force when the Articles are adopted, shall have the same meaning in the Articles except where the word or expression is otherwise defined in the Articles

References to a document include, unless the context otherwise requires, references to an electronic communication

References to a document being executed include references to its being executed under hand or under seal or in the case of an electronic communication, by electronic signature.

Words denoting the singular number include the plural number and vice versa, words denoting the masculine gender include the feminine gender, and words denoting persons include corporations.

The *ejusdem generis* principle of construction shall not apply. Accordingly, general words shall not be given a restrictive meaning by reason of their being preceded or followed by words indicating a particular class of Act, matters or things or by examples falling within the general words

Headings and marginal notes are inserted for convenience only and do not affect the construction of these Articles

Where an ordinary resolution of the Company is expressed to be required for any purpose, a special resolution is also effective for that purpose

References to any statutory provision or statute include all modifications thereto and all re enactments thereof (with or without modification) and all subordinate legislation made thereunder in each case for the time being in force. This paragraph does not affect the interpretation of the first paragraph of Article 3

A member is "present" at a meeting if the member (being an individual) attends in person or if the member (being a corporation) attends by its duly authorised representative, who attends in person, or if the member attends by his or its duly appointed proxy, who attends in person

In these Articles, (a) powers of delegation shall not be restrictively construed but the widest interpretation shall be given to them, (b) the word "**board**" in the context of the exercise of any power contained in these Articles includes any committee consisting of one or more directors, any director holding executive office and any local or divisional board, manager or agent of the Company to which or, as the case may be, to whom the power in question has been delegated, (c) no power of delegation shall be limited by the existence or, except where expressly provided by the terms of delegation, the exercise of that or any other power of delegation, and (d) except where expressly provided by the terms of delegation, the delegation of a power shall not exclude the concurrent exercise of that power by any other body or person who is for the

time being authorised to exercise it under these Articles or under another delegation of the power.

- (b) the allotment of another share ranking in priority for payment of a dividend or in respect of capital or which confers on its holder voting rights more favourable than those conferred by that share or class of shares,

but shall not be deemed to be varied by the creation or issue of another share ranking equally with, or subsequent to, that share or class of shares or by the purchase or redemption by the Company of its own shares.

#### SHARE CERTIFICATES

Members' rights  
to certificates

14 Every member, upon becoming the holder of any shares, shall be entitled within two months without payment to one certificate for all the shares of each class held by him (and, upon transferring a part of his holding of shares of any class, to a certificate for the balance of such holding) or several certificates each for one or more of his shares upon payment for every certificate after the first of such reasonable sum as the directors may determine. Every certificate shall be issued under the seal, which may be affixed or printed on it, or shall be signed by two directors of the Company or by a director and the secretary of the Company or by one director in the presence of a witness who attests his signature, or shall be issued in such other manner as the board may approve and shall specify the number, class and distinguishing numbers (if any) of the shares to which it relates and the amount or respective amounts paid up thereon. The Company shall not be bound to issue more than one certificate for shares held jointly by several persons and delivery of a certificate to one joint holder shall be a sufficient delivery to all of them.

Any director may waive notice of a meeting and any such waiver may be retrospective.
Quorum	75	The quorum for the transaction of the business of the board may be fixed by the board or these Articles and unless so fixed at any other number shall be two except that where the Company shall have only one director, the quorum shall be one. A person who holds office only as an alternate director shall, if his appointor is not present, be counted in the quorum. Any director who ceases to be a director at a board meeting may continue to be present and to act as a director and be counted in the quorum until the termination of the board meeting if no director objects.

If they do not, it shall be signed by at least one director and the secretary, by two directors or by one director in the presence of a witness who attest his signature. Any instrument may be executed under the seal by impressing the seal by mechanical means or by printing the seal or a facsimile of it on the document or by applying the seal or a facsimile of it by any other means to the instrument. An instrument signed by a director and the secretary or by two directors or by one director in the presence of a witness who attest his signature and expressed (in whatever form of words) to be executed by the Company has the same effect as if executed under the seal.

- (b) any resolution passed by the Company, the holders of any class of shares in the capital of the Company, the board or any committee of the board, whether in physical form or electronic form; and
- (c) any book, record and document relating to the business of the Company, whether in physical form or electronic form (including without limitation the accounts).

If certified in this way, a document purporting to be a copy of a resolution, or the minutes or an extract from the minutes of a meeting of the Company, the holders of any class of shares in the capital of the Company, the board or a committee of the board, whether in physical form or electronic form shall be conclusive evidence in favour of all persons dealing with the Company in reliance on it or them that the resolution was duly passed or that the minutes are, or the extract from the minutes is, a true and accurate record of proceedings at a duly constituted meeting.
