The Deferred Shares grant the holder no rights to receive notice or to attend or vote at any general meeting of the Company and do not confer any other voting rights in relation to any resolution of the members. The Deferred Shares give no entitlement to any dividend or any other distribution of the Company. The entitlement of holders of any Deferred Shares to participate on a return of capital on a winding up of the Company shall be limited to the repayment of the amount paid up on such Deferred Shares to a maximum of 0.5 pence per Deferred Share and such entitlement shall take place only after each of the members has received this entitled sum plus the payment in cash of £1 million Holders of the Deferred Shares shall not be entitled to any other return of capital or right of participation in the assets of the Company.
