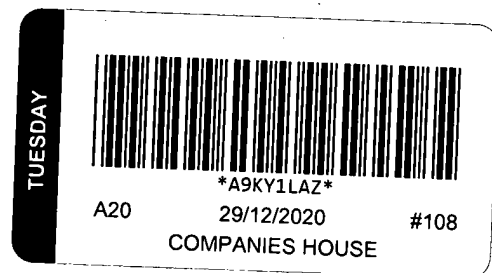

1 STATUTORY INFORMATION

Rowner (Rodney Close) Residents Company Limited is a private company, limited by shares, registered in England & Wales. The company's registered number is 05398101 and registered office address is located at Unit 8 The Forum, Minerva Business Park, Lynchwood, Peterborough, PE2 6FT.

2 ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

3 ULTIMATE CONTROLLING PARTY

In the opinion of the directors the company does not have one ultimate controlling party.

4 ACCOUNTING POLICY

In line with RICS (Royal Institute of Chartered Surveyors) guidance on accounting for service charge income, dormant accounts have been prepared for the financial period ending 31 March 2020.

As the service charge fund is held in trust for the contributors to the fund, it is not a part of the assets of the residents company and should not therefore be shown in the balance sheet. Equally the income and expenditure relates to the fund and not to the residents company, therefore dormant accounts are applicable.

Income and expenditure into and out of the service charge fund for the accounting period is fully disclosed in the audited service charge accounts.
