AND UPON the proposed liquidators filing with the Court a statement of being qualified under the Insolvency Act 1986 to act as an insolvency practitioner in relation to the Company and consenting to act

IT IS ORDERED pursuant to section 108(2) of the Insolvency act 1986 that:

- 1 The Respondent be and he is hereby removed from office as liquidator of Cannon Automotive Limited (in Liquidation) and be replaced by David Standish and Kristina Kicks (both of KPMG LLP);
- 2 Any act required or authorised under any enactment to be done by the liquidator is to be done by both or any one of them;

- 3 The Applicant's claim in the liquidation of the Company is admitted in the sum of £4,394,561.70; and
- 4 Costs of the Respondent shall be paid as an expense of the liquidation.
