#### Directors' Report for the period ended 30 June 2015

The directors present their report and the audited financial statements for Apia Regional Office Fund (General Partner) Limited ('the Company') for the period from 1 January 2014 to 30 June 2015.

#### **Directors**

#### **Principal Activities**

The principal activity of the Company is property investment by way of a 0.02063% (2013: 0.02063%) interest in the Apia Regional Office Fund Limited Partnership (the 'Partnership') and the holding of shares in other property companies as detailed in note 6 to the financial statements. The Partnership is a partnership within the meaning of the Limited Partnerships Act 1907 and the Company is the General Partner to the Partnership.

#### **Future Outlook**

During the period, the Partnership sold its investment properties. The directors expect to wind up both the Partnership and the Company within 12 months of the period end date.

No liquidation costs have been included in the financial statements of the Company as the directors consider such costs will be borne by the Partnership.

#### Dividend

The directors do not recommend the payment of a dividend for the financial period ending 30 June 2015 (2013: £nil).

# **Going Concern**

During the period, as the Partnership sold its investment properties the directors expect to wind up both the Partnership and the Company within 12 months of the period end date. These financial statements have therefore been prepared on a basis other than going concern. Adjustments were made in these financial statements to reclassify fixed assets as current assets.

#### **Employees**

The Company has no employees (2013: none).

#### **Independent Auditors**

It is the intention of the directors to reappoint the auditors under the deemed appointment rules of Section 487 of the Companies Act 2006.

#### **Material Events**

Following the appointment of CCW Recovery Solutions as administrator of Warner Estate Holdings plc (WEH) on 28 August 2013, WEH was dissolved on 2 December 2015. The remaining group companies are in liquidation.

# Report on the financial statements

#### Our opinion

#### Notes to the financial statements

### 1. Accounting policies

#### a) Basis of presentation

The Company is a private company limited by shares, which is incorporated and domiciled in England and Wales. The address of the registered office is given on page 3. The nature of the Company's operations and its principal activities are set out on page 4.

The financial statements have been prepared in accordance with International Financial Reporting Standards (IFRSs) as adopted by the European Union (IFRS as adopted by the EU), IFRIC interpretations and the Companies Act 2006 applicable to companies reporting under IFRS.

Consolidated financial statements have not been prepared as the Company qualifies for exemption under section 402 of the Companies Act 2006.

The principal accounting policies are set out below and have, unless otherwise stated, been applied consistently throughout the current period and preceding year.

Unless otherwise noted, the amounts shown in these financial statements are in pounds sterling ("£"), the functional currency of the Company.

Information on the ultimate controlling parent and immediate parent can be found on page 20.

#### b) Going concern

During the period, as the Partnership sold its investment properties the directors intend to wind up both the Partnership and the Company within 12 months of the period end date. These financial statements have therefore been prepared on a basis other than going concern. Adjustments were made in these financial statements to reclassify fixed assets as current assets. No accrual has been made for costs relating to liquidation as all such costs are expected to be borne by the Partnership.

#### c) Strategic Report

A strategic report has not been included in these audited financial statements as the Company qualifies for exemption as a small entity under Section 382 of the Companies Act 2006 relating to small companies.

#### d) New standards and interpretations not applied

The International Accounting Standards Board (IASB) and International Financial Reporting Interpretations Committee (IFRIC) have issued a number of standards and interpretations with an effective date after the date of these financial statements. The General Partner does not consider that any of these may have a material impact on the financial statements in future periods.

#### e) Critical accounting estimates and assumptions

In the process of applying the Company's accounting policies, management has made no judgements that have a significant effect on the amounts recognised in the financial statements.

#### f) Investments

The investments in subsidiary undertakings are held as current assets. Investment in the Partnership, is shown in the Statement of Financial Position at net realisable value, equivalent to the Company's share of the net assets of the Partnership. Unrealised gains and losses in the value of the Partnership are taken directly to the statement of comprehensive income.

#### g) Cash

All expenses are settled on behalf of the Company by the Partnership. The Company has no cash or cash equivalents. Consequently, no cash flow statement has been produced.

#### h) Provisions and contingent liabilities

Provisions are recognised when the Company has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate of the amount of the obligation can be made. Where the Company expects a provision to be reimbursed, for example under an insurance contract, the reimbursement is recognised as a separate asset but only when the reimbursement is more probable than not

Contingent liabilities are disclosed if the future obligation is probable and the amount cannot be reasonably estimated.

Deferred tax is provided on temporary differences arising from investments in subsidiaries, associates and joint ventures, except where the timing of the reversal of the temporary difference can be controlled and it is probable that the difference will not reverse in the foreseeable future.

#### i) Financial instruments

Financial assets and financial liabilities are recognised in the Statement of Financial Position when the Company becomes a party to the contractual provisions of the instrument.

Trade receivables are measured at initial recognition at fair value, and subsequently measured at amortised cost using the effective interest rate method. Appropriate allowances for estimated irrecoverable amounts are recognised in the Statement of Comprehensive Income when there is objective evidence that the asset is impaired. The allowance recognised is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the effective interest rate computed at initial recognition.

Trade payables are initially measured at fair value, and are subsequently measured at amortised cost using the effective interest rate method.

#### j) Investment income

Investment income consists of distributions made by the Partnership and are accounted on an accruals basis.

#### k) Income taxes

The current tax expense is based on the taxable profits for the period, after any adjustments in respect of prior years. Tax, including tax relief for losses if applicable, is allocated over profits before taxation and amounts charged or credited to reserves as appropriate.

Provision is made for deferred tax liabilities, or credit taken for deferred tax assets, using the liability method, on all material temporary differences between the tax bases of assets and liabilities and their carrying amounts in the financial statements.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

#### l) Prior year restatement

The brought forward balances have been restated to include the investment by the Company in Apia Regional Office Fund (No.1) Limited, increasing the investment in subsidiary undertakings from £2 to £3.

#### 2. Directors' emoluments

The directors are remunerated by Aviva Investors Employment Services Limited and Isobel Assetco Limited in respect of their services. No separate charge is made to the Company.

# 3. Employees

The Company had no employees during the financial period (year ended 31 December 2013: nil).

#### 4. Sundry income
