# Strategic Report

#### Context

Direct Group Investment Limited (the "Company") is a subsidiary of the ultimate UK parent Ryan Specialty Group Europe Limited ("RSGEL"). RSGEL and its subsidiary undertakings hereby referred to as the UK Group. The Company's ultimate parent company is Ryan Specialty Group, LLC ("RSG").

The annual report and financial statements present the results of the Company.

#### Strategy and objectives

#### Overview of strategy and objectives

The Company is a non-trading intermediate holding company within RSGEL.

#### Change in group structure

During the year the UK Group underwent a group reorganisation. As part of this the Company acquired the entire share capital of Direct Group Property Services Limited from Direct Group Holdings Limited through a distribution in specie for £300,000 on 30 October 2015. On the same day the Company disposed of its' entire interest in Direct Group Property Services Limited through a distribution for £300,000 to Direct Newco Limited.

On 27 November 2015 the Company acquired the entire share capital of Direct Group Limited for £23,800,000. On the same day the Company sold its' entire interest in Millennium Insurance Brokers Limited to Direct Group Limited through a share for share exchange of £2,180,000, increasing its investment to £25,980,000.

On 27 November 2015 the Company sold its entire interest in Direct Group Limited for its book value of £25,980,000 to Direct Newco Limited.

#### Changes in share capital

On 30 October 2015 the Company capitalised a loans and inter-company balances of £42,236,000 with Direct Newco Limited, the Company's immediate parent company, by increasing its share capital by this amount. On 30 October the Company undertook a capital reduction to reduce its' share capital by £43,466,000 to £108.67.

On 27 November 2015 the Company issued share capital of £17,811,000 in settlement of inter-company balances with Direct Newco Limited, its immediate parent undertaking. On the same day the Company undertook a capital reduction to reduce its share capital by £17,811,000 to £153.19.

# Financial performance and key performance indicators

The Company had an operating profit of £nil (2014: £nil). The net interest payable and similar charges in the year was £1,679,000 (2014: £1,935,000), the Company received a dividend of £11,534,000 (2014: £nil) and wrote down its investment in its direct subsidiary undertaking, Direct Group Holdings Limited, by £34,201,000 (2014: £nil). With a tax charge of £nil (2014: £nil) the Company's loss for the financial year was £24,346,000 (2014: £1,935,000).

#### Dividends paid

The Company declared and paid a dividend of £300,000 on 30 October 2015 which was settled through the transfer of its newly acquired interest in Direct Group Property Services Limited.

On 27 November 2015 the Company declared and settled a dividend of £25,847,000 via its inter-company account.

#### **Business Review** (continued)

#### Going Concern

The directors have continued to closely monitor financial performance and cash flow throughout the period. The forecasts and analysis carried out to facilitate these together with current business opportunities have enabled the directors to confirm (using the principles contained within the Financial Reporting Council Paper entitled "Going Concern and Liquidity Risk") that the Company has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis in preparing the annual financial statements.

Further details regarding the adoption of the going concern basis can be found in note 1 to the financial statements.

## Credit and Liquidity risk

As regards to credit and liquidity, the Company's policy has throughout the period been to ensure continuity of funding by generating cash flow to finance the repayment obligations of its various loan facilities. It does not set any target maturity profile of its facilities but careful consideration to future requirements and profile are under constant review.

# Notes to the financial statements

for the year ended 31 December 2015

#### 1 Accounting policies

The following accounting policies have been applied consistently throughout the current and preceding year.

#### Basis of preparation

The financial statements have been prepared in accordance with applicable United Kingdom accounting standards, including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" ("FRS 102"), and with the Companies Act 2006. The financial statements have been prepared on the historical cost basis except for the modification to a fair value basis for certain financial instruments as specified in the accounting policies below

This is the first year in which the financial statements have been prepared under FRS 102. This resulted in no transitional changes being required.

The Company is exempt by virtue of s400 of the Companies Act 2006 from the requirement to prepare group financial statements as it and its subsidiary undertakings are included in the consolidated financial statements of Ryan Specialty Group Europe Limited, a company registered in England and Wales. These financial statements present information about the Company as an individual undertaking and not about its group.

As all of the Company's voting rights are controlled within the UK group headed by Ryan Specialty Group Europe Limited, the Company has taken advantage of the exemption contained in FRS 8 and has therefore not disclosed transactions or balances with entities which form part of the group (or investees of the group qualifying as related parties).

The consolidated financial statements of Ryan Specialty Group Europe Limited, within which this Company is included, can be obtained from Quay Point, Lakeside Boulevard, Doncaster, South Yorkshire, DN4 5PL.

#### Going concern

The Company's business activities, together with the factors likely to affect its future development, performance and position are set out in the strategic report. The strategic report also describes the liquidity position and borrowing facilities, its financial risk management objectives.

The financial statements have been prepared on a going concern basis, notwithstanding the net current liability position of the Company's balance sheet, which the directors believe to be appropriate for the reasons set out below.

The Company is dependent for its working capital on funds provided to it by its subsidiary undertakings and the Company's ultimate parent undertaking Ryan Specialty Group, LLC. Ryan Specialty Group LLC, has indicated that for the foreseeable future from the date of approval of these financial statements, it will continue to make available such funds as are needed by the Company and in particular will not seek repayment of the amounts currently made available. The directors consider that this should enable the Company to continue in operational existence for the foreseeable future by meeting its liabilities as they fall due for payment.

As with any Company placing reliance on other group entities for financial support, the directors acknowledge that there can be no certainty that this support will continue although, at the date of approval of these financial statements, they have no reason to believe that it will not do so.

#### Fixed asset investments

Investments in subsidiary undertakings are stated at cost less any provisions for impairment.

The carrying values of fixed asset investments are reviewed for impairment if events or changes in circumstances indicate the carrying value may not be recoverable. In considering this the investments are deemed to be impaired if there is an excess of the carrying value over the recoverable amount and are calculated based on the fair values of the business based on discounted cash flows. Impairment is recognised in the profit and loss account in the year in which it occurs.

#### 1 Accounting policies (continued)

#### Financial liabilities and equity

Financial instruments issued by the Company are treated as equity (i.e. forming part of shareholder's funds) only to the extent that they include no contractual obligations upon the Company to deliver cash or other financial assets or to exchange financial assets or liabilities with another party under conditions that are potentially unfavourable to the Company.

To the extent that this definition is not met, the proceeds of issue are classified as a financial liability. Where the instrument so classified takes the legal form of the Company's own shares, the amounts presented in these financial statements for called up share capital and share premium exclude amounts in relation to those shares.

Finance payments associated with financial liabilities are dealt with as part of interest payable and similar charges. Finance payments associated with financial instruments that are classified as part of shareholder's funds (see dividend policy) are dealt with as appropriations in the reconciliation of movements in shareholder's funds.

#### Interest receivable and payable

Interest receivable and payable is recognised in the profit and loss account on an accruals basis. If the collection of interest is considered doubtful, it is suspended and excluded from interest income in the profit and loss account.

#### **Taxation**

Current tax is provided at amounts expected to be paid (or recovered) using the tax rate and laws that have been enacted or substantively enacted by the balance sheet date.

#### Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed by the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. Timing differences are differences between the Company's taxable profits and its results as stated in the financial statements that arise from the inclusion of gains and losses in tax assessments in periods different from those in which they are recognised in the financial statements.

A deferred tax asset is considered recoverable and therefore recognised only to the extent that, on the basis of all available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax assets and liabilities are calculated without discounting, at the tax rate expected to be effective at the time the timing differences are expected to reverse.

#### Loan note interest

On 3 August 2007 the Company received a £37,749,000 loan from Direct Newco Limited. The interest on the loan was a fixed rate of 7%.

On 2 June 2008 Direct Newco Limited paid cash consideration of £1,267,000 for the purchase of Millennium Insurance Brokers Limited before the company was hived down to Direct Group Investment Limited on the same date. The interest on this loan was a fixed rate of 7%.

The capital amount on these loans was settled on 30 October 2015 through the issue of new share capital in the Company to Direct Newco Limited. The outstanding interest was subsequently settled on 27 November 2015 through the issue of new share capital in the Company Direct Newco Limited.

As a result the Company's loan note and associated interest obligations were £nil (2014: £50,535,000) to Direct Newco Limited as at 31 December 2015.

# 12 Commitments and guarantee

The Company's ultimate parent undertaking, Ryan Specialty Group, LLC, entered into a new group wide banking facility on 14 July 2014 which replaced the existing facility. This facility is provided by a syndicate of lenders (Bank of Montreal, JP Morgan Chase, SunTrust Bank, PNC Bank and National Association, Private Bank Trust Company and Barclays) with the borrowers being Ryan Specialty Group, LLC and the Company. As part of this facility the Company and certain of its subsidiary undertakings act as guarantors of the borrowers. The balance outstanding on this facility as at 31 December 2015 was £120,273,000 (2014: £90,119,000).

The Company is a subsidiary undertaking of Direct Newco Limited, incorporated in the United Kingdom and registered in England and Wales.
