Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 ("CA2006"), the directors of the Company propose that resolutions 1 and 2 below are passed as ordinary resolutions of the Company and that resolution 3 is passed as a special resolution.

ORDINARY RESOLUTIONS

- 1. THAT, following the increase in share capital by the creation of 1,132,300 'A' Preferred Shares of £1 circulated on 15 April 2009, the Company's share capital was increased to £8,610,060 and not £8,609,300.
- 2. THAT the directors be and they are generally and unconditionally authorised for the purposes of section 80 of the Companies Act 1985 as amended (the "Act") to exercise all the powers of the Company to allot relevant securities (within the meaning of that section) up to the authorised share capital of the Company provided that this authority is for a period expiring five years from the date of this resolution but the Company may before such expiry make an offer or agreement which would or might require relevant securities to be allotted after such expiry and the directors may allot relevant securities in pursuance of such offer or agreement notwithstanding that the authority conferred by this resolution has expired. This authority is in substitution for all subsisting authorities, to the extent unused.

SPECIAL RESOLUTION

3. THAT, shareholders of the Company waive any pre-emption rights that they may have (whether pursuant to the Articles of Association of the Company (as amended from time to time) or otherwise) in relation to the issue of upto 125,000 'A' Ordinary Shares of £0.0001 each in the Company to employees or other staff of the Company or its subsidiaries provided that the allotment of such shares, or the right to have such shares be allotted, has occurred or been granted prior to 31 December 2013.
