The undersigned, being the members of the Company who at the date of circulation of the resolution are entitled to vote on the resolution (being the "eligible members" for the purposes of Section 219 of the Companies Act 2006), RESOLVE AND AGREE that the following resolutions proposed by the directors of the Company be passed, in the case of resolutions 1 and 2, as written special resolutions of the Company and, in the case of resolution 3, as a written ordinary resolution of the Company in each case to take effect pursuant to Chapter 2 of Part 13 of the 2006 Act

SPECIAL RESOLUTIONS

- 1 THAT, the Articles of Association of the Company be amended by replacing the wording in article 2.1 with the following wording "The Company shall not have a maximum authorised share capital"
- THAT, subject to the passing of resolution 3, the Directors be generally empowered to allot 'A' Ordinary shares of £0 0001 each in the capital of the Company pursuant to the authority conferred by resolution 3, as if the pre-emption contained in Article 3 of the Company's Articles of Association or elsewhere did not apply to any such allotment, provided that this power shall be limited to the allotment of up to 60,000 'A' Ordinary shares of £0 0001 each in the capital of the Company

ORDINARY RESOLUTION

THAT, in accordance with section 551 of the 2006 Act, the directors of the Company be generally and unconditionally authorised to allot up to 60,000 'A' Ordinary shares of £0 0001 each in the capital of the Company or grant rights to subscribe for such shares in the capital of the Company ("Rights") provided that this authority shall, unless renewed, varied or revoked by the Company, expire on the date which is five years from the date on which the resolution is passed save that the Company may, before such expiry, make an offer or agreement which would or might require shares to be allotted or Rights to be granted and the directors of the Company may allot shares or grant Rights in pursuance of such offer or agreement notwithstanding that the authority conferred by this resolution has expired

This authority is in addition to all previous authorities conferred on the directors of the Company in accordance with section 80 of the Companies Act 1985 or section 551 of the 2006 Act
