Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover represents net invoiced sales of services, excluding value added tax.

Intangible fixed assets

The cost of intangible fixed assets is their purchase cost, together with any incidental costs of acquisition.

Intangible fixed assets are written off over their estimated useful life of 20 years.
