
DIRECTORS

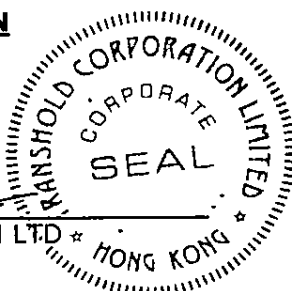
