THIS DEBENTURE is dated 9 September 2022, is made

BETWEEN

- (1) **CROWN UK HOLDCO LIMITED**, a company incorporated in England and Wales with registered number 11088548 (the "**Company**");
- (2) **THE COMPANIES** listed in Schedule 1 (*The DIP Chargors*) (each a "**DIP Chargor**" and together with the Company, the "**DIP Chargors**"); and
- (3) **BARCLAYS BANK PLC** as administrative and collateral agent for the Secured Parties (the "**DIP Agent**").

WHEREAS, on 28 February 2018, a credit agreement was concluded between, among others, Crown UK HoldCo Limited, Crown Finance US, Inc., certain lenders from time to time party thereto and Barclays Bank PLC, as, inter alia, administrative agent, whereby the lenders provided financing to Crown UK HoldCo Limited and Crown Finance US, Inc., as amended and amended and restated from time to time (the "2018 Credit Agreement").

WHEREAS, in order to secure the obligations of the borrowers under the 2018 Credit Agreement, the DIP Chargors executed a debenture dated 28 February 2018 in favour of the Barclays Bank PLC (the "2018 Debenture").

WHEREAS, Crown Finance US, Inc. (the "Borrower") and the DIP Chargors have filed in the United States Bankruptcy Court for the Southern District of Texas, Houston Division (the "Bankruptcy Court") a voluntary petition for relief under Chapter 11 of the Bankruptcy Code and have continued in the possession of their assets and in the management of their businesses pursuant to Sections 1107 and 1108 of the Bankruptcy Code, and such reorganisation cases are being jointly administered under Case Number 22-90168 (the "Cases").

WHEREAS, on 8 September 2022, the Bankruptcy Court entered an interim order (the "Interim DIP Order") in connection with the Borrower and the DIP Chargors inter alia, (a) authorising the Borrower to enter into a superpriority secured debtor-in-possession credit agreement, including the schedules thereto (the "DIP Credit Agreement") which was subsequently executed on 9 September 2022 with, among others, the Lenders (as defined therein), and Barclays Bank PLC as administrative agent; and (b) authorising the DIP Chargors (other than the Borrower) to jointly and severally guarantee the Borrower's obligations under the DIP Credit Agreement by entering into a Guarantee Agreement further concluded on 9 September 2022 (the "DIP Guarantee Agreement") and (c) affirming the priority of the DIP Liens (as defined therein), as contemplated by Section 8 (*DIP Lien Priority*) of the Interim DIP Order.

WHEREAS, the execution, delivery and performance of this Debenture and the grant of a Security Interest over the Charged Property and the proceeds thereof to secure the Obligations have been authorised pursuant to Sections 364(c)(2), 364(c)(3) and 364(d)(1) of the Bankruptcy Code by the Interim DIP Order and, after the entry thereof by the Bankruptcy Court, will have been so authorised by the Final Order and the Security granted to DIP Agent under this

Debenture and the exercise of the rights and remedies of DIP Agent hereunder and under any other Loan Document are subject to the DIP Orders.

IT IS AGREED as follows:

1 INTERPRETATION

1.1 Definitions

Unless the context otherwise requires or unless otherwise defined in this Debenture, words and expressions defined in the DIP Credit Agreement have the same meanings when used in this Debenture and:

"Account Bank" means the financial institution with whom an Account is opened or maintained;

"Account Notice" means a notice substantially in the form set out in Part 3 of Schedule 6 (*Forms of Notices*);

"Accounts" means all present and future accounts opened or maintained by the DIP Chargors, including but not limited to the accounts set out in Schedule 4 (*Bank Accounts*) of this Debenture (and any renewal or re-designation of such account(s)), in each case, together with the debt or debts represented thereby;

"Charged Agreements" means the Intra-Group Debt Documents, any letter of credit issued in favour of any DIP Chargor, and any other agreement designated as a Charged Agreement by the Company and the DIP Agent;

"Charged Property" means all the assets and undertakings of the DIP Chargors which from time to time are subject of the security created or expressed to be created in favour of the DIP Agent by or pursuant to this Debenture and any Security Accession Deed;

"CIGA" means the Corporate Insolvency and Governance Act 2020;

"Counterparty Notice" means a notice substantially in the form set out in Part 1 of Schedule 6 (Forms of Notices);

"COVID-19 Pandemic" has the meaning given to that term in the DIP Credit Agreement;

"Default Rate" means the rate at which interest is payable under Section 2.10(d) (*Default Interest*) of the DIP Credit Agreement;

"**DIP Chargor**" means each of the DIP Chargors and each company which grants security over its assets in favour of the DIP Agent by executing a Security Accession Deed;

"DIP Orders" means the Interim Order and the Final Order (as defined in the DIP Credit Agreement);

"Enforcement Event" means the occurrence of an Event of Default which is continuing;

"Equipment" means in relation to any DIP Chargor any plant, machinery, computers, office equipment or vehicles from time to time owned by that DIP Chargor;

"Event of Default" means an Event of Default as defined in the DIP Credit Agreement;

"Insurance Notice" means a notice substantially in the form set out in Part 2 of Schedule 6 (Forms of Notices);

"**Insurance Policies**" means all present and future policies of insurance (other than third party insurance, public liability insurance and directors' and officer's insurance) held by, or written in favour of, a DIP Chargor or in which it is otherwise interested, including but not limited to the policies of insurance, if any, specified in Schedule 5 (*Insurance Policies*);

"Intellectual Property" means all present and future patents, trademarks, service marks, designs, business names, copyrights, database rights, design rights, domain names, moral rights, inventions, confidential information, knowhow and other intellectual property rights and interests, whether registered or unregistered, and the benefit of all applications and rights to use such assets which may now or in the future subsist;

"Intra-Group Debt Documents" means any document or agreement providing for a loan or other type of financial accommodation by a DIP Chargor to another Group Member and/or any other document or agreement providing for the payment of any amount by any Group Member to a DIP Chargor;

"Investment" means all present and future stock, share, debenture, loan stock, securities, bonds, warrants, coupons, commercial paper, certificates of deposits, options, warrants, interest in any investment fund or investment scheme and any other comparable investment (including all warrants, options and any other rights to subscribe for, convert into or otherwise acquire these investments), including but not limited to the investments, if any, specified in Schedule 3 (*Shares*) (including, unless the context otherwise requires, the Shares), in each case whether owned directly by or to the order of a DIP Chargor or by any trustee, fiduciary, nominee or clearance system on its behalf (including all rights against any such trustee, fiduciary, nominee or clearance system);

"Mortgaged Real Property" has the meaning given to that term in the DIP Credit Agreement (but only to the extent that such Property is located within England and Wales) and shall include:

- (a) the proceeds of sale of all or any part of such property;
- (b) all rights, benefits, privileges, warranties, covenants, easements, appurtenances and licences relating to such property;
- (c) all money received by or payable to a DIP Chargor in respect of such property; and
- (d) all buildings, fixtures and fittings from time to time on such property;

"Occupational Lease" means any agreement for lease, licence or other right granted to any DIP Chargor to occupy or use any part of that DIP Chargor's Property;

"**Other Debts**" means all present and future book debts and other debts and monetary claims (other than Trading Receivables) owing to a DIP Chargor;

"Parties" means each of the parties to this Debenture from time to time;

"**Property**" means all present and future freehold and leasehold property from time to time owned by a DIP Chargor or in which a DIP Chargor is otherwise interested, including, but not limited to the property, if any, specified in Schedule 2 (*Properties*), and shall include:

- (a) the proceeds of sale of all or any part of such property;
- (b) all rights, benefits, privileges, warranties, covenants, easements, appurtenances and licences relating to such property;
- (c) all money received by or payable to a DIP Chargor in respect of such property; and
- (d) all buildings, fixtures and fittings from time to time on such property;

"**PSC Register**" means the "PSC register" within the meaning of section 790C(10) of the Companies Act 2006;

"Quasi-Security" means a transaction in which a DIP Chargor:

- (a) sells, transfers or otherwise disposes of any of its assets on terms whereby they are or may be leased to or re-acquired by a DIP Chargor or any other Group Member;
- (b) sells, transfers or otherwise disposes of any of its receivables on recourse terms;
- (c) enters into any arrangement under which money or the benefit of a bank or other account may be applied, set-off or made subject to a combination of accounts; or
- (d) enters into any other preferential arrangement having a similar effect,

in circumstances where the arrangement or transaction is entered into primarily as a method of raising Indebtedness (as defined in the DIP Credit Agreement) or of financing the acquisition of an asset;

"Receiver" means a receiver, receiver and manager or administrative receiver appointed under this Debenture;

"**Related Rights**" means all dividends, distributions and other income paid or payable on a Share or Investment, together with all shares or other property derived from any Share or Investment and all other allotments, accretions, rights, benefits and advantages of all kinds accruing, offered or otherwise derived from or incidental to that Share or Investment (whether by way of conversion, redemption, bonus, preference, option or otherwise);

"Secured Obligations" has the meaning given to the term "Obligations" in the DIP Credit Agreement;

"Security" means any Security Interest created, evidenced or conferred by or under this Debenture;

"Security Accession Deed" means a deed executed by a Group Member substantially in the form set out in Schedule 7 (*Form of Security Accession Deed*), with those amendments which the DIP Agent may reasonably approve or reasonably require;

"Security Interest" means a mortgage, charge, pledge or lien or other security interest securing any obligation of any person or any other agreement or arrangement having a similar effect;

"Security Period" means the period beginning on the date of this Debenture and ending on the date on which the Security is released in accordance with Clause 18.3 (*Covenant* to Release) or otherwise in accordance with the terms of any Loan Document;

"Shares" means all present and future shares owned by a DIP Chargor in any Loan Party or Subsidiary that is organized or incorporated under the laws of England and Wales, including but not limited to the shares, if any, specified in Schedule 3 (*Shares*); and

"**Trading Receivables**" means all present and future book and other debts arising in the ordinary course of trading owing to a DIP Chargor.

1.2 Construction

- (a) In this Debenture, unless a contrary intention appears, a reference to:
 - (i) an "**agreement**" includes any legally binding arrangement, concession, contract, deed or franchise (in each case whether oral or written);
 - (ii) an "**amendment**" includes any amendment, supplement, variation, novation, modification, replacement or restatement and "**amend**", "**amending**" and "**amended**" shall be construed accordingly;
 - (iii) "assets" includes present and future properties, revenues and rights of every description;
 - (iv) "including" means including without limitation and "includes" and "included" shall be construed accordingly;
 - (v) "losses" includes losses, actions, damages, claims, proceedings, costs, demands, expenses (including fees) and liabilities and "loss" shall be construed accordingly;
 - (vi) a "**person**" includes any person, firm, company, corporation, government, state or agency of a state or any association, trust or

partnership (whether or not having separate legal personality) or any two or more of the foregoing;

- (vii) a "**regulation**" includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any governmental, intergovernmental or supranational body, agency, department or regulatory, self-regulatory or other authority or organisation; and
- (viii) a reference to any charge being made with "full title guarantee" shall mean that such charge is granted with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994 except for any Security Interests permitted under the Loan Documents.
- (b) An Event of Default is "**continuing**" if it has not been remedied or waived.
- (c) In the event of any conflict between the terms of this Debenture and the DIP Credit Agreement, then (to the fullest extent permitted by law) the terms of the DIP Credit Agreement shall take priority over the terms of this Debenture.

1.3 Other References

- (a) In this Debenture, unless a contrary intention appears, a reference to:
 - (i) any Secured Party, DIP Chargor or any other person is, where relevant, deemed to be a reference to or to include, as appropriate, that person's successors in title, permitted assignees and transferees and in the case of the DIP Agent, any person for the time being appointed as DIP Agent or DIP Agents in accordance with the Loan Documents;
 - (ii) any Loan Document or other agreement or instrument is to be construed as a reference to that agreement or instrument as amended (howsoever fundamentally and whether or not such amendment results in new and/or more onerous obligations and liabilities), including by way of a change in the purpose of the facilities, or by way of a refinancing, deferral or extension of the facilities or by way of an addition or increase of or other changes to the facilities or other obligations or liabilities under the agreements or accession or retirement of the parties to the agreements;
 - (iii) any clause or schedule is a reference to, respectively, a clause of and schedule to this Debenture and any reference to this Debenture includes its schedules; and
 - (iv) a provision of law is a reference to that provision as amended or reenacted.
- (b) The index to and the headings in this Debenture are inserted for convenience only and are to be ignored in construing this Debenture.
- (c) Words importing the plural shall include the singular and vice versa.

1.4 Miscellaneous

- (a) The terms of the documents under which the Secured Obligations arise and of any side letters between any DIP Chargor and any Secured Party relating to the Secured Obligations are incorporated in this Debenture to the extent required for any purported disposition of the Charged Property contained in this Debenture to be a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- (b) Notwithstanding any other provision of this Debenture, the obtaining of a moratorium under section 1A of the Insolvency Act 1986, or anything done with a view to obtaining such a moratorium (including any preliminary decision or investigation), shall not be an event causing any floating charge created by this Debenture to crystallise or causing restrictions which would not otherwise apply to be imposed on the disposal of property by any DIP Chargor or a ground for the appointment of a Receiver.
- (c) Unless expressly provided to the contrary in a Loan Document, the Contracts (Rights of Third Parties) Act 1999 shall not apply to this Debenture and no rights or benefits expressly or impliedly conferred by this Debenture shall be enforceable under that Act against the Parties by any other person.
- (d) The Parties intend that this document shall take effect as a deed notwithstanding that any party may only execute this document under hand.

1.5 DIP Orders

- (a) The DIP Agent shall hold the benefit of this Debenture and the 2018 Debenture in accordance with the DIP Intercreditor Arrangements and all receipts, recoveries and realisations pursuant to the enforcement of this Debenture and the 2018 Debenture, shall be applied towards discharge of the "Obligations" as defined in the DIP Credit Agreement and the "Obligations" as defined in the 2018 Credit Agreement respectively in accordance with the DIP Intercreditor Arrangements. This Debenture and the 2018 Debenture are subject to and shall be read in accordance with the terms of the DIP Intercreditor Arrangements.
- (b) The Parties hereby agree that:
 - (i) notwithstanding any other provision contained herein, this Debenture, the Security created hereby and the rights, remedies, duties and obligations provided for herein, upon the execution thereof, shall be subject in all respects to the provisions of the DIP Credit Agreement and the DIP Orders. In the event of any conflict or inconsistency between the provisions of this Debenture, the DIP Credit Agreement and the DIP orders, the provisions of the DIP Credit Agreement or the DIP Orders (as applicable) shall apply; provided, however, the Parties understand and agree that this Debenture sets forth additional undertakings, obligations and rights, and the Parties will use all reasonable efforts to construe the provisions and covenants in this Debenture as not being in direct conflict with the DIP Credit Agreement and the DIP Orders; and

- (ii) notwithstanding anything herein to the contrary, the Security granted to the DIP Agent pursuant to this Debenture and the exercise of any right or remedy by the DIP Agent hereunder are subject to the terms of the DIP Credit Agreement and the DIP Orders. In the event the DIP Agent decides, or is required, to take any action hereunder, it shall take such action only in accordance with the terms and provisions of the DIP Credit Agreement and the DIP Orders.
- (b) Provided that a DIP Chargor is in compliance with the terms of the 2018 Debenture, the DIP Credit Agreement and the DIP Orders (including without limitation, any obligation to deliver or deposit any deeds, documents of title, certificates, evidence of ownership or related documentation, to give any notice or to carry out any registration or filing (other than the registration of this Debenture at Companies House pursuant to section 859 of the Companies Act 2006 or any applications to the Land Registrar for a restriction to be entered on the Register of Title in relation to any Mortgaged Real Property pursuant to Clause 7.4 (*The Land Registry*)) then to the extent that the terms of this Debenture impose the same or substantially the same obligation in respect of the same assets, the DIP Chargor will be deemed to have complied with the relevant obligations herein by virtue of its compliance under the 2018 Debenture, the DIP Credit Agreement and the DIP Orders.

2 COVENANT TO PAY

Each DIP Chargor as primary obligor covenants with the DIP Agent (for the benefit of itself and the other Secured Parties) that it will pay or discharge the Secured Obligations in the manner provided for in the Loan Documents.

3 CHARGING PROVISIONS

3.1 General

- (a) All the Security:
 - (i) is created in favour of the DIP Agent;
 - (ii) is security for the payment, discharge and performance of all the Secured Obligations; and
 - (iii) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994 except for any Security Interests permitted under the Loan Documents.
- (b) The DIP Agent holds the benefit of this Debenture on trust for the Secured Parties.
- (c) The fact that no or incomplete details of any Charged Property are inserted in any of Schedule 2 (*Properties*), Schedule 3 (*Shares*), Schedule 4 (*Bank Accounts*) and/or Schedule 5 (*Insurance Policies*) to this Debenture does not affect the validity or enforceability of the Security.

3.2 Specific Security

Each DIP Chargor, as continuing security for the payment of the Secured Obligations, charges in favour of the DIP Agent with full title guarantee the following assets, both present and future, from time to time owned by it or in which it has an interest:

- (a) by way of first legal mortgage all Mortgaged Real Property now belonging to or vested in it; and
- (b) by way of first fixed charge:
 - (i) all other interests (not effectively charged under Clause 3.2(a) and/or Clause 3.2(b) (as applicable)) in any Property and the benefit of all other agreements relating to land;
 - (ii) all of its rights, title and interest in the Intellectual Property;
 - (iii) all of its rights, title and interest in the Equipment;
 - (iv) all the Investments, Shares and all corresponding Related Rights;
 - (v) all Trading Receivables and all rights and claims against third parties and against any security in respect of those Trading Receivables;
 - (vi) all Other Debts and all rights and claims against third parties against any security in respect of those Other Debts;
 - (vii) all monies from time to time standing to the credit of the Accounts (including any interest and other sums accruing thereon), together with all of its rights, title and interest in, and benefits and proceeds deriving from or arising in connection with, the Accounts (subject, in each case, to any security interests in favour of the relevant Account Bank where such security interests arise by operation of law or by operation of the terms and conditions of such Account Bank as applicable to the relevant Account);
 - (viii) all of its rights, title and interest in the Hedging Contracts;
 - (ix) all of its goodwill and uncalled capital;
 - (x) any beneficial interest, claim or entitlement it has to any assets of any pension fund;
 - (xi) the benefit of any authorisation (statutory or otherwise) held in connection with its business or the use of any Charged Property;
 - (xii) the right to recover and receive compensation which may be payable to it in respect of any authorisation referred to in paragraph (xi) above; and
 - (xiii) all its rights, title and interest in (and proceeds and claims under) the Insurance Policies and the Charged Agreements (subject, in each case, to such Security being permissible under the terms of such Insurance

Policy or Charged Agreement, as applicable), and includes, in respect of each of the above charged assets (as appropriate), the benefit of all licences, consents and agreements held by the DIP Chargor in connection with the use of the asset, any monies or income paid or payable in respect of the asset, any proceeds of the sale of the asset and any other property, rights or claims relating to, accruing to or deriving from the asset.

3.3 Floating Charge

- (a) As further continuing security for the payment of the Secured Obligations, each DIP Chargor charges with full title guarantee in favour of the DIP Agent by way of first floating charge all its present and future assets, undertakings and rights.
- (b) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 shall apply to the floating charge created by this Debenture.

3.4 Conversion of Floating Charge

- (a) Except as provided below, the DIP Agent may, by notice to any DIP Chargor, convert the floating charge created under this Debenture into a fixed charge with immediate effect as regards those assets specified in the notice:
 - (i) an Enforcement Event has occurred;
 - (ii) if the DIP Agent reasonably considers that any asset charged under the floating charge created under this Debenture is in danger of being seized or sold under any form of distress, attachment, execution or other legal process or is otherwise in jeopardy; or
 - (iii) if any DIP Chargor fails to comply, or takes or threatens to take any action which, in the reasonable opinion of the DIP Agent, is likely to result in it failing to comply with its obligations under paragraph (a) of Clause 5 (*Negative Pledge*).
- (b) The floating charge created under this Debenture will automatically (without notice, and in addition to the circumstances in which the same will occur by operation of law) and immediately be converted into a fixed charge over all the assets of a DIP Chargor which are subject to the floating charge created under this Debenture, if:
 - (i) the members of that DIP Chargor convene a meeting for the purposes of considering any resolution for its winding-up, dissolution, or a compromise, assignment or arrangement with any creditor; or
 - (ii) any person (entitled to do so) gives notice of its intention to appoint an administrator to any DIP Chargor or files such a notice with the court.
- (c) Upon the conversion of any floating charge pursuant to this Clause 3.4, each relevant DIP Chargor shall, at its own expense, immediately upon request by the DIP Agent execute a fixed charge or legal assignment in such form as the DIP Agent may require.

3.5 Appointment of an Administrator

- (a) The DIP Agent may, without notice to the relevant DIP Chargor, appoint any one or more persons to be an Administrator of that DIP Chargor pursuant to Paragraph 14 of Schedule B1 of the Insolvency Act 1986 if the security constituted by this Debenture becomes enforceable.
- (b) Any appointment under this clause 3.5 shall:
 - (i) be in writing signed by a duly authorised signatory of the DIP Agent; and
 - (ii) take effect in accordance with paragraph 19 of Schedule B1 of the Insolvency Act 1986.

3.6 **Property Restricting Charging**

- (a) There shall be excluded from the charge created by Clause 3.2 (*Specific Security*) and from the operation of Clause 4 (*Further Assurance*):
 - (i) any leasehold property held by a DIP Chargor under a lease which prohibits either absolutely or conditionally (including requiring the consent of any third party) that DIP Chargor from creating any charge over its leasehold interest; and
 - (ii) any Intellectual Property in which a DIP Chargor has an interest under any licence or other agreement which prohibits either absolutely or conditionally (including requiring the consent of any third party) that DIP Chargor from creating any charge over its interest in that Intellectual Property,

in each case until the relevant condition or waiver has been satisfied or obtained.

- (b) For all leasehold property or Intellectual Property referred to in Clause 3.5(a), each relevant DIP Chargor undertakes to use all reasonable endeavours to obtain the relevant consent or waiver of prohibition or condition as soon as practicable and promptly to supply to the DIP Agent a copy of any such consent or waiver of prohibition or condition obtained by it.
- (c) For all leasehold property or Intellectual Property referred to in Clause 3.5(a), each relevant DIP Chargor undertakes to secure all damages, compensation, remuneration, profit, rent or income which the DIP Chargor may receive, or has received, under any relevant lease document or Intellectual Property document but shall not be required to provide security over the document itself until such consent is obtained.
- (d) Immediately upon receipt of the relevant waiver or consent, the formerly excluded leasehold property or Intellectual Property shall stand charged to the DIP Agent under Clause 3.2 (*Specific Security*). If required by the DIP Agent, at any time following receipt of that waiver or consent, the relevant DIP Chargor will forthwith execute a valid fixed charge or legal assignment in such form as the DIP Agent shall reasonably require.

4 FURTHER ASSURANCE

- (a) The covenants set out in Section 2(1)(b) of the Law of Property (Miscellaneous Provisions) Act 1994 shall extend to include the obligations set out in sub-clause 4 (b) and (c) below.
- (b) Each DIP Chargor shall promptly (and at its own expense) do all such acts (including payment of all stamp duties or fees) or execute or re-execute all such documents (including assignments, transfers, mortgages, charges, notices and instructions) as the DIP Agent may reasonably specify (and in such form as the DIP Agent may reasonably require):
 - (i) to perfect the Security created or intended to be created under or evidenced by this Debenture (which may include the execution or reexecution of a mortgage, charge, assignment or other Security over all or any of the assets which are, or are intended to be, the subject of this Debenture) or for the exercise of any rights, discretion, powers and remedies of the DIP Agent, any Receiver or the other Secured Parties provided by or pursuant to this Debenture or by law;
 - to confer on the DIP Agent, or on the Secured Parties, Security over any property and assets of that DIP Chargor located in any jurisdiction equivalent or similar to the Security intended to be conferred by or pursuant to this Debenture; and/or
 - (iii) to facilitate the realisation of the assets which are, or are intended to be, the subject of the Security created under this Debenture.
- (c) Each DIP Chargor shall take all such action as is available to it (including making all filings and registrations) as may be necessary for the purpose of the creation, perfection, protection or maintenance of any Security conferred or intended to be conferred on the DIP Agent or the Secured Parties by or pursuant to this Debenture.

5 NEGATIVE PLEDGE

No DIP Chargor may:

- (a) create or agree to create or permit to subsist any Security or Quasi-Security over all or any part of the Charged Property other than the Security Interest created by the 2018 Debenture or the DIP Orders; or
- (b) sell, transfer, lease out, lend or otherwise dispose of all or any part of the Charged Property (other than in respect of assets charged under Clause 3.3 (*Floating Charge*) on arm's length terms in the ordinary course of trading) or the right to receive or to be paid the proceeds arising on the disposal of the same, or agree or attempt to do so,

except as permitted by the Loan Documents or with the prior consent of the DIP Agent.

6 **REPRESENTATIONS AND WARRANTIES**

6.1 General

Each DIP Chargor represents and warrants to the DIP Agent as set out in this Clause 6 on the date of this Debenture (or, with respect to any DIP Chargor which becomes a party to this Debenture by way of a Security Accession Deed, on the date when it becomes a DIP Chargor) and on each date on which representations are required by Article IV (*Representations and Warranties*) of the DIP Credit Agreement.

6.2 Shares

It is the legal and beneficial owner of the Shares identified against its name in Schedule 3 (*Shares*) which, unless otherwise disclosed to the DIP Agent (including in Schedule 3), represent the entire issued share capital of the relevant Subsidiaries and all of those Shares are duly authorised, validly issued and fully paid, and not subject to any option to purchase or similar right.

6.3 Bank Accounts

It is the legal and beneficial owner of the Accounts. It has full power to establish and maintain the Accounts and to enter into and deliver and to create the Security constituted by this Debenture.

6.4 **PSC Register**

- (a) It has not issued, and does not, intend to issue any warning notice or restrictions notice under Schedule 1B of the Companies Act 2006 in respect of any shares which constitute Charged Property.
- (b) It has not received any warning notice or restrictions notice under Schedule 1B of the Companies Act 2006 in respect of any shares which constitute Charged Property.

7 **PROTECTION OF SECURITY**

7.1 Title Documents and Other Information

- (a) Each DIP Chargor will promptly:
 - (i) in respect of all Mortgaged Real Property (to the extent not already held by the DIP Agent pursuant to the 2018 Debenture):
 - (A) deposit with the DIP Agent (or as it shall direct) all deeds and documents of title relating to all Mortgaged Real Property and, if those deeds and documents are with the Land Registry, will promptly deposit them with the DIP Agent (or as it shall direct) upon their release; or
 - (B) procure that all deeds and documents of title relating to all Mortgaged Real Property are held to the order of the DIP Agent

by a firm of solicitors approved by the DIP Agent for that purpose; and

- (ii) subject to Clause 9.3 (*Share Certificates*), deposit with, or provide to, the DIP Agent (or as it shall direct):
 - (A) to the extent not already held by the DIP Agent pursuant to the 2018 Debenture, all stock and share certificates and other documents of title relating to the Shares and Investments together with stock transfer forms executed in blank and left undated on the basis that the DIP Agent shall be able to hold such documents of title and stock transfer forms until the Secured Obligations have been irrevocably and unconditionally discharged in full and shall be entitled, at any time following the occurrence of an Enforcement Event, to complete, under its power of attorney given in this Debenture, the stock transfer forms on behalf of the relevant DIP Chargor in favour of itself or such other person as it shall select;
 - (B) details of all Accounts (including Account Bank name, address and sort code and Account number);
 - (C) details of all Insurance Policies (including the insured, the insurer, policy number and type of risk insured);
 - (D) following the occurrence of an Enforcement Event, copies of all Insurance Policies, Charged Agreements and Hedging Contracts; and
 - (E) following the occurrence of an Enforcement Event, all other documents relating to the Charged Property which the DIP Agent may from time to time reasonably require.
- (b) The DIP Agent may retain any document delivered to it under this Clause 7.1 or otherwise until the security created under this Debenture is released and, if for any reason it ceases to hold any such document before that time, it may by notice to the relevant DIP Chargor require that the document be redelivered to it and the relevant DIP Chargor shall promptly comply (or procure compliance) with that notice.
- (c) Any document required to be delivered to the DIP Agent under Clause 7.1(a) which is for any reason not so delivered or which is released by the DIP Agent to a DIP Chargor shall be held on trust by the relevant DIP Chargor for the DIP Agent.

7.2 Receivables and Other Debts

- (a) Before the occurrence of an Enforcement Event, each DIP Chargor shall be free to deal with, amend, waive or terminate any Trading Receivable or Other Debt in the ordinary course of business.
- (b) Each DIP Chargor shall:

- (i) pay all monies received in respect of any Trading Receivables and Other Debts into an Account pending application;
- (ii) upon the occurrence of an Enforcement Event, as agent for the DIP Agent, collect all Trading Receivables and Other Debts charged to the DIP Agent under this Debenture, pay the proceeds into an Account promptly upon receipt and, pending such payment, hold those proceeds on trust for the DIP Agent; and
- (iii) subject to Clause 7.2(a) (*Receivables and Other Debts*) not charge, factor, discount or assign any of the Trading Receivables or Other Debts in favour of any person, or purport to do so unless permitted by the Loan Documents or with the prior consent of the DIP Agent.
- (c) Subject to Clause 8, before the occurrence of an Enforcement Event, no DIP Chargor shall be required to prepare or serve a notice in respect of any Security over Trading Receivables or Other Debts or any rights and claims against third parties and against any security in respect of those Trading Receivables or Other Debts other than any such notice required to be delivered to a Group Member. Subject to the terms of the DIP Credit Agreement, promptly following the occurrence of an Enforcement Event, each DIP Chargor shall give notice to the other party to each Trading Receivable or Other Debt (to the extent such notice has not already been given) in the form of a Counterparty Notice. Each DIP Chargor shall use all commercially reasonable endeavours to procure that the relevant counterparty signs and delivers to the DIP Agent an acknowledgement substantially in the form of that set out in the schedule to the relevant notice within 20 Business Days of the notice being given (it being acknowledged that, provided such DIP Chargor has used all commercially reasonable endeavours to obtain such acknowledgement, the obligation described in this sentence shall cease at the expiry of the 20 Business Day period).

7.3 Insurance Policies, Charged Agreements and Hedging Contracts

- (a) Each DIP Chargor will:
 - (i) subject to the terms of the DIP Credit Agreement, promptly following the occurrence of an Enforcement Event, give notice to the other party to each Insurance Policy, each Charged Agreement and each Hedging Contract that it has assigned or charged its right under the relevant policy or agreement to the DIP Agent under this Debenture. Such notice will be a Counterparty Notice, except in the case of the Insurance Policies where it will be an Insurance Notice. Each relevant DIP Chargor will use all commercially reasonable endeavours to procure that the relevant counterparty or insurer signs and delivers to the DIP Agent an acknowledgement substantially in the form of that set out in the schedule to the relevant notice within 20 Business Days of the notice being given (it being acknowledged that, provided such DIP Chargor has used all commercially reasonable endeavours to obtain such acknowledgement, the obligation described in this sentence shall cease at the expiry of the 20 Business Day period);

- (ii) perform all its obligations under the Insurance Policies or Charged Agreements in a diligent and timely manner;
- (iii) not amend any provision of any Hedging Contract, Insurance Policies or Charged Agreements except:
 - (A) in the case of any Hedging Contract or Charged Agreement (other than an Intra-Group Debt Document), where the relevant hedge counterparty, the parties thereto, are permitted in accordance with the provisions of the DIP Credit Agreement; and
 - (B) (subject to compliance with any applicable terms of the DIP Credit Agreement) for any amendment to any Intra-Group Debt Documents.
- (b) Before the occurrence of an Enforcement Event, no co-insurance or loss payee or other endorsement shall be required in respect of any Insurance Policy (and following the occurrence of an Enforcement Event, shall be required only upon request by the DIP Agent).

7.4 The Land Registry

(a) Each DIP Chargor shall apply to the Land Registrar for a restriction to be entered on the Register of Title in relation to any Mortgaged Real Property (including any Mortgaged Real Property consisting of unregistered properties subject to compulsory first registration at the date of this Debenture) on the prescribed Land Registry form and in the following or substantially similar terms:

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a consent signed by the proprietor for the time being of the charge dated $[\bullet]$ in favour of $[\bullet]$ referred to in the charges register or their conveyancer".

- (b) Subject to the terms of the DIP Credit Agreement, if the DIP Lenders are under an obligation to make further advances to the DIP Chargors (which obligation is deemed to be incorporated into this Debenture) and this security has been made for securing those further advances. Each DIP Chargor shall apply to the Land Registrar on the prescribed Land Registry form for a notice to be entered on the Register of Title in relation to any Mortgaged Real Property (including any unregistered properties subject to compulsory first registration at the date of this Debenture) that there is an obligation to make further advances on the security of the registered charge.
- (c) If any DIP Chargor fails to make the applications set out in Clauses 7.4(a) or (b) or if the DIP Agent gives notice to any DIP Chargor that it will make such applications on its behalf, each DIP Chargor irrevocably consents to the DIP Agent making such application on its behalf and shall promptly provide the DIP Agent with all information and fees which the DIP Agent may request in connection with such application.

7.5 Intellectual Property

- (a) Before the occurrence of an Enforcement Event, each DIP Chargor shall be free to deal with, use, licence and otherwise commercialise its Intellectual Property in the ordinary course of business (including allowing such Intellectual Property to lapse, provided such Intellectual Property is not material to business) to the extent permitted under the Loan Documents.
- (b) Subject to the terms of the DIP Credit Agreement, notice of Security over Intellectual Property may be served by the DIP Agent on a third party from whom such Intellectual Property is licensed after the occurrence of an Enforcement Event. No DIP Chargor shall be required to, or be required to procure any Group Member or other person to, make or cause to be made any changes to, new entries on, or corrections of filings on, external intellectual property registers (including the United Kingdom Register of Trade Marks).

7.6 Accounts

- (a) Before the occurrence of an Enforcement Event, each DIP Chargor shall be free to deal, operate and transact business in relation to all monies from time to time standing to the credit of the Accounts (including any interest and other sums accruing thereon), all of its rights, title and interest in, and benefits and proceeds deriving from or arising in connection with, the Accounts (including opening and closing Accounts) unless the Loan Document expressly provide for any Account to be subject to specific restrictions on use.
- (b) Subject to the terms of the DIP Credit Agreement and where an Account is not maintained with the DIP Agent, promptly following the occurrence of an Enforcement Event, each DIP Chargor shall serve an Account Notice on the relevant Account Bank and such DIP Chargor shall use all commercially reasonable endeavours to procure that the relevant Account Bank signs and delivers to the DIP Agent an acknowledgement substantially in the form of that set out in the schedule to the relevant notice within 20 Business Days of the notice being given (it being acknowledged that, provided such DIP Chargor has used all commercially reasonable endeavours to obtain such acknowledgement, the obligation described in this sentence shall cease at the expiry of the 20 Business Day period).

8 NOTICE OF CHARGE

By its execution of this Debenture:

(a) each DIP Chargor (the "**First DIP Chargor**") shall be deemed to have given notice to each other DIP Chargor which from time to time owes the First DIP Chargor any Trading Receivables or Other Debts (including, without limitation, pursuant to any Intra-Group Debt Document) that such First DIP Chargor has charged all of its rights, title and interest, both present and future, from time to time in such Trading Receivables or Other Debts (including, without limitation, pursuant to any Intra-Group Debt Document) in favour of the DIP Agent under this Debenture; and (b) each DIP Chargor shall be deemed to have acknowledged the notice deemed given under paragraph (a) above.

9 UNDERTAKINGS

9.1 General

- (a) Each DIP Chargor undertakes to the DIP Agent in the terms of this Clause 9 from the date of this Debenture and for so long as any of the Secured Obligations are outstanding.
- (b) Each DIP Chargor will observe and perform all covenants and stipulations from time to time affecting the Charged Property, make all payments, carry out all registrations or renewals and generally take all steps which are necessary to preserve, maintain and renew when necessary or desirable all of the Charged Property.

9.2 Real Property

Repair

(a) Each DIP Chargor will keep all Property and Equipment which forms part of the Charged Property in such repair and working order as is consistent with use of such Property and Equipment in the ordinary course of business conducted therein.

Compliance

- (b) Each DIP Chargor must pay all taxes, rates, duties, charges, assessments and outgoings whatsoever due and payable by it in relation to the Property within a reasonable time of the relevant due date, unless:
 - (i) (and only to the extent) that they are being contested in good faith and by appropriate means; or
 - (ii) they have been waived or deferred pursuant to any legislative instrument (as may be amended, supplemented or replaced from time to time), including (without limitation) CIGA, introduced in order to provide relief in connection with the COVID-19 Pandemic in the United Kingdom.
- (c) Each DIP Chargor must only use the Property for such purpose or purposes as may for the time being be authorised as the permitted use or user thereof under or by virtue of any applicable laws relating to planning permission and all title deeds relating to the Property.
- (d) Each DIP Chargor must duly and punctually perform and observe all its obligations in connection with the Property under any present or future statute or any regulation, order or notice made or given thereunder, non-performance or non-observance of which would have a Material Adverse Effect.

(e) Each DIP Chargor must duly and punctually perform and observe all covenants and stipulations, restrictive or otherwise, affecting all or any part of the Property and all or any facilities necessary for the enjoyment and use of the Property and/or the carrying on of the business at the Property, including, without limitation, access to and egress from the Property, if in any such case failure to do so would materially and adversely affect the value, saleability or use of the Property, and indemnify the DIP Agent in respect of any breach thereof and permit access to such Property in accordance with Section 7.6 (*Access*) of the DIP Credit Agreement.

Leases

- (f) Except as permitted by the Loan Documents, no DIP Chargor will grant any lease, tenancy, contractual licence or right to occupy in respect of the whole or any part of the Property or otherwise part with possession of the whole or any part of the Property.
- (g) Each DIP Chargor must perform and observe all the covenants, agreements and stipulations on the part of such DIP Chargor contained in any Occupational Lease and must not do or suffer to be done any act or thing whereby any Occupational Lease may become liable to forfeiture or otherwise be determined prior to the expiration of its term, in each case where such failure to observe or such forfeiture or determination would have or would reasonably be likely to have a Material Adverse Effect.

Notices

- (h) Each DIP Chargor will give notice within fourteen days after receipt of any application, requirement, order or notice served or given by any public or local or any other authority with respect to its Property (or any part of it) which would have a material adverse effect on the value, saleability or use of any of the Property.
- (i) Each DIP Chargor will give prompt notice to the DIP Agent if it receives any notice under section 146 of the Law of Property Act 1925 or any proceedings are commenced against it for the forfeiture of any lease comprised in any Property.

Investigation of Title

- (j) Each DIP Chargor must grant the DIP Agent or its lawyers on request all facilities within the power of that DIP Chargor to enable the DIP Agent or its lawyers (at the expense of that DIP Chargor) after the occurrence of an Enforcement Event:
 - (i) carry out investigations of title to its Property; and
 - (ii) make such enquiries in relation to any part of its Property as a prudent mortgagee might carry out.

Register of Overseas Entities Regime

(k) Each Chargor incorporated in a jurisdiction other than the United Kingdom shall comply with any applicable requirements of the Economic Crime (Transparency and Enforcement) Act 2022 within the timeframes specified in that Act.

Exceptions

- No DIP Chargor shall be in breach of Clause 9.1(b) (*General*) or this Clause 9.2 (*Real Property*) where such DIP Chargor's non-performance or non-compliance with any covenants, agreements and stipulations contained in the relevant Occupational Lease or otherwise relating to the Charged Property are solely relating to:
 - (i) non-payment of rent falling due during the applicable "relevant period" under CIGA (as such period may be extended, supplemented or replaced from time to time) or equivalent period of protection under any replacement or analogous legislation or instrument providing relief in connection with the COVID-19 Pandemic in the United Kingdom; or
 - (ii) any other non-payment of rent directly related to business disruption caused by the COVID-19 Pandemic, or for the avoidance of doubt, in circumstances in which the lessor in respect of such Occupational Lease has agreed to a deferral, amendment or waiver in relation to the relevant covenants, agreements and stipulations; or
 - (iii) the DIP Chargor being prevented from keeping any Property open for business and/or maintaining active trade due to any Act of Parliament, statutory instrument, statutory power or decree passed, issued or exercised by or on behalf of the United Kingdom government in relation to an epidemic, public health emergency or communicable disease outbreak (whether national or international and including the COVID-19 Pandemic), including compliance by the DIP Chargor and/or its staff with advice and/or guidance and/or directives from the United Kingdom Government, the National Health Service or other health or regulatory bodies in relation to such epidemic, emergency or disease.

9.3 Share Certificates

Each relevant DIP Chargor:

- (a) will on, or as soon as reasonably practicable following execution of this Debenture (or if it acquires the relevant Shares later, as soon as reasonably practicable after it does so) deposit with the DIP Agent (to the extent not already held by the DIP Agent), or as the DIP Agent may direct, any bearer instrument (provided that the DIP Agent shall not dispose of, sell or otherwise deal with any such bearer instrument until an Enforcement Event has occurred), certificate or other document of title or evidence of ownership in relation to the Shares; and
- (b) must on, or as soon as reasonably practicable following execution of this Debenture (or if it acquires the relevant Shares later, as soon as reasonably

practicable after it does so) take any action and execute and deliver to the DIP Agent any undated share transfer or other document which may be requested by the DIP Agent in order to enable the transferee to be registered as the owner or otherwise obtain legal title to the Shares upon the occurrence of an Enforcement Event, including:

- (i) delivering executed undated share transfers in favour of the DIP Agent or any of its nominees as transferee or, if the DIP Agent so directs, with the transferee left blank; and
- (ii) procuring that those share transfers are registered by the relevant Subsidiary of such DIP Chargor and that share certificates in the name of the transferee are delivered to the DIP Agent.

9.4 Changes to rights

A DIP Chargor may not (except to the extent not prohibited by the Loan Documents) take or allow the taking of any action on its behalf which may result in the rights attaching to the Shares being materially and adversely altered or in any circumstance take any such action that may adversely affect the enforcement of the Security.

9.5 Calls

- (a) Each relevant DIP Chargor must pay all calls and other payments due and payable in respect of the Shares during the Security Period.
- (b) If such DIP Chargor fails to do so, the DIP Agent may pay those calls or other payments on behalf of such DIP Chargor. Such DIP Chargor must promptly on request reimburse the DIP Agent for any payment made by the DIP Agent under this subclause and, pending reimbursement, that payment will constitute part of the Secured Liabilities.

9.6 Other obligations in respect of Shares

- (a)
- (i) Each relevant DIP Chargor must comply with all requests for information regarding the Shares which is within its knowledge and which it is required to comply with by law or under the constitutional documents relating to the Shares. If such DIP Chargor fails to do so, the DIP Agent may elect to provide any information which it may have on behalf of such DIP Chargor.
- (ii) Each relevant DIP Chargor must, if the DIP Agent reasonably so requests, promptly supply a copy to the DIP Agent of any information referred to in subparagraph (i) above.
- (b) Each relevant DIP Chargor must comply with all other conditions and obligations assumed by it in respect of any of the Shares.
- (c) No Secured Party will be required in any manner to:

- (i) perform or fulfil any obligation of a DIP Chargor;
- (ii) make any payment;
- (iii) make any enquiry as to the nature or sufficiency of any payment received by it or a DIP Chargor; or
- (iv) present or file any claim or take any other action to collect or enforce the payment of any amount,

in respect of the Shares.

9.7 Voting and distribution rights

- (a) Before the occurrence of an Enforcement Event, each relevant DIP Chargor may continue to exercise the voting rights, powers and other rights in respect of the Shares provided that any exercise of rights does not materially adversely affect the validity or enforceability of the Security over the shares or cause an Event of Default to occur.
- (b) Before the occurrence of an Enforcement Event, if for any reason the relevant Shares have been registered in the name of the DIP Agent or its nominee, the DIP Agent (or its nominee) must exercise the voting rights, powers and other rights in respect of the Shares in any manner which the relevant DIP Chargor may direct in writing. The DIP Agent (or that nominee) will execute any form of proxy or other document which the relevant DIP Chargor may reasonably require for this purpose.
- (c) Before the occurrence of an Enforcement Event, all dividends or other income or distributions paid or payable in relation to any of the Shares (whether in cash or otherwise) must be paid to the relevant DIP Chargor. To achieve this, if for any reason the relevant Shares have been registered in the name of the DIP Agent (or its nominee):
 - (i) the DIP Agent (or its nominee) will promptly execute any dividend mandate necessary to ensure that payment is made direct to the relevant DIP Chargor; or
 - (ii) if payment is made directly to the DIP Agent (or its nominee) before this Security becomes enforceable, the DIP Agent (or that nominee) will promptly pay that amount to the relevant DIP Chargor.
- (d) Before the occurrence of an Enforcement Event, the DIP Agent shall use its reasonable endeavours to promptly forward to the relevant DIP Chargor all material notices, correspondence and/or other communication it receives in relation to the Shares but only in so far as the Shares are registered in the name of the DIP Agent.
- (e) After the occurrence of an Enforcement Event, the DIP Agent or its nominee may (in order to preserve and/or realise the value of the Security) exercise or refrain from exercising:

- (i) any voting rights; and
- (ii) any other powers or rights which may be exercised by the legal or beneficial owner of the Shares, any person who is the holder of the Shares or otherwise,

in each case, in the name of the relevant DIP Chargor, the registered holder or otherwise and without any further consent or authority on the part of such DIP Chargor and irrespective of any direction given by such DIP Chargor.

- (f) The DIP Agent shall not be entitled to exercise voting or any other rights or powers or take any action otherwise permitted under paragraph (e) above if and to the extent that, from time to time:
 - (i) a notifiable acquisition would, as a consequence, take place under section 6 of the National Security and Investment Act 2021 (the "NSIA") and any regulations made under the NSIA; and
 - (ii) either:
 - (A) the Secretary of State has not approved that notifiable acquisition under and in accordance with the NSIA; or
 - (B) the Secretary of State has so approved that notifiable acquisition but there would, as a consequence, be a breach of the provisions of a final order made in relation to it under the NSIA,

provided that, for the avoidance of doubt, this paragraph (f) is for the benefit of the DIP Agent only and the DIP Agent shall be entitled to exercise rights under paragraph (e) above without obtaining any approvals under the NSIA, if it determines that it is not necessary or advisable to obtain the same.

- (g) To the extent that the Shares remain registered in the name of the relevant DIP Chargor, such DIP Chargor irrevocably appoints the DIP Agent or its nominee as its proxy to exercise all voting rights in respect of those Shares at any time after the occurrence of an Enforcement Event.
- (h) Each DIP Chargor must indemnify the DIP Agent against any loss or liability incurred by the DIP Agent as a consequence of the DIP Agent acting in respect of its Shares on the direction of such DIP Chargor, except where such loss, cost, expense or liability results from the gross negligence or wilful misconduct of the DIP Agent.

9.8 Clearance systems

- (a) At any time after the occurrence of an Enforcement Event, each relevant DIP Chargor must, if so requested by the DIP Agent:
 - (i) instruct any clearance system to transfer any Shares held by it for such DIP Chargor or its nominee to an account of the DIP Agent (or its nominee) with that clearance system; and

- (ii) take whatever action the DIP Agent may reasonably request for the dematerialisation or rematerialisation of any Shares held in a clearance system.
- (b) At any time after the occurrence of an Enforcement Event the DIP Agent may, at the expense of the relevant DIP Chargor, take whatever action is required for the dematerialisation or rematerialisation of the Shares as necessary.

9.9 Custodian arrangements

Each relevant DIP Chargor must:

- (a) promptly give notice of this Debenture to any custodian of any of the Shares (if applicable), in any form which the DIP Agent may reasonably require; and
- (b) use reasonable endeavours to ensure that the custodian acknowledges that notice in any form which the DIP Agent may reasonably require,

but so that the DIP Agent shall not require any such notice or acknowledgment to state that the DIP Agent has any rights over or in respect of the Shares prior to the occurrence of an Enforcement Event.

9.10 PSC Register

- (a) Each relevant DIP Chargor shall promptly:
 - (i) notify the DIP Agent of its receipt of, any "warning notice" or "restrictions notice" (as defined in paragraph 1(2) of Schedule 1B of the Companies Act 2006) in respect of any of the Shares; and
 - (ii) provide to the DIP Agent a copy of any such warning notice or restrictions notice,

in each case before it issues, or after it receives, any such notice.

(b) For the purposes of withdrawing any restrictions notice or for any application (or similar) to the court under Schedule 1B of the Companies Act 2006, each relevant DIP Chargor shall provide such assistance as the DIP Agent may reasonably request in respect of any Shares and provide the DIP Agent with all information, documents and evidence that it may reasonably request in connection with the same.

10 CONTINUING SECURITY¹

10.1 Continuing Security

The Security constituted by this Debenture shall be a continuing security notwithstanding any intermediate payment or settlement of all or any part of the Secured Obligations or any other act, matter or thing.

10.2 Other Security

The Security constituted by this Debenture is to be in addition to and shall neither be merged in nor in any way exclude or prejudice or be affected by any other Security or other right which the DIP Agent and/or any other Secured Party may now or after the date of this Debenture hold for any of the Secured Obligations, and this Security may be enforced against each DIP Chargor without first having recourse to any other rights of the DIP Agent or any other Secured Party.

11 ENFORCEMENT OF SECURITY

11.1 When Security becomes enforceable

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the Security constituted by this Debenture shall become immediately enforceable on the occurrence of an Enforcement Event. After the Security constituted by this Debenture has become enforceable, the DIP Agent may, subject to the terms of the DIP Credit Agreement and the DIP Orders, enforce all or any part of that Security at the times, in the manner and on the terms it thinks fit, and take possession of and hold or dispose of all or any part of the Charged Assets.²

11.2 Enforcement Powers

Subject to the terms of the DIP Credit Agreement and the DIP Orders, for the purpose of all rights and powers implied or granted by statute, the Secured Obligations are deemed to have fallen due on the date of this Debenture. The power of sale and other powers conferred by section 101 of the Law of Property Act 1925 and all other enforcement powers conferred by this Debenture shall (subject to the terms of the DIP Credit Agreement) be immediately exercisable at any time after an Enforcement Event.

11.3 Statutory Powers

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the powers conferred on mortgagees, receivers or administrative receivers by the Law of Property Act 1925 and the Insolvency Act 1986 (as the case may be) shall apply to the Security created under this Debenture, unless they are expressly or impliedly excluded. If there

is ambiguity or conflict between the powers contained in those Acts and those contained in this Debenture, those contained in this Debenture shall prevail.

11.4 Exercise of Powers

Subject to the terms of the DIP Credit Agreement and the DIP Orders, all or any of the powers conferred upon mortgagees by the Law of Property Act 1925 as varied or extended by this Debenture, and all or any of the rights and powers conferred by this Debenture on a Receiver (whether expressly or impliedly), may be exercised by the DIP Agent without further notice to any DIP Chargor at any time after an Enforcement Event has occurred, irrespective of whether the DIP Agent has taken possession or appointed a Receiver of the Charged Property.

11.5 Disapplication of Statutory Restrictions

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the restriction on the consolidation of mortgages and on power of sale imposed by sections 93 and 103 respectively of the Law of Property Act 1925 shall not apply to the security constituted by this Debenture.

11.6 Appropriation under the Financial Collateral Regulations

Subject to the terms of the DIP Credit Agreement and the DIP Orders:

- (a) To the extent that any of the Charged Property constitutes "financial collateral" and this Debenture and the obligations of the DIP Chargors hereunder constitute a "security financial collateral arrangement" (in each case as defined in, and for the purposes of, the Financial Collateral Arrangements (No. 2) Regulations 2003 (as amended) (the "**Regulations**")), the DIP Agent shall have the right to appropriate all or any part of such financial collateral in or towards discharge of the Secured Obligations and may exercise that right to appropriate by giving notice to the relevant DIP Chargors at any time after an Enforcement Event has occurred.
- (b) Where any financial collateral is appropriated:
 - (i) if the financial collateral is listed or traded on a recognised exchange, its value shall be taken as the value at which it could have been sold on the exchange on the date of the appropriation; or
 - (ii) in any other case, the value of the financial collateral shall be such amount as the DIP Agent reasonably determines by reference to a public index or by such other process as the DIP Agent may select, which (without limitation and in the DIP Agent's discretion) may be upon the valuation or advice obtained by it from an independent investment or accountancy firm of national standing selected by it,

and each Secured Party will give credit for the proportion of the value of the financial collateral appropriated to its use.

(c) The parties agree that the methods of valuation provided for in paragraph (b) above shall constitute commercially reasonable methods of valuation for the purposes of the Regulations.

11.7 Powers of Leasing

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the DIP Agent may lease, make agreements for leases at a premium or otherwise, accept surrenders of leases and grant options or vary or reduce any sum payable under any leases or tenancy agreements as it thinks fit, without the need to comply with any of the provisions of sections 99 and 100 of the Law of Property Act 1925.

11.8 Fixtures

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the DIP Agent may sever any fixtures from the property to which they are attached and sell them separately from that property.

11.9 Bank Accounts

Subject to the terms of the DIP Credit Agreement and the DIP Orders, at any time after an Enforcement Event has occurred the DIP Agent may and is hereby irrevocably and unconditionally authorised, without further enquiry and without either giving notice to the DIP Chargor or the Company or obtaining any consent, to apply the whole or part of all monies standing to the credit of the Accounts in or towards payment of the Secured Obligations.

12 RECEIVERS

12.1 Appointment of Receiver

Subject to the terms of the DIP Credit Agreement and the DIP Orders:

- (a) Subject to paragraph (c) below, at any time on or after an Enforcement Event, or if so requested by the relevant DIP Chargor, the DIP Agent may by writing under hand signed by any officer or manager of the DIP Agent, appoint any person (or persons) to be a Receiver of all or any part of the Charged Property.
- (b) Section 109(1) of the Law of Property Act 1925 shall not apply to this Debenture.
- (c) The DIP Agent shall be entitled to appoint a Receiver save to the extent prohibited by section 72A Insolvency Act 1986.
- (d) The DIP Agent is not entitled to appoint a Receiver solely as a result of the obtaining of a moratorium (or anything done with a view to obtaining a moratorium) under section 1A of the Insolvency Act 1986.
- (e) The DIP Agent may not appoint an administrative receiver (as defined in section 29(2) of the Insolvency Act 1986) over the Charged Property if the DIP Agent is prohibited from so doing by section 72A of the Insolvency Act 1986 and no exception to the prohibition on appointing an administrative receiver applies.

12.2 Powers of Receiver

Subject to the terms of the DIP Credit Agreement and the DIP Orders, each Receiver appointed under this Debenture shall have (subject to any limitations or restrictions which the DIP Agent may incorporate in the deed or instrument appointing it) all the powers conferred from time to time on receivers by the Law of Property Act 1925 and the Insolvency Act 1986 (each of which is deemed incorporated in this Debenture), so that the powers set out in schedule 1 to the Insolvency Act 1986 shall extend to every Receiver, whether or not an administrative receiver. In addition, notwithstanding any liquidation of the relevant DIP Chargor, each Receiver shall have power to:

- (a) manage, develop, reconstruct, amalgamate or diversify any part of the business of the relevant DIP Chargor;
- (b) enter into or cancel any contracts on any terms or conditions;
- (c) incur any liability on any terms, whether secured or unsecured, and whether to rank for payment in priority to this security or not;
- (d) let or lease or concur in letting or leasing, and vary the terms of, determine, surrender leases or tenancies of, or grant options and licences over, or otherwise deal with, all or any of the Charged Property, without being responsible for loss or damage;
- (e) establish subsidiaries to acquire interests in any of the Charged Property and/or arrange for those subsidiaries to trade or cease to trade and acquire any of the Charged Property on any terms and conditions;
- (f) make and effect all repairs, renewals and improvements to any of the Charged Property and maintain, renew, take out or increase insurances;
- (g) exercise all voting and other rights attaching to the Shares or Investments and stocks, shares and other securities owned by the relevant DIP Chargor and comprised in the Charged Property, but only following a written notification from either the Receiver or the DIP Agent to the relevant DIP Chargor stating that the DIP Agent shall exercise all voting rights in respect of the Shares or Investments and stocks, shares and other securities owned by the relevant DIP Chargor and comprised in the Charged Property;
- (h) redeem any prior Security on or relating to the Charged Property and settle and pass the accounts of the person entitled to that prior Security, so that any accounts so settled and passed shall (subject to any manifest error) be conclusive and binding on the relevant DIP Chargor and the money so paid shall be deemed to be an expense properly incurred by the Receiver;
- (i) appoint and discharge officers and others for any of the purposes of this Debenture and/or to guard or protect the Charged Property upon terms as to remuneration or otherwise as he may think fit;
- (j) settle any claims, accounts, disputes, questions and demands with or by any person who is or claims to be a creditor of the relevant DIP Chargor or relating to any of the Charged Property;

- (k) implement or continue the development of (and obtain all consents required in connection therewith) and/or complete any buildings or structures on any real property comprised in the Charged Property;
- (1) purchase or acquire any land or any interest in or right over land;
- (m) exercise on behalf of the relevant DIP Chargor all the powers conferred on a landlord or a tenant by any legislation from time to time in force in any relevant jurisdiction relating to rents or agriculture in respect of any part of the Property;
- (n) exercise all rights expressed to be conferred upon the DIP Agent in connection with the Security, including to release the Charged Property from the Security (whether such right is contained in this Debenture or any other Loan Document); and
- (o) do all other acts and things (including signing and executing all documents and deeds) as the Receiver considers to be incidental or conducive to any of the matters or powers in this Clause 12.2, or otherwise incidental or conducive to the preservation, improvement or realisation of the Charged Property, and use the name of the relevant DIP Chargor for all such purposes,

and in each case may use the name of any DIP Chargor and exercise the relevant power in any manner which he may, in good faith, think fit.

12.3 Receiver as Agent

Subject to the terms of the DIP Credit Agreement and the DIP Orders, each Receiver shall be the agent of the relevant DIP Chargor, which shall be solely responsible for his acts or defaults, and for his remuneration and expenses, and be liable on any agreements or engagements made or entered into by him. The DIP Agent will not be responsible for any misconduct, negligence or default of a Receiver.

12.4 Removal of Receiver

Subject to the terms of the DIP Credit Agreement and the DIP Orders, the DIP Agent may by notice remove from time to time any Receiver appointed by it (subject to the provisions of section 45 of the Insolvency Act 1986 in the case of an administrative receivership) and, whenever it may deem appropriate, appoint a new Receiver in the place of any Receiver whose appointment has terminated, for whatever reason.

12.5 Remuneration of Receiver

Subject to the terms of the DIP Credit Agreement and the DIP Orders, subject to section 36 of the Insolvency Act 1986, the DIP Agent may from time to time fix the remuneration of any Receiver appointed by it.

12.6 Several Receivers

Subject to the terms of the DIP Credit Agreement and the DIP Orders, if at any time there is more than one Receiver, each Receiver may separately exercise all of the powers conferred by this Debenture (unless the document appointing such Receiver states otherwise).

13 APPLICATION OF PROCEEDS

13.1 Order of Application

All moneys received or recovered by the DIP Agent or any Receiver pursuant to this Debenture shall (subject to the claims of any person having prior rights thereto and subject to Clause 13.5 (*Suspense Account*)) be applied in the order and manner specified by the DIP Credit Agreement or the DIP Orders notwithstanding any purported appropriation by any DIP Chargor.

13.2 Insurance Proceeds

If an Enforcement Event has occurred, all moneys received by virtue of any insurance maintained or effected in respect of the Charged Property shall be paid to the DIP Agent (or, if not paid by the insurers directly to the DIP Agent, shall be held on trust for the DIP Agent) and shall, at the option of the DIP Agent, be applied in replacing or reinstating the assets destroyed, damaged or lost (any deficiency being made good by the relevant DIP Chargor) or (except in the case of leasehold premises) in reduction of the Secured Obligations.

13.3 Section 109 Law of Property Act 1925

Sections 109(6) and (8) of the Law of Property Act 1925 shall not apply to a Receiver appointed under this Debenture.

13.4 Application against Secured Obligations

Subject to Clause 13.1 above, any moneys or other value received or realised by the DIP Agent from a DIP Chargor or a Receiver under this Debenture may be applied by the DIP Agent to any item of account or liability or transaction forming part of the Secured Obligations to which they may be applicable in any order or manner which the DIP Agent may determine.

13.5 Suspense Account

Until the Secured Obligations are paid in full, the DIP Agent or the Receiver (as applicable) may place and keep (for such time as it shall determine) any money received, recovered or realized pursuant to this Debenture or on account of any DIP Chargor's liability in respect of the Secured Obligations in an interest bearing separate suspense account (to the credit of either the relevant DIP Chargor or the DIP Agent or the Receiver as the DIP Agent or the Receiver shall think fit) and the DIP Agent or the Receiver may retain the same for the period which it considers expedient without having any obligation to apply all or any part of that money in or towards discharge of the Secured Obligations.

14 PROTECTION OF DIP AGENT AND RECEIVER

14.1 No Liability

Neither the DIP Agent nor any Receiver nor any Delegate shall be liable in respect of any of the Charged Property or for any loss or damage which arises out of the exercise or the attempted or purported exercise of, or the failure to exercise any of, their respective powers, unless caused by its or his gross negligence, bad faith or wilful misconduct.

14.2 Possession of Charged Property

Without prejudice to Clause 14.1 above, if the DIP Agent or the Receiver enters into possession of the Charged Property, it will not be liable to account as mortgagee in possession and may at any time at its discretion go out of such possession.

14.3 Primary liability of DIP Chargor

Each DIP Chargor shall be deemed to be a principal debtor and the sole, original and independent obligor for the Secured Obligations and the Charged Property shall be deemed to be a principal security for the Secured Obligations. The liability of each DIP Chargor under this Debenture and the charges contained in this Debenture shall not be impaired by any forbearance, neglect, indulgence, abandonment, extension of time, release, surrender or loss of securities, dealing, variation or arrangement by the DIP Agent or any other Secured Party, or by any other act, event or matter whatsoever whereby the liability of the relevant DIP Chargor (as a surety only) or the charges contained in this Debenture (as secondary or collateral charges only) would, but for this provision, have been discharged.

14.4 Waiver of defences

The obligations of each DIP Chargor under this Debenture will not be affected by an act, omission, matter or thing which, but for this Debenture, would reduce, release or prejudice any of its obligations under this Debenture (without limitation and whether or not known to it or any Secured Party) including:

- (a) any time, waiver or consent granted to, or composition with, any Loan Party or other person;
- (b) any release of any other Loan Party or any other person under the terms of any composition or arrangement with any creditor of any Group Member;
- (c) the taking, variation, compromise, exchange, renewal or release of, or refusal or neglect to perfect, take up or enforce, any rights against, or security over assets of, any Loan Party or other person;
- (d) any non-presentation or non-observance of any formality or other requirement in respect of any instrument or any failure to realise the full value of any security;
- (e) any incapacity or lack of power, authority or legal personality of or dissolution or change in the members or status of a Loan Party or any other person;
- (f) any amendment, novation, supplement, extension restatement (however fundamental and whether or not more onerous) or replacement of a Loan Document or any other document or security including, without limitation, any change in the purpose of, any extension of or increase in any facility or the addition of any new facility under any Loan Document or other document or security;

- (g) any unenforceability, illegality or invalidity of any obligation of any person under any Loan Document or any other document or security or the failure by any Group Member to enter into or be bound by any Loan Document; or
- (h) any insolvency or similar proceedings.

14.5 DIP Agent

The provisions set out in Article X (*Administrative Agent*) of the DIP Credit Agreement shall govern the rights, duties and obligations of the DIP Agent under this Debenture.

14.6 Delegation

The DIP Agent may delegate by power of attorney or in any other manner all or any of the powers, authorities and discretions which are for the time being exercisable by it under this Debenture to any person or persons upon such terms and conditions (including the power to sub-delegate) as it may think fit. The DIP Agent will not be liable or responsible to any DIP Chargor or any other person for any losses arising from any act, default, omission or misconduct on the part of any delegate.

14.7 Cumulative Powers

The powers which this Debenture confers on the DIP Agent, the other Secured Parties and any Receiver appointed under this Debenture are cumulative, without prejudice to their respective powers under the general law, and may be exercised as often as the relevant person thinks appropriate. The DIP Agent, the other Secured Parties or the Receiver may, in connection with the exercise of their powers, join or concur with any person in any transaction, scheme or arrangement whatsoever. The respective powers of the DIP Agent, the other Secured Parties and the Receiver will in no circumstances be suspended, waived or otherwise prejudiced by anything other than an express consent or amendment.

15 POWER OF ATTORNEY

Each DIP Chargor, by way of security, irrevocably and severally appoints the DIP Agent, each Receiver and any person nominated for the purpose by the DIP Agent or any Receiver (in writing and signed by an officer of the DIP Agent or Receiver) as its attorney (with full power of substitution and delegation) in its name and on its behalf and as its act and deed to ((i) following the occurrence of an Enforcement Event or (ii) if the relevant DIP Chargor has materially failed to comply with a further assurance or perfection obligation, in which case, only to the extent necessary in order to complete such further assurance or perfection requirement) execute, seal and deliver (using the company seal where appropriate) and otherwise perfect and do any deed, assurance, agreement, instrument, act or thing which it ought to execute and do under the terms of this Debenture, or which may be required or deemed proper in the exercise of any rights or powers conferred on the DIP Agent or any Receiver under this Debenture or otherwise for any of the purposes of this Debenture, and each DIP Chargor covenants with the DIP Agent and each Receiver to ratify and confirm all such acts or things made, done or executed by that attorney.

16 PROTECTION FOR THIRD PARTIES

16.1 No Obligation to Enquire

No purchaser from, or other person dealing with, the DIP Agent or any Receiver (or their agents) shall be obliged or concerned to enquire whether:

- (a) the right of the DIP Agent or any Receiver to exercise any of the powers conferred by this Debenture has arisen or become exercisable or as to the propriety or validity of the exercise or purported exercise of any such power; or
- (b) any of the Secured Obligations remain outstanding and/or are due and payable or be concerned with notice to the contrary and the title and position of such a purchaser or other person shall not be impeachable by reference to any of those matters.

16.2 Receipt Conclusive

The receipt of the DIP Agent or any Receiver shall be an absolute and a conclusive discharge to a purchaser, and shall relieve him of any obligation to see to the application of any moneys paid to or by the direction of the DIP Agent or any Receiver.

17 COSTS AND EXPENSES

17.1 Initial Expenses

Each DIP Chargor shall within five Business Days of demand pay to each of the DIP Agent and any Receiver the amount of all reasonable and documented costs and expenses (including legal fees) properly incurred by any of them in connection with:

- (a) the negotiation, preparation, execution, completion and perfection of this Debenture and any other documents or notices referred to in, or related or incidental to, this Debenture; and
- (b) any amendment, waiver or consent relating to this Debenture (and documents, matters or things referred to in this Debenture).

17.2 Enforcement Expenses

Each DIP Chargor shall, within five Business Days of demand, pay to each of the DIP Agent, any Receiver and each other Secured Party the amount of all documented costs and expenses (including legal fees) properly incurred by it in connection with the enforcement of or the preservation of any rights under (and any documents referred to in) this Debenture and any proceedings instituted by or against the DIP Agent and any Secured Party as a consequence of taking or holding the Security created under this Debenture or enforcing these rights.

17.3 Stamp Duties, etc.

Each DIP Chargor shall pay and, within five Business Days of demand, indemnify each Secured Party against any cost, loss or liability that Secured Party incurs in relation to all stamp duty, registration and other similar Taxes, if any, payable in respect of this Debenture.

17.4 Default Interest

If not paid when due, the amounts payable under this Clause 17 shall carry interest compounded with monthly rests at the Default Rate (after as well as before judgment), from the date of demand and shall form part of the Secured Obligations.

18 REINSTATEMENT AND RELEASE

18.1 Amounts Avoided

If any discharge (whether in respect of the obligations of any Loan Party or any security for those obligations or otherwise) or arrangement is made in whole or in part on the faith of any payment, security or other disposition which is avoided or must be restored on insolvency, liquidation, administration or otherwise without limitation, the liability of each DIP Chargor under this Debenture will continue or be reinstated as if the discharge or arrangement had not occurred. No interest shall accrue on any such amount, unless and until such amount is so avoided or set aside.

18.2 Discharge Conditional

Any settlement or discharge between a DIP Chargor and any Secured Party shall be conditional upon no security or payment to that Secured Party by that DIP Chargor or any other person being avoided, set aside, ordered to be refunded or reduced by virtue of any provision or enactment relating to insolvency and accordingly (but without limiting the other rights of that Secured Party under this Debenture) that Secured Party shall be entitled to recover from that DIP Chargor the value which that Secured Party has placed on that security or the amount of any such payment as if that settlement or discharge had not occurred.

18.3 Covenant to Release

If the DIP Agent is satisfied that:

- (a) all the Secured Obligations have been irrevocably paid or discharged in full and none of the DIP Agent nor any Secured Party has any actual or contingent liability to advance further monies to, or incur liability on behalf of, any Loan Party; or
- (b) any DIP Chargor is unconditionally entitled pursuant to any provision of the Loan Documents to have the Charged Property released from the Security, the DIP Agent must promptly, at the request and cost of the DIP Chargors, take whatever action is reasonably necessary to release and discharge the Charged Property from this Security (which shall include the execution, on behalf of each Secured Party, of each document reasonably required to achieve such release).

19 CURRENCY CLAUSES

19.1 Conversion

All monies received or held by the DIP Agent or any Receiver under this Debenture may be converted into any other currency which the DIP Agent considers necessary to cover the obligations and liabilities comprised in the Secured Obligations in that other currency at the DIP Agent's spot rate of exchange then prevailing for purchasing that other currency with the existing currency.

19.2 No Discharge

No payment to the DIP Agent (whether under any judgment or court order or otherwise) shall discharge the obligation or liability of the relevant DIP Chargor in respect of which it was made unless and until the DIP Agent has received payment in full in the currency in which the obligation or liability is payable or, if the currency of payment is not specified, was incurred. To the extent that the amount of any such payment shall on actual conversion into that currency fall short of that obligation or liability expressed in that currency, the DIP Agent shall have a further separate cause of action against the relevant DIP Chargor and shall be entitled to enforce the Security constituted by this Debenture to recover the amount of the shortfall.

20 SET-OFF

20.1 Set-off rights

Upon the occurrence of an Enforcement Event, the DIP Agent may set off any matured obligation due from a DIP Chargor under the Loan Documents (to the extent beneficially owned by the DIP Agent) against any matured obligation owed by the DIP Agent to that DIP Chargor, regardless of the place of payment, booking branch or currency of either obligation.

20.2 Different Currencies

The DIP Agent may exercise its rights under Clause 20.1 (*Set-off rights*) notwithstanding that the amounts concerned may be expressed in different currencies and the DIP Agent is authorised to effect any necessary conversions at a market rate of exchange selected by it acting reasonably.

20.3 Unliquidated Claims

If, at any time after notice demanding payment of any sum which is then due but unpaid in respect of the Secured Obligations has been given by the DIP Agent to any DIP Chargor, the relevant obligation or liability is unliquidated or unascertained, the DIP Agent may set-off the amount which it estimates (in good faith) will be the final amount of that obligation or liability once it becomes liquidated or ascertained.

20.4 No Set-off

The DIP Chargor will pay all amounts payable under this Debenture without any setoff, counterclaim or deduction whatsoever unless required by law, in which event, other than in the case of a payment of interest, the DIP Chargor will pay an additional amount to ensure that the payment recipient receives the amount which would have been payable had no deduction been required to have been made.

21 RULING OFF

If the DIP Agent or any other Secured Party receives notice of any subsequent Security or other interest affecting any of the Charged Property (except as permitted by the Loan Documents) it may open a new account for the relevant DIP Chargor in its books. If it does not do so then (unless it gives express notice to the contrary to the relevant DIP Chargor), as from the time it receives that notice, all payments made by the relevant DIP Chargor to it (in the absence of any express appropriation to the contrary) shall be treated as having been credited to a new account of the relevant DIP Chargor and not as having been applied in reduction of the Secured Obligations.

22 REDEMPTION OF PRIOR CHARGES

The DIP Agent may, at any time after an Enforcement Event has occurred, redeem any prior Security on or relating to any of the Charged Property or procure the transfer of that Security to itself, and may settle and pass the accounts of any person entitled to that prior Security. Any account so settled and passed shall (subject to any manifest error) be conclusive and binding on each DIP Chargor. Each DIP Chargor will on demand pay to the DIP Agent all principal monies and interest and all losses incidental to any such redemption or transfer.

23 NOTICES

Section 11.8 (*Notices, Etc.*) of the DIP Credit Agreement shall apply to any communication to be made under or in connection with this Debenture (including by any Secured Creditor who is not a party to this Debenture) as if it were set out in full in this Debenture.

24 CHANGES TO PARTIES

24.1 Assignment by the DIP Agent

The DIP Agent may at any time assign or otherwise transfer all or any part of its rights under this Debenture in accordance with the Loan Documents.

24.2 New Subsidiaries

Each of the DIP Chargors will procure that any new Subsidiary of it which is required to do so by Section 7.11 (*Additional Collateral and Guaranties; Guarantor Coverage Test*) of the DIP Credit Agreement executes a Security Accession Deed.

24.3 Consent of DIP Chargors

- (a) Each DIP Chargor consents to new Subsidiaries becoming DIP Chargors as contemplated by Clause 24.2 above.
- (b) Each DIP Chargor confirms that the execution of any Security Accession Deed by a new Subsidiary will in no way prejudice or affect the security granted by each of them under (and the covenants given by each of them in), this Debenture

and that this Debenture shall remain in full force and effect as supplemented by any such Security Accession Deed.

(c) Each DIP Chargor further confirms that the execution of any other supplemental security document by a DIP Chargor will in no way prejudice or affect the security granted by each of them under (and the covenants given by each of them in), this Debenture and that this Debenture shall remain in full force and effect as supplemented by any such supplemental security document.

25 MISCELLANEOUS

25.1 Certificates Conclusive

A certificate or determination of the DIP Agent as to any amount payable under this Debenture will be conclusive and binding on each DIP Chargor, except in the case of manifest error.

25.2 Counterparts

This Debenture may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Debenture.

25.3 Invalidity of any Provision

If any provision of this Debenture is or becomes invalid, illegal or unenforceable in any respect under any law, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired in any way.

25.4 Failure to Execute

Failure by one or more parties ("**Non-Signatories**") to execute this Debenture on the date hereof will not invalidate the provisions of this Debenture as between the other Parties who do execute this Debenture. Such Non-Signatories may execute this Debenture on a subsequent date and will thereupon become bound by its provisions.

26 GOVERNING LAW AND JURISDICTION

- (a) This Debenture and any non-contractual claims arising out of or in connection with it shall be governed by and construed in accordance with English law.
- (b) Subject to paragraph (c) below, the Parties agree that the courts of England shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this Debenture, whether contractual or non-contractual (including a dispute regarding the existence, validity or termination of this Debenture) (a "Dispute"). The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no party will argue to the contrary.
- (c) The Parties agree that, for the benefit of the Secured Parties only, nothing in this Debenture shall limit the right of the Secured Parties to bring any legal action against any of the DIP Chargors in any other court of competent jurisdiction.

FORM OF SECURITY ACCESSION DEED

THIS SECURITY ACCESSION DEED is made on [•]

BETWEEN:

- (1) **Crown UK HoldCo Limited**, a company incorporated in England and Wales with registered number 11088548 (the "**Company**");
- (2) [•] Limited, a company incorporated in England and Wales with registered number
 [•] (the "New DIP Chargor"); and
- (3) [•] as security trustee for itself and the other Secured Parties (the "DIP Agent").

RECITAL:

This deed is supplemental to a debenture dated 9 September 2022 between, amongst others, the Company, the DIP Chargors named therein and the DIP Agent, as amended, restated, amended and restated, supplemented or otherwise modified from time to time (the "**Debenture**").

NOW THIS DEED WITNESSES as follows:

2 INTERPRETATION

2.1 Definitions

Terms defined in the Debenture shall have the same meaning when used in this deed.

2.2 Construction

Clauses 1.2 (*Construction*) to 1.5 (*Miscellaneous*) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to the "Debenture" and other similar expressions were references to this deed.

3 ACCESSION OF NEW DIP CHARGOR

3.1 Accession

The New DIP Chargor agrees to be a DIP Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a DIP Chargor.

3.2 Covenant to pay

The New DIP Chargor as primary obligor covenants with the DIP Agent (for the benefit of itself and the other Secured Parties) that it will pay or discharge the Secured Obligations in the manner provided for in the Loan Documents.

3.3 Specific Security

Subject to Clause 2.6 (*Property Restricting Charging*), the New DIP Chargor, as continuing security for the payment of the Secured Obligations, charges in favour of the DIP Agent with full title guarantee the following assets, both present and future, from time to time owned by it or in which it has an interest:

- (a) by way of first legal mortgage all Mortgaged Real Property now belonging to or vested in it; and
- (b) by way of first fixed charge:
 - (i) all other interests (not effectively charged under Clause 1.1(a)) in any Property and the benefit of all other agreements relating to land;
 - (ii) all of its rights, title and interest in the Intellectual Property;
 - (iii) all of its rights, title and interest in the Equipment;
 - (iv) all the Investments, Shares and all corresponding Related Rights;
 - (v) all Trading Receivables and all rights and claims against third parties and against any security in respect of those Trading Receivables;
 - (vi) all Other Debts and all rights and claims against third parties against any security in respect of those Other Debts;
 - (vii) all monies from time to time standing to the credit of the Accounts (including any interest and other sums accruing thereon), together with all of its rights, title and interest in, and benefits and proceeds deriving from or arising in connection with, the Accounts (subject, in each case, to any security interests in favour of the relevant Account Bank where such security interests arise by operation of law or by operation of the terms and conditions of such Account Bank as applicable to the relevant Account);
 - (viii) all of its rights, title and interest in the Hedging Contracts;
 - (ix) all of its goodwill and uncalled capital;
 - (x) any beneficial interest, claim or entitlement it has to any assets of any pension fund;
 - (xi) the benefit of any authorisation (statutory or otherwise) held in connection with its business or the use of any Charged Property;
 - (xii) the right to recover and receive compensation which may be payable to it in respect of any authorisation referred to in paragraph (xi) above; and
 - (xiii) all its rights, title and interest in (and proceeds and claims under) the Insurance Policies and the Charged Agreements (subject, in each case, to such Security being permissible under the terms of such Insurance

Policy or Charged Agreement, as applicable), and includes, in respect of each of the above charged assets (as appropriate), the benefit of all licences, consents and agreements held by the New DIP Chargor in connection with the use of the asset, any monies or income paid or payable in respect of the asset, any proceeds of the sale of the asset and any other property, rights or claims relating to, accruing to or deriving from the asset.

3.4 Floating Charge

- (a) As further continuing security for the payment of the Secured Obligations, the New DIP Chargor charges with full title guarantee in favour of the DIP Agent by way of first floating charge all its present and future assets, undertakings and rights.
- (b) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 shall apply to the floating charge created by this deed.

3.5 Conversion of Floating Charge

- (a) Except as provided below, the DIP Agent may, by notice to the New DIP Chargor, convert the floating charge created under this deed into a fixed charge with immediate effect as regards those assets specified in the notice:
 - (i) if an Enforcement Event has occurred;
 - (ii) if the DIP Agent reasonably considers that any asset charged under the floating charge created under this deed is in danger of being seized or sold under any form of distress, attachment, execution or other legal process or is otherwise in jeopardy; or
 - (iii) if the New DIP Chargor fails to comply, or takes or threatens to take any action which, in the reasonable opinion of the DIP Agent, is likely to result in it failing to comply with its obligations under paragraph (a) of Clause 3.
- (b) The floating charge created under this deed will automatically (without notice, and in addition to the circumstances in which the same will occur by operation of law) and immediately be converted into a fixed charge over all the assets of the New DIP Chargor which are subject to the floating charge created under this deed, if:
 - (i) the members of the New DIP Chargor convene a meeting for the purposes of considering any resolution for its winding-up, dissolution, or a compromise, assignment or arrangement with any creditor; or
 - (ii) any person (entitled to do so) gives notice of its intention to appoint an administrator to the New DIP Chargor or files such a notice with the court.
- (c) Upon the conversion of any floating charge pursuant to this Clause 2.5, the New DIP Chargor shall, at its own expense, immediately upon request by the DIP

Agent execute a fixed charge or legal assignment in such form as the DIP Agent may require.

3.6 Property Restricting Charging

- (a) There shall be excluded from the charge created by Clause 2.3 and from the operation of the further assurance provisions set out in the Debenture:
 - (i) any leasehold property held by a the New DIP Chargor under a lease which prohibits either absolutely or conditionally (including requiring the consent of any third party) the New DIP Chargor from creating any charge over its leasehold interest; and
 - (ii) any Intellectual Property in which the New DIP Chargor has an interest under any licence or other agreement which prohibits either absolutely or conditionally (including requiring the consent of any third party) the New DIP Chargor from creating any charge over its interest in that Intellectual Property,

in each case until the relevant condition or waiver has been satisfied or obtained.

- (b) For all leasehold property or Intellectual Property referred to in Clause 2.6(a), the New DIP Chargor undertakes to use reasonable endeavours to obtain the relevant consent or waiver of prohibition or condition as soon as practicable and promptly to supply to the DIP Agent a copy of any such consent or waiver of prohibition or condition obtained by it.
- (c) For all leasehold property or Intellectual Property referred to in Clause 2.6(a), the New DIP Chargor undertakes to secure all damages, compensation, remuneration, profit, rent or income which the New DIP Chargor may receive, or has received, under any relevant lease document or Intellectual Property document but shall not be required to provide security over the document itself until such consent is obtained.
- (d) Immediately upon receipt of the relevant waiver or consent, the formerly excluded leasehold property or Intellectual Property shall stand charged to the DIP Agent under Clause 2.3. If required by the DIP Agent, at any time following receipt of that waiver or consent, the New DIP Chargor will forthwith execute a valid fixed charge or legal assignment in such form as the DIP Agent shall reasonably require.

4 NEGATIVE PLEDGE

The New DIP Chargor may not:

- (a) create or agree to create or permit to subsist any Security or Quasi-Security over all or any part of its Charged Property; or
- (b) sell, transfer, lease out, lend or otherwise dispose of all or any part of its Charged Property (other than in respect of assets charged under Clause 2.4 (*Floating Charge*) on arm's length terms in the ordinary course of trading) or the right to receive or to be paid the proceeds arising on the disposal of the same, or agree

or attempt to do so, except as permitted by the Loan Documents or with the prior consent of the DIP Agent.

5 CONSTRUCTION OF DEBENTURE

- (a) The Debenture shall remain in full force and effect as supplemented by this deed.
- (b) The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this deed" or "this Debenture" and other similar expressions will be deemed to be references to the Debenture as supplemented by this deed.

6 DESIGNATION AS A LOAN DOCUMENT

This deed is designated as a Loan Document.

7 FAILURE TO EXECUTE

Failure by one or more parties ("Non-Signatories") to execute this deed on the date hereof will not invalidate the provisions of this deed as between the other Parties who do execute this deed. Such Non-Signatories may execute this deed on a subsequent date and will thereupon become bound by its provisions.

- (b) Subject to paragraph (c) below, the Parties agree that the courts of England shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this deed, whether contractual or non-contractual (including a dispute regarding the existence, validity or termination of this deed) (a "**Dispute**"). The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no party will argue to the contrary.
- (c) The Parties agree that, for the benefit of the Secured Parties only, nothing in this deed shall limit the right of the Secured Parties to bring any legal action against the New DIP Chargor in any other court of competent jurisdiction.
