**THIS DEED** is dated **28** October 2013 and is made **BETWEEN**:

- (1) **THE COMPANIES** listed in Schedule 1 as chargors (the **Chargors**); and
- (2) **BANK OF SCOTLAND PLC** as security agent (the **Security Agent**).

**BACKGROUND:**

- (A) Pursuant to a Security Agreement dated 25 March 2004 (the **Original Security Agreement**) and a supplemental security agreement dated 13 January 2010 between the **Chargors** and the **Security Agent** (the **Supplemental Security Agreement**), the **Chargors** created **Security Interests** over certain of their assets as security for, amongst other things, the present and future obligations and liabilities of each **Chargor** under the **Finance Documents** (as amended or supplemented).
- (B) The **Facility Agreement** has been further amended by a supplemental agreement dated **28** October 2013 between, among others, the **Chargors** and the **Security Agent** (the **Supplemental Agreement**).
- (C) Each **Chargor** and the **Security Agent** considers that the **Security Interests** created by the **Chargors** under the **Original Security Agreement** secure payment of the **Secured Liabilities** (as defined below) but enter into this Deed in case they do not.
- (D) This Deed is supplemental to the **Original Security Agreement**.
- (E) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

**IT IS AGREED** as follows:

**1. INTERPRETATION**

- (a) In this Deed, **Secured Liabilities** means all present and future obligations and liabilities (whether actual or contingent and whether owed jointly or severally or in any other capacity whatsoever) of the **Obligors** to any **Finance Party** under the **Finance Documents** including those obligations and liabilities as they are amended by the **Supplemental Agreement**.
- (b) Capitalised terms defined in the **Original Security Agreement** have, unless expressly defined in this Deed, the same meaning in this Deed.
- (c) The provisions of clause 1.2 (Construction) of the **Facility Agreement** apply to this Deed as though they were set out in full in this Deed except that references to the **Facility Agreement** are to be construed as references to this Deed.
- (d)
  - (i) A **Finance Document** or other document or security includes (without prejudice to any prohibition on amendments) any amendment to that **Finance Document** or other document or security, including any change in the purpose of, any extension of or any increase in the amount of a facility or any additional facility;
  - (ii) the term **this Security** means any security created by this Deed; and
  - (iii) a reference to any asset, unless the context otherwise requires, includes any present and future assets.



- (e) Any covenant of the Chargors under this Deed (other than a payment obligation) remains in force during the Security Period
- (f) The terms of the other Finance Documents and of any side letters between any Parties in relation to any Finance Document are incorporated in this Deed to the extent required to ensure that any purported disposition of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with Section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989
- (g) If the Security Agent considers (on the basis of legal advice) that an amount paid to a Finance Party under a Finance Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount will not be considered to have been irrevocably paid for the purposes of this Deed
- (h) Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of sale of that Security Asset

## **2. CREATION OF SECURITY**

### **2.1 General**

- (a) All the security created under this Deed
  - (i) is created in favour of the Security Agent,
  - (ii) is created over present and future assets of each Chargor,
  - (iii) is security for the payment and satisfaction of all the Secured Liabilities, and
  - (iv) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994
- (b) If the rights of a Chargor under a document cannot be secured without the consent of a party to that document
  - (i) that Chargor must notify the Security Agent promptly,
  - (ii) this Security will secure all amounts which that Chargor may receive, or has received, under that document but exclude the document itself,
  - (iii) unless the Security Agent otherwise requires, that Chargor must use reasonable endeavours to obtain the consent of the relevant party to that document being secured under this Deed, and
  - (iv) the Chargor must promptly supply to the Security Agent a copy of the consent obtained by it
- (c) The Security Agent holds the benefit of this Deed on trust for the Finance Parties
- (d) All the security created under this Deed
  - (i) is created in case the security created by the Original Security Agreement does not secure all of the Secured Liabilities, and

- (ii) is created in addition to and does not affect the security created by the Original Security Agreement
- (e) Where this Deed purports to create a first fixed Security Interest, that Security Interest will be a third ranking Security Interest ranking subject to the equivalent Security Interest created by the Original Security Agreement and the Supplemental Security Agreement until such time as the Security Interest created by the Original Security Agreement and the Supplemental Security Agreement ceases to have effect
- (f) Subject to paragraph (b) above, where a right or asset has been assigned (subject to a proviso for re-assignment on redemption) under the Original Security Agreement and/or the Supplemental Security Agreement and the same asset or right is expressed to be assigned again under this Deed, that third assignment will take effect as a fixed charge over the right or asset and will only take effect as an assignment if the relevant security interest created by the Original Security Agreement and the Supplemental Security Agreement ceases to have effect at a time when this Deed still has effect

## **2.2 Land**

- (a) Each Chargor charges
  - (i) by way of a first priority legal mortgage all estates or interests in any freehold or leasehold property owned by it (this includes the real property specified in Appendix 1 (Real Property) to the various Deeds of Accession to the Original Security Agreement (the details of which are reproduced in Schedule 2 (Real Property) to this Deed)) and all rights under any licence or other agreement or document which gives that Chargor a right to occupy or use property, and
  - (ii) (to the extent that they are not the subject of a mortgage under sub-paragraph (i) above) by way of first fixed charge all estates or interests in any freehold or leasehold property owned by it and all rights and licences or other agreement or document which gives that Chargor a right to occupy or use property
- (b) A reference in this Deed to any freehold or leasehold property includes
  - (i) all buildings, fixtures, fittings and fixed plant and machinery on that property owned by the relevant Chargor, and
  - (ii) the benefit of any covenants for title given or entered into by any predecessor in title of the relevant Chargor in respect of that property or any moneys paid or payable in respect of those covenants

## **2.3 Investments**

- (a) Each Chargor charges
  - (i) by way of a first priority legal mortgage all shares in any member of the Group (other than itself) owned by it or held by any nominee on its behalf, and
  - (ii) (to the extent that they are not the subject of a mortgage under sub-paragraph (i) above) by way of a first fixed charge its interest in all shares, stocks, debentures, bonds or other securities and investments owned by it or held by any nominee on its behalf
- (b) A reference in this Deed to any stock, share, debenture, bond or other security includes

- (i) any dividend or interest paid or payable in relation to it, and
- (ii) any right, money or property accruing or offered at any time in relation to it by way of redemption, substitution, exchange, bonus or preference, under option rights or otherwise

#### **2.4 Plant and machinery**

Each Chargor charges by way of a first fixed charge all plant and machinery owned by it and its interest in any plant or machinery in its possession

#### **2.5 Credit balances**

Each Chargor charges by way of a first fixed charge all of its rights in respect of any amount standing to the credit of any account (including any account contemplated by this Deed) it has with any person and the debt represented by it

#### **2.6 Book debts etc.**

Each Chargor charges by way of a first fixed charge.

- (a) all of its book and other debts,
- (b) all other moneys due and owing to it, and
- (c) the benefit of all rights, securities or guarantees of any nature enjoyed or held by it in relation to any item under paragraph (a) or (b) above

#### **2.7 Insurances**

Each Chargor assigns absolutely by way of security, subject to a proviso for re-assignment on redemption, all of its rights in respect of any contract or policy of insurance taken out by it or on its behalf or in which it has an interest

#### **2.8 Other contracts**

Each Chargor assigns absolutely by way of security, subject to a proviso for re-assignment on redemption, all of its rights in respect of

- (a) its Relevant Contracts,
- (b) any letter of credit issued in its favour, and
- (c) any bill of exchange or other negotiable instrument held by it

#### **2.9 Intercompany Loans**

Each Chargor assigns absolutely by way of security, subject to a proviso for re-assignment on redemption, all of its rights in respect of any Intercompany Loans to which it is a party provided that while no Event of Default is outstanding the relevant Chargor may, subject to the terms of the Facility Agreement, exercise all its rights in respect of any Intercompany Loan to which it is a party and receive and exercise all rights in respect of the proceeds thereof

## 2.10 Miscellaneous

Each Chargor charges by way of first fixed charge

- (a) any beneficial interest, claim or entitlement it has in any pension fund,
- (b) its goodwill,
- (c) the benefit of any authorization (statutory or otherwise) held in connection with its use of any Security Asset,
- (d) the right to recover and receive compensation which may be payable to it in respect of any authorization referred to in paragraph (c) above, and
- (e) its uncalled capital

## 2.11 Floating charge

(a) Each Chargor charges by way of a first floating charge

- (i) all its assets not at any time otherwise effectively mortgaged, charged or assigned by way of fixed mortgage, charge or assignment under this Clause, and
- (ii) all its assets located in or otherwise governed by Scots law (irrespective of whether or not such assets are effectively mortgaged, charged or assigned by way of first mortgage, charge or assignment under this Clause)

(b) Except as provided below, the Security Agent may (acting on the instructions of the Majority Lenders) by notice to a Chargor convert the floating charge created by that Chargor under this Subclause into a fixed charge as regards any of that Chargor's assets specified in that notice, if

- (i) an Event of Default is outstanding, or
- (ii) the Security Agent considers those assets to be in danger of being seized or sold under any form of distress, attachment, execution or other legal process or to be otherwise in jeopardy

(c) The floating charge created by this Subclause may not be converted into a fixed charge solely by reason of

- (i) the obtaining of a moratorium, or
- (ii) anything done with a view to obtaining a moratorium,

under the Insolvency Act 2000.

(d) The floating charge created by this Subclause will automatically convert into a fixed charge over all of a Chargor's assets if an administrator is appointed or the Security Agent receives notice of an intention to appoint an administrator

(e) The floating charge created by this Subclause is a **qualifying floating charge** for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986

**3. INCORPORATION**

The provisions of clause 3 (Representations - General) to 20 (Release) (inclusive) (other than clause 5.5 (H.M. Land Registry)) of the Original Security Agreement are deemed to be incorporated into this Deed with all necessary modifications as if they were set out in full in this Deed

**4. H.M. LAND REGISTRY**

Each Chargor consents to a restriction in the following terms being entered into on the Register of Title relating to any Mortgaged Property registered at H.M. Land Registry

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the charge dated [ ] referred to in the charges register or their conveyancer (Standard Form P) "

**5. MISCELLANEOUS**

- (a) The Original Security Agreement will remain in full force and effect
- (b) This Deed is designated a Finance Document

**6. GOVERNING LAW**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law
