STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is governed by its Memorandum and Articles of Association, and is a company limited by guarantee, as defined by the Companies Act 2006. The Company registration number is 05514023. As a Charity we are also governed by the provisions of the Charities Act 2011. Our Charity registration number is 1111085. During the year the Trustees have been reviewing the Memorandum and Articles and in the coming year will be bringing forward some amendments to improve the management of the Society.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error. A review of the major risks has been carried out and no additional actions found necessary.

OBJECTIVES AND ACTIVITIES

The objects of the Society, in the governing Memorandum, are

- to secure the preservation, protection, development and improvement of features of general public amenity or historic or public interest in the area of benefit or adjacent areas,
- to educate the public in the geography, history, natural history and architecture of the area of benefit,
- to preserve the character of the area of benefit as a thriving community,
- to promote a high standard of planning and architecture in or affecting the area of benefit and to oppose any inappropriate developments,
- to represent the views of the members to local and other authorities
- to help foster community spirit by arranging lectures, social events and other appropriate activities

These objects have been achieved largely through the work of your committees viz Planning, Community Services, Local History, Meetings & Social and Walks. The Natural Environment committee was in abeyance during the year although some of its activities were continued on an ad hoc basis. Information on the Society's activities has been publicised through the Newsletter, our Website and the local media.

The Community Services Committee maintains close contacts with Solihull M.B.C., the Police, Public Transport providers, the Airport and the local traders to ensure that the views of the Society are heard in all relevant areas.

The Local History Committee maintains contact with appropriate organisations. It manages the Society's collection of documents and artefacts relating to the village and also arranges regular exhibitions of local interest in the History Centre in Knowle Library. This has furniture and fittings provided by the Society in order to preserve and display the artefacts and archived documents.

The Meetings & Social and Walks Committee arranged well-supported programmes of talks and walks throughout the year. Our involvement with the switching on of the Christmas Lights in the High Street was again well supported and widely appreciated.

OBJECTIVES AND ACTIVITIES

In addition to these ongoing activities the Planning Committee had a busy year, especially dealing for yet another year with the planning application in respect of St John's Close, usually known as the 'Waitrose plans'. We have continued to liaise with the developers to try and ensure the inevitable disruption is kept to a minimum. It also dealt with a number of other significant planning applications, notably that for retirement apartments on the High Street and a housing estate off Hampton Rd. Both these were granted planning permission, but we were able to influence the design and layout to minimise the impacts on the village. The Planning Committee also made a number of significant submissions to the Solihull Local Plan that will guide the development of the borough up to 2028 in an attempt to control the rate of implementation of housing developments in the Village. Significant work has been put in to enable the Society to lead the launch, in the coming year, of a 'local forum' to investigate the creation of a 'Neighbourhood Plan' which would sit under the Solihull Local Plan and influence any developments in the village.

Regular contact is maintained with the Council's Planning Department and representations made when appropriate. The Trustee Directors are also grateful for the advice and assistance given to the Society by the local Councillors on planning and other matters.

It was not possible to raise funding for the proposed Knowle Green Community Project, which involved the redevelopment of the former toilet block at the junction of Station Road and the High Street. However it now looks as if a similar scheme will be undertaken by a local resident on a commercial basis. The Society will be consulted on the design of the scheme.

The major project of the Natural Environment Committee that continued was the attempt to register three areas of the previous route of the now abandoned Knowle Relief Road as 'Town & Village Greens'. This was carried on under the leadership of your Chairman as a stand-alone project. A considerable amount of work has been done, with the invaluable assistance of Members (and non-members). The applications were submitted in advance of new legislation, which would have made the applications more difficult. They are being reviewed by Solihull Council and it remains to be seen what the outcomes will be. No doubt there will be more effort required in the coming year.

Financial result for the Year

The year resulted in an Excess of Expenditure over Income of £833 (2012 - Excess of Expenditure over Income of £3,407). This represents a considerable reduction from last year, where there was exceptional spending on the two jubilees and the Waitrose project. This year's expenditure excess is largely due to depreciation of fixed assets, indicating that actual income exceeded revenue expenditure.

Membership

At the end of the year the membership of the Society stood at 3605, a further increase of 342 members over the past year, mainly due to the recruitment efforts of one of the Trustee Directors.


Reserves Policy

The Reserves Policy of the Society is that sufficient funds are retained to cover a minimum of one year's normal expenditure. It will be seen from the figures that the policy was maintained this year. Your Trustee Directors will be reviewing the subscriptions this coming year, due to the ever increasing expense of running the Society. At present it is not thought necessary to increase the subscriptions, but there are a number of potentially expensive projects under way, which may require the raising of additional funds.

Gifts in Kind

The Trustee Directors and many other volunteers freely give of their time and expertise. It is not considered meaningful to place an accurate value on this gift.

**Independent Examiner's Report to the Trustees of
The Knowle Society**

I report on the accounts for the year ended 30th September 2013 set out on pages five to nine

Respective responsibilities of trustees and examiner

The charity's trustees (who are also the directors for the purposes of company law) are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

Basis of the independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statements below.


