1 ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005)

Turnover

Turnover represents subscriptions, donations, grants and monies raised from fundraising events. The company is not registered for value added tax.

2 MEMBERS LIABILITY

The company does not have share capital but is limited by guarantee. In the event of winding up the liability of each member is limited to an amount not exceeding £1.
