Report of the Trustees **for the Year Ended 31 August 2016**

In the course of the year the charity donated further funds towards the building of a home for a disabled family badly affected by the disaster that struck the Philippines in 2013, and literally wiped out thousands of homes and villages when a Typhoon hit the coast. It chose to help a family of 22 who lost everything, but had the added complications of a mother who was wheelchair bound and a father who has suffered two strokes. Our volunteer, Florence Wadley, was determined to build them a new home and helped raise funds for the architect's fees, foundations and walls by holding various events in west London and Bristol. The project completed by the end of the financial year.

1. Accounting policies

Accounting convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
