HARD COPY PROXY APPOINTMENTS AND VOTING INSTRUCTIONS MUST BE RECEIVED AT THE REGISTERED OFFICE OR SUCH OTHER PLACE (IN THE UK) AS THE COMPANY MAY SPECIFY, AND ELECTRONIC PROXY APPOINTMENTS AND VOTING INSTRUCTIONS MUST BE RECEIVED AT ANY ADDRESS SPECIFIED BY THE COMPANY, BEFORE THE TIME APPOINTED FOR HOLDING THE MEETING. SUBJECT TO THE APPLICABLE STATUTES, THE COMPANY MAY BY ORDINARY RESOLUTION DECLARE DIVIDENDS, BUT NO DIVIDEND SHALL EXCEED THE AMOUNT RECOMMENDED BY THE BOARD.
