# 1. Joint Administrators' final progress report

## Introduction

The Joint Administrators ("the Administrators") previously reported on 10 July 2009 and are pleased to provide their final progress report on the Administration of OP Realisations (Alaska) Limited (formerly known as Orchid Pubs Alaska Limited) ("the Company") pursuant to Rules 2.47 and 2.110 of the Insolvency Rules 1986 ("IR86").

The Administrators are required to provide certain statutory information pursuant to Rule 2.47(1)(a) to (d) IR86, which is shown in Section 2 to this report. The Administrators are also required to provide a summary of their proposals. As outlined in the Administrators' proposals document dated 6 February 2009, it became evident on appointment that we would be unable to achieve the purpose of Administration and subsequently no proposals were prepared.

Details of the steps taken during the Administration are set out below.

## Steps taken during the Administration

The Company is part of the Orchid Pub Group of Companies ("the Group") and is one of a twelve companies ("the Companies") in the Group that went into Administration on 13 December 2008.

As previously reported, at the time of the Administrators' appointment it was unclear which of the Companies owned assets. The Company was put into Administration in order to ensure that any assets it did own would be transferred as part of a sale of the Companies' business, so that the purchaser could run the business. Following the sale it became apparent that the Company did not own any assets.

## Outcome for creditors

Both the Administrators' proposals and previous report dated 10 July 2009 stated that it will not be possible to achieve any of the objectives of Administration because the Company has no assets. There will not be a

dividend for any class of creditor.

## Receipts and payments account

There have been no receipts and payments recorded during the period.

## Exit route from Administration

The Administrators will now notify the Registrar of Companies that the Company has no property which might permit a distribution to creditors following which Alaska will be dissolved three months later under Paragraph 84 of Schedule B1 to The Insolvency Act 1986 and Rule 2.118 IR86.


## Discharge
