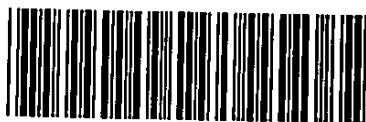

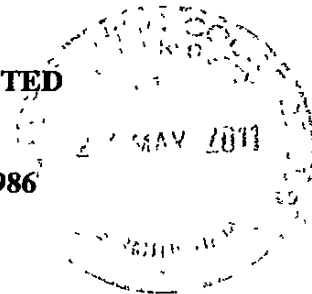

ORDER

UPON the Application of the Administrators dated 17th May 2011

AND UPON READING the evidence

AND UPON THE COURT deciding to determine the application without a hearing

ORDER

- (1) The administration is extended until midnight on 7th July 2013 pursuant to paragraph 76(2)(a) of Schedule B1 to the Insolvency Act 1986
- (2) The requirement for the administrators to prepare and distribute a report to creditors for the six-month period ending 8th July 2011 shall be dispensed with subject to the progress report dated the 20th April 2011 prepared pursuant to rule 2.112 of the Insolvency Rules 1986 being distributed pursuant to Rule 2.47(4) together with notice of any material change up to the date of distribution
- (3) The costs of this application shall be treated as an expense of the administration.

Reasons

1. A further period is required for a property development to be completed and the units sold to realise funds
2. The administrators have a clearly formulated exit strategy, reached after consideration of the alternatives to an extension of the administration.
3. The administration is being conducted for the benefit of the secured creditor and there is no prospect of a dividend for unsecured creditors unless there are significant realisations from outstanding book debts.
