- In the case of each Creditors' Voluntary Liquidation and Members' Voluntary Liquidation, the Applicant be released from all liability both in respect of acts and omissions of his in the administration and otherwise in relation to his conduct as office holder of the companies as are listed in Schedules 1 and 2 hereto with effect from 42 days after the relevant notice referred to in paragraph 12 above has been placed in the London Gazette, save in respect of any claim notified to the Applicant or (where appropriate) his joint appointee or replacement office holder by that date pursuant to the Act and / or pursuant to such other provision as may apply,
- 15.
