ORDER

UPON THE APPLICATION OF ROBERT HUNTER KELLY (hereafter referred to as the "Lead Applicant") (whose address for service is Pinsent Masons LLP, 3 Hardman Street, Manchester, M3 3AU), made in his capacity as outgoing liquidator, administrator

and supervisor (as applicable) in respect of the matters listed in the Schedules hereto, and **TIMOTHY GRAHAM VANCE** (c/o Ernst & Young LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5QR), **CHARLES GRAHAM JOHN KING** (c/o Ernst & Young LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5QR), **COLIN PETER DEMPSTER** (c/o Ernst & Young LLP, Atria One, 144 Morrison Street, Edinburgh EH3 8EX) and **DANIEL CHRISTOPHER HURD** (c/o Ernst & Young LLP, One Colmore Square, Birmingham B4 6HQ) made in their capacity as joint office holders with the Lead Applicant, by notice dated 22 June 2022

**AND UPON READING** the evidence

**AND UPON READING** the statements of each of Samuel James Woodward, Timothy Graham Vance and Charles Graham John King confirming that they are qualified to act as insolvency practitioners in the relevant cases and that they consent to so act in accordance with the terms of this Order

**IT IS ORDERED THAT:-**

**1. LEAD APPLICANT'S REMOVAL AS OFFICE HOLDER**

1.1 The Lead Applicant be removed as office holder in the cases set out in the Schedules hereto pursuant to the relevant power set opposite each category below with effect from the date of this Order:-

- 1.1.1 Creditors' voluntary liquidation cases – Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
- 1.1.2 Compulsory liquidation cases – Section 172(2) of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;

- 1.1.3 Administration cases – Paragraph 88 of Schedule B1 to the Insolvency Act 1986 and Rule 12.36(2)(b) of the Insolvency (England and Wales) Rules 2016; and
- 1.1.4 Company voluntary arrangement case – Section 7(5) of the Insolvency Act 1986 and Rule 12.36(2)(d) of the Insolvency (England and Wales) Rules 2016.

**2. APPOINTMENT OF REPLACEMENT OFFICE HOLDERS**

- 2.1 Samuel James Woodward (of Ernst & Young LLP, 2 St Peters Square, Manchester, M2 3DF), having filed a statement with the Court that he is qualified to act as an insolvency practitioner in the relevant cases and that he consents to act, be appointed in substitution for the Lead Applicant as joint liquidator, administrator or supervisor (as applicable) with the current joint office holder for the matters set out in Schedule 1 from the date of this Order.
- 2.2 Timothy Graham Vance (of Ernst & Young LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5QR), having filed a statement with the Court that he is qualified to act as an insolvency practitioner in the relevant cases and that he consents to act, be appointed in substitution for the Lead Applicant as joint administrator or liquidator (as applicable) with the current joint office holder for the matters set out in Schedule 2 from the date of this Order.
- 2.3 Charles Graham John King (of Ernst & Young LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5QR), having filed a statement with the Court that he is qualified to act as an insolvency practitioner in the relevant case and that he consents to act, be appointed in substitution for the Lead Applicant as joint liquidator with the current joint office holder for the matter set out in Schedule 3 from the date of this Order.
- 2.4 Any act required or authorised under any enactment to be done by a liquidator, an administrator or a supervisor (as applicable) in the cases set out in the Schedules hereto may be done by all or any one of the respective liquidators, administrators or supervisors (as applicable) in each relevant matter acting jointly or alone.

3. **ADVERTISEMENT, REPORTING TO CREDITORS AND RELEASE**

- 3.1 As soon as reasonably practicable, and in any event within 28 days of the date of this Order, the Lead Applicant shall procure that a block advertisement is placed in the Gazette. The advertisement shall contain notification of the removal of the Lead Applicant from the cases identified in the Schedules hereto and the appointment of the relevant replacement office holder in his place and shall be in substitution for notifying each individual creditor on each estate, save to the extent provided for at paragraph 3.2 below.
- 3.2 The Applicants (excluding the Lead Applicant) and the Respondents shall at the first convenient opportunity, and in any event when the next routine report is due to the creditors of each estate or within twelve months following the making of this Order, whichever is sooner, notify such creditors of the making of this Order, such notice to contain the following matters:-
- 3.2.1 an explanation of the effect of this Order; and
- 3.2.2 express reference to the liberty to apply contained in paragraph 4 below.
- 3.3 In relation to the cases listed in the Schedules hereto, insofar as there is any requirement for any appointment or removal of an office holder to be advertised or notified to creditors, the requirement shall be dispensed with save to the extent provided for in paragraphs 3.1 and 3.2 above.
- 3.4 The Applicants and the Respondents be authorised to dispense with any requirement to file a progress report or a receipts and payments account in any of the cases set out in the Schedules hereto as a consequence of the removal and the replacement of the Lead Applicant as an office holder, and the period to be covered by such reports and the dates by which such reports are required to be prepared shall not be altered by virtue of the making of this Order.

- 3.5 The Lead Applicant shall be granted his release in respect of each administration case 28 days after the publication in the Gazette referred to in paragraph 3.1 above unless application has by then been lodged seeking to challenge such release, and otherwise on application to the Secretary of State.

4. **LIBERTY TO APPLY TO THE COURT**

- 4.1 There be liberty to each creditor (where they have a financial interest in the outcome of the relevant proceedings) of each estate set out in the Schedules hereto to apply to vary or discharge this Order within 28 days of receipt of the notices directed to be sent under paragraph 3.2 above.

**AND IT IS HEREBY FURTHER ORDERED:-**

5. **SERVICE**

- 5.1 Service of the Application be dispensed with.
- 5.2 Notice of the Order be delivered to the Secretary of State to whom there be express liberty to apply.
- 5.3 The Lead Applicant file any appropriate notices in respect of his removal and replacement and those appointments in accordance with this Order with the Registrar of Companies.

6. **COSTS**

- 6.1 The costs of this Application be borne by Ernst & Young LLP.
