- THAT the articles of association of the Company be amended by inserting a new Article 27.6 as follows:
  - "27.6 Notwithstanding anything contained in these articles the directors of the company may not decline to register any transfer of shares in the company and may not suspend any registration thereof, where such transfer is:
  - (a) to a bank or institution to which such shares have been mortgaged or charged by way of security (whether as lender, or agent and trustee for a group of banks or institutions or otherwise) (a "Secured Institution"), or to any nominee of such Secured Institution, pursuant to any such security;
  - (b) executed by a Secured Institution or its nominee pursuant to the power of sale or other power under any such security; or
  - (c) executed by a receiver or manager appointed by or on behalf of any Secured Institution or its nominee, under any such security.
- 2. THAT the lien granted by the provisions of Article 31.1 of the Company's articles of association shall not apply in respect of any shares that have been mortgaged or charged by way of security (whether to a lender or an agent or trustee for a group of banks or institutions or otherwise).
- 3. THAT the provisions of Article 32 of the Company's articles of association shall not apply in respect of any shares that have been mortgaged or charged by way of security (whether to a lender an agent or trustee for a group of banks or institutions or otherwise).
