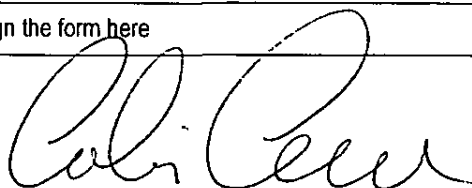

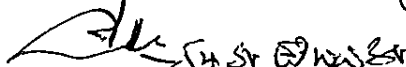
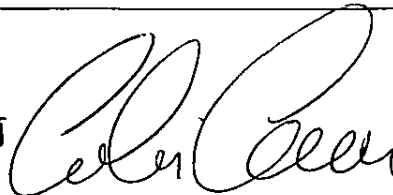
9 Additional provisions

The total maximum amount due and owing to the Lender as at today's date is One Hundred and Sixty Thousand Pounds (£160,000) ("the Loan").
