**UPON THE APPLICATION** of Philip Lewis Armstrong ("the Applicant") dated 19 December 2011

**AND UPON HEARING** Counsel for the Applicant

**AND UPON READING** the documents recorded on the Court file as having been read

**IT IS ORDERED** that

- 1 in relation to each of the cases identified in schedules A1-A4 to the draft order, Nicholas O'Reilly do be removed as the office holder and Philip Lewis Armstrong be appointed in his place,
