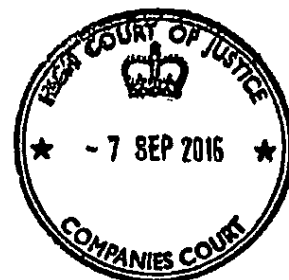

**IT IS ORDERED BY CONSENT THAT:**

1. The cases listed in Schedules A to E attached to this Order, in so far as there are currently proceedings in the County Court or in a District Registry be transferred to the High Court in London for the purpose of making the Orders listed below. The cases transferred from the County Court are transferred back to the relevant court upon the making of this Order and the First Applicant shall ensure a copy of this Order is added to the respective insolvency files

  - 2.4 In rows 12 to 18 of Schedule A to this Order and the First, Second, Third, Seventh, Tenth and Twelfth Respondents shall remain in office as joint administrators.
3. The First Applicant be removed from office as Supervisor with immediate effect pursuant to Section 7(5) of the Insolvency Act 1986 of each of the companies listed.
  - 3.1 In row 1 of Schedule B to this Order and the First Respondent be appointed as Joint Supervisor in place of the First Applicant such appointment to (i) be held jointly with the insolvency practitioner identified at row 1 of Schedule B to this Order who is and remains in office and (ii) take effect from the date of this Order.
  - 3.2 in rows 2 to 4 of Schedule B to this Order and the First, Third, Eleventh and Thirteenth Respondents shall remain in office as joint supervisors
4. Pursuant to Section 172(2) of the Insolvency Act 1986, the First Applicant be removed from the office of liquidator of the companies listed at rows 1 to 4 of Schedule C to this

Order The First, Second, Third, Seventh Eighth, Tenth and Twelfth Respondents shall remain in office as joint liquidators



9. All creditors to the estates listed in Schedules rows 1 to 11 of Schedule A, rows 5 to 15 of Schedule C, Schedule D and Schedule E of this Order do have permission to apply to the Court, on Notice to the Applicants and the Successor Practitioners within 56 days of the advertisement referred to in paragraph 8 above for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor
10. The First Respondent shall give notice of his appointments to all creditors of the estate listed at row 1 of Schedule B to this Order within 28 days of the date of this Order by way of written notice sent to each creditor of the estate
11. All creditors to the estate listed in row 1 of Schedule B of this Order do have permission to apply to the Court, on Notice to the Applicants and the First Respondent within 56 days of the written notice referred to in paragraph 10 above for the purpose of applying to vary or discharge the Order insofar as it affects the estate of which they are a creditor.
12. Nothing in this order requires the time for production of any progress report in respect of the estates listed at Schedules A to E of this order to be varied
13. Pursuant to paragraph 98(2)(c) of Section B1 to the Insolvency Act 1986 the First Applicant be discharged from liability in respect of any action of his as administrator in respect of the Estates listed in Schedule A
  - 13.1 if no application is made pursuant to paragraph 9 above, on the date being 57 days from the date of advertisement referred to in paragraph 8 above of this order, or
  - 13.2 if an application is made pursuant to paragraph 9 above, at such time as should be subsequently ordered by the Court
