
## **Cohort plc**

### **Board Approval**

The Board considered the interim accounts for the Company for the four month period to 31 August 2008 which were prepared under section 838 of the Companies Act 2006 for the purpose of confirming that the Company has sufficient distributable profits to support proposed dividends of 1.00 pence per share, payable on 3 September 2008 (a total distribution of £405,000) and 0.55 pence per share, payable on 6 March 2009 (a total distribution of £219,000)

The Board are of the opinion that the accounts have been properly prepared within the meaning of section 838 subject only to matters which are not material for determining, by reference to items mentioned in section 836(1) which are included in the accounts, whether the proposed distribution would contravene the relevant requirements of the Companies Act 2006

### Notes to the company financial statements

#### 1 Accounting policies

Cohort plc is a company domiciled in the United Kingdom (UK)

##### *Basis of preparation*

The financial statements have been prepared and approved by the Directors in accordance with UK GAAP

##### *Accounting policies*

The accounts have been prepared in accordance with the principal accounting policies as set out on pages 49 to 53 of Cohort plc Annual Report for the year ended 30 April 2008 which are in accordance with applicable accounting standards. These accounts are properly prepared as required by s838 of the Companies Act 2006, subject only to matters which are not material for the purpose of Part 23 of the 2006 Act

The comparative figures for the financial year ended 30 April 2008 are not the Company's statutory accounts for that financial year. Those accounts have been reported on by the Company's auditors and delivered to the Registrar of Companies. The report of the auditors was (i) unqualified, (ii) did not include a reference to any matters to which the auditors drew attention by way of emphasis without qualifying their report, and (iii) did not contain a statement under section 498 (2) or (3) of the Companies Act 2006

#### 2 Dividends

A final dividend of 1.00 pence for the year ending 30 April 2008 was proposed by the directors on 25 June 2008. This interim dividend had not been approved at the balance sheet date and so has not been included as a liability in these financial statements. The dividend totaling £405,000 was paid on 3 September 2008 to shareholders on the register at the close of business on 8 August 2008.
