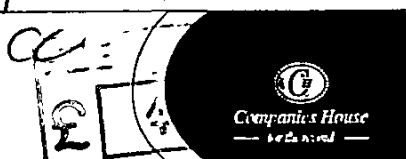

4.1 Rights of Ordinary Shares

4.1.1 Income

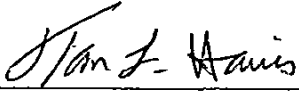
